The regular meeting of the Executive Committee was called to order at **10:04 AM** by Chair, Dr. Tim Glover. No additional reportable action was taken.

- 8. COMMISSIONER’S REPORT.....Joe Heinz, Commissioner
Mr. Heinz shared with the committee the following information:

- Mr. Heinz shared with the committee the section's fall sports update regarding COVID-19. Mr. Heinz shared that the CIF State and CIF State Commissioners have been working diligently on the current state-wide circumstances of COVID-19 and of the challenges it has brought to high school athletics.
- Mr. Heinz informed the committee of the CIF State's announcement that would be taking place on Monday, July 20, 2020. He shared that the CIFSDS will also be sending out its own formal announcement regarding the section plan's and information for high school athletics in San Diego.
- Mr. Heinz shared with the committee the section's potential plans regarding draft calendars, possible athletic start dates, condensed season of sport dates, combination season of sport, the movement of a sport to a different season, section championships, and CIF State championships.
- Mr. Heinz shared with the committee the potential facility conflicts the section and its member schools may have due to the challenges that come with field space and availability due to a more condensed and combination season of sport.
- Mr. Heinz shared with the committee the challenges the section and its members schools may have with the officiating of their sports due to a decrease in officials' availability due to the potential combination/ season of sport for certain sports. In the past, member schools have experienced a decrease in the number of officials the associations have available to officiate their athletic contests. The section commissioner's plan on meeting with the officials' associations shortly after the state and section announcement of July 20 to discuss the possible challenges and the discussion of potential resolutions that may be addressed to better serve the current situation.
- Mr. Heinz shared the potential conflicts districts may have with staffing as some coaches do coach multiple sports and may not be available to do so regarding the potential condensed athletic calendar and the sport(s) they may coach.
- Mr. Heinz informed the committee that he and the assistant commissioner have met with the section's Conference Presidents and will continue to actively meet with them and to receive open feedback from their conference stakeholders.
- Mr. Heinz shared that he and the assistant commissioner also plan on meeting with the fall advisory groups to openly discuss, vet, and receive their feedback that pertains to their individual sport. Mr. Heinz believes communication is a key component to have with the advisories of the section.
- Mr. Heinz informed the committee of the potential upcoming revisions regarding Bylaw 600. The CIFSDS has a much stricter policy regarding Bylaw 600 and he believes much needs to be discussed and vetted with its section stakeholders moving forward with any potential and/or possible language revisions due to the impact and situations of the pandemic.
- Mr. Heinz announced that the section would be holding a special Board of Managers meeting on July 22, 2020 to review the CIF State announcement and section information of July 20.

A discussion took place amongst the committee members regarding the potential challenges of the return of high school athletics; student-athlete health and safety; state and county health departments; athletic equity; club sports; facilities. Officiating of games; master calendar draft dates due to new start/end dates; district calendars; and the overall logistics and return of high school sports.

8. COMMISSIONER’S REPORT.....Jerry Schniepp, Commissioner
Mr. Schniepp shared with the committee the following information:

- Mr. Schniepp shared that the section officially cancelled the 2019-2020, spring sport season due to COVID-19.
- Mr. Schniepp shared with the committee that incoming 9th grade students may not meet with schools until they finish their 8th grade education. Due to COVID-19 some parent/school meetings are taking place virtually; it’s important that parents are able to stay informed as much as possible as long as they are done after the completion of their student-athlete’s 8th grade education date.
- Mr. Schniepp shared with the committee that the CIF State was in the process of reviewing the language of Bylaw 600 due to COVID-19.
- Mr. Schniepp shared with the committee the information of the Waiver of Semester (5th Year Request). He informed the committee that the section had several inquiries regarding the waiver request (additional semesters of eligibility), but as of today, the section had only received one formal submission. Mr. Schniepp shared that the section has been very clear with the information they have shared with the public and parents that the restrictions due to COVID-19 are not going to be a stand-alone item to be considered regarding granted additional semesters of eligibility. Students will need to submit hardship information that proves that meets the required criteria to receive consideration for a hardship request.
- Mr. Schniepp shared with the committee the information of student athlete Academic Eligibility and Academic Probation. The CIF is seeking assistance with California legislators regarding a possible one-time exception to the required GPA standards for extra-curricular activities due to COVID-19.
- Mr. Schniepp shared with the committee the State Federated Council meeting date of May 29, 2020. He believes that the section and the State CIF office are working diligently together to work through all future possible scenarios to allow the fall sport season to begin as scheduled.
- Mr. Schniepp shared with the committee that due to the cancellation of the spring sport season, All CIF Teams and All Academic Teams were not selected due to COVID-19 and school closures.
- Mr. Schniepp shared with the committee the information of waiving the No-Contact period for the 2020-2021, summer period only. He shared that a proposal for the No-Contact period was included in the agenda of May 13, 2020.
- Mr. Schniepp informed the committee with the summer school grading policy rules of the CIFSDS Bylaw 205 B, (3), Grading Period, has not changed. He shared that summer school grades may be used to make students eligible but cannot be used to make students ineligible if they were otherwise eligible.
- Mr. Schniepp shared with the committee the information of the current CIFSDS Finances. The section lost significant income with the loss of the 2019-2020 spring championships not taking place. The section was able to secure the PPP Loan from the Federal Government and are working to ensure the section is adhering to the federal mandated terms.

The regular meeting of the Board of Managers was called to order at 9:04 AM by Chair, Dr. Tim Glover. No additional reportable action was taken.
- 5. ADOPT BOARD OF MANAGERS' AGENDA.....Dr. Tim Glover, Chair
It was moved by Mr. Scott Giusti, seconded by Dr. Anne Staffieri, to adopt the Board of Managers' Agenda as presented. Motion unanimously carried.
- 6. APPROVAL OF MINUTES, BOARD OF MANAGERS MEETING, MAY 20, 2020.....Dr. Tim Glover, Chair
It was moved by Mr. Bill Singh, seconded by Mr. Dave Smola, to approve the minutes of the May 20, 2020 meeting, as presented. Motion carried with two abstentions: Dr. Moises Aguirre and Mr. Mariano Velez.

No correspondence was submitted.

8. COMMISSIONER'S REPORTJoe Heinz, Commissioner
Mr. Heinz shared with the board the following information:

- Mr. Heinz shared with the board the CIF State athletics update Information of July 20, 2020 and shared a PowerPoint presentation to review the section and state information.
- Mr. Heinz shared with the board the multiple meetings that have taken place with the following governance teams within the state (CIF State Executive Director, Dr. Ron Nocetti, Ed.D., Asst. Executive Director. Mr. Brian Seymour, state-wide section commissioners, and with the conference presidents of the section) regarding what was the best course of action for the section in moving forward with a plan for high school athletics for 2020-2021, school year.
- Mr. Heinz shared with the board that it was discussed with the state commissioners and decided that two (2) seasons of sport instead of three (3) was going to be implemented and the calendar start date for the combined season of fall/winter sports will begin on December 14, 2020. would take place with the movement of some season sports.
- Mr. Heinz based on the cancellation of the spring the spring season consensus from the state and its commissioners was to allow a full season of sport for the spring season. The spring start date for the spring season of sports is March 15, 2021.
- Mr. Heinz shared and reviewed with the board the CIF State calendar and the proposed information of the section's full season of sport calendar for the 2020-2021 school year. He informed the board of the proposed timelines and dates for the start of practice, first permissible scrimmage, start of competition, end of league competition, dates of section finals, and dates of state championships. He shared that some spring sports have the potential of not ending until June 26 of 2021.
- Mr. Heinz shared with the board the potential facility conflicts the section and its member schools may have due to the challenges that come with field space and availability due to a more condensed and combination season of sport.
- Mr. Heinz shared with the board the potential conflicts districts may have with staffing as some coaches do coach multiple sports and may not be available to do so regarding the potential condensed athletic calendar and the sport(s) they may coach.
- Mr. Heinz shared with the board the challenges the section and its members schools may have with the officiating of sports due to a decrease in officials' availability due to the potential combination/ season of sport for certain sports. In the past, member schools have experienced a decrease in the number of officials the associations have available to officiate their athletic contests. The section commissioner's will be meeting with the officials' associations at the conclusion of the July 22, board meeting to discuss the possible challenges of the section and CIF State announcements that took place on July 20. Mr. Heinz believes that the discussion needs to take place so that potential resolutions may be addressed to better serve the current situation.
- Mr. Heinz informed the board that he and the assistant commissioner plan on meeting with the fall advisory groups to openly discuss, vet, and receive their feedback that pertains to their individual sport.

Meetings for the fall advisories have been scheduled to take place from July 22-August 3, 2020. Mr. Heinz believes that open communication is key to the success and implementation of a successful fall season of sport and advisory feedback is important.

- Mr. Heinz informed the board of the revisions coming from the CIF State and section-wide regarding the suspension of Bylaw 600 – Bylaw 605. Athletes will be allowed to practice and play with their club sport and will also be able to participate and play in their high school team of sport during the same season of sport. The CIF State is waiving Bylaw 600- Bylaw 605 for the 2020-2021, school year only. The CIFSDS has a much stricter policy regarding Bylaw 600 and believes much needs to be discussed and vetted with its section stakeholders moving forward with any potential and/or possible language revisions due to the impact and situations of the pandemic.
- Mr. Heinz informed the board of the revision and waiver of Bylaw 501 that allows section to extend the summer period which may allow us to have an off-season leading up to the start of the fall sport season of December 14, 2020. Mr. Heinz believes it gives the section and its student-athletes the flexibility withing the season of sport.
- Mr. Heinz plans on bringing forward a proposed 2020-2021, CIFSDS Master Calendar for the 2020-21 school year to the next board meeting of August 14, 2020, to be reviewed and voted on by the Board.
- Mr. Heinz informed the board that all the shared information regarding the return of high school athletics is contingent on the state health department allowing for athletics to begin.

A discussion took place amongst the board members regarding the potential challenges of the return of high school athletics; student-athlete health and safety; state and county health departments; athletic equity; equitable schedule of contests, club sports; facilities, officiating of games; master calendar draft dates due to new start/end dates; district calendars; the review of Bylaws 501, 600-605, modified/adaptation of calendar within a region of the section (Imperial Valley), and the overall logistics and return of high school sports.

- Mr. Heinz honored CIF Board Chairperson, Dr. Tim Glover with a CIF Lifetime pass. Dr. Tim Glover has been an advocate for high school athletics for his entire educational career. As a teacher and coach, he worked directly with student-athletes and as a site administrator, he understood and valued educational athletics and their importance in the growth of young people.

As the Superintendent of the Grossmont Union High School District, Dr. Glover not only played an active role on the CIFSDS Board of Managers, but for the past 2 years served as our Board Chair. Tim has been incredibly involved in all components of CIF and has been an advocate for all that we do.

He always put the interests of students first, advocated for transparency and building and maintaining an enduring foundation for CIF. He has been a grounded, sincere leader whose positive influence on education and educational athletics will be long lasting. Dr. Glover will be missed.

EXECUTIVE SUMMARY

On January 22, 2020, the San Diego Section Board of Managers approved the Master Calendar for the 2020 -2021 school year. Due to the impact of the Covid-19 Pandemic on the State of California, the CIF State Offices released an updated Seasons of Sport Calendar on July 20, 2020 for the 2020-2021 school year. Based upon the reconfiguration of State Bylaws 504 E. and H. (Season of Sport) the updated calendar for the state pushed the start date back for the first season of high school sports to mid-December, while also adjusting all CIF sports into two specific seasons of sport. EXECUTIVE SUMMARY

The Board of Managers is asked to consider the approval of the revised CIFSDS Bylaws 600, 601, 602, 603, 604, 605, language revisions for the 2020-2021 school year only as shown in the attached supplement(s) and in the information of the Executive Summary below:

On July 20, 2020, the State CIF Offices announced that they would be temporarily suspending state bylaws 600, 601, 602, 603, 604, 605, regarding competition on outside teams for the 2020-2021 school year. Per CIF Article 23, which enables sections throughout the state to develop more restrictive rules than the CIF State Office, the San Diego Section has adhered to Section Bylaw 600.1 which states that student athletes are not allowed to practice or compete on an outside team during their season of sport.

Based upon the adjusted Seasons of Sport for the 2020-2021 school year, the Board of Managers is asked to consider approval of a one year waiver for section Bylaw 600.1, enabling student athletes throughout our section to join those throughout the state in being able to practice and compete on an outside team during their official season of sport.

CIF San Diego Section Bylaw 600.2, pertaining to activities that occur outside the CIF San Diego Section Master Calendar's prescribed "season of sport" will remain in place.

Temporary Suspension of Bylaws 600-605 (Outside Competition)

Due to the need to move sports to non-traditional times of the year, the CIF is temporarily suspending Bylaws 600, 601, 602, 603, 604, and 605 for all sports for the 2020-21 school year. Accordingly, students will be allowed to participate on an outside team at the same time they participate on their high school team. As per CIF Article 23, local schools, school districts, leagues, and Sections may develop a more restrictive rule than the CIF State Office with respect to the aforementioned Bylaws.

Each of the above Bylaw modifications are effective as of July 20, 2020 and remain in effect for the 2020-21 school year only.

RECOMMENDATION FIRST READ/ ACTION:

The Board of Managers is asked to approve a one-year waiver for San Diego Section Bylaw 600.1 for the 2020-2021 school year, enabling student athletes to both practice and compete on an outside team, during their official season of sport.

This item was reviewed by the Executive Committee as a first read/action and voted on at the meeting of August 10, 2020.

The recommendation for item # 11 of the Executive Committee and CIF Commissioner's are as follows:

ARTICLE 60 OUTSIDE COMPETITION**600. COMPETITION ON AN OUTSIDE TEAM**

A student on a high school team becomes ineligible if the student competes in a contest on an "outside" team, in the same sport, during the student's high school season of sport (See Bylaw 504.A). The following exceptions apply:

- ~~If the outside team has half or more of the team members as stated in the National Federation rules book for that sport, it shall be considered the same sport. Examples: three-on-three basketball---outside team competition prohibited; two-on-two volleyball-outside team competition permitted.~~
- ~~**Flag Football/Beach Volleyball/Slow Pitch Softball**
For purposes of this rule, touch football, flag football, beach volleyball and slow pitch softball are considered to be different sports than tackle football, volleyball and softball respectively. (Editorial Revision May 2017)~~
- ~~**Soccer**
In the sport of soccer, Bylaw 600 shall be in effect only during the winter high school soccer season. High school soccer programs that compete during the fall or spring season are not subject to Bylaw 600.
NOTE: For purposes of this section, indoor soccer and futsal are not considered the same sport as soccer.~~
- ~~**Swimming and Diving**
Swimmers may compete for an amateur team during the season of sport in the USA Swimming Senior National Championship Meet, the USA Swimming Sectional Championship Meet and the USA Swimming Junior Olympic Meet. Divers may compete for an amateur team during the season of sport in the USA National Championships, USA Junior National Championships and any Regional and/or Zone Championship meet that qualifies the diver to the aforementioned Championships.~~
- ~~Bylaw 600 shall not be in effect for those sports conducted outside the State-adopted season of sport.~~
- ~~**Spontaneous Recreational Activity**
It is permissible for a high school team member to participate in a spontaneous recreational activity or game in which sides or teams are chosen without regard to players representing any group or organization. Such participation would not cause loss of eligibility. (Definition of spontaneous: no prior planning or notice; an unplanned part of another activity which has a primary focus other than the sport.)~~

G. Unattached Competition in Individual Sports (see also Bylaw 215)

- ~~(1) An unattached athlete shall not represent any team. Points won by the athlete shall not be credited to any team. An unattached athlete shall not use a uniform which identifies a school or "outside" team. Any violation shall be considered an infraction of Bylaw 600.~~
- ~~(2) Unattached competition is permissible for a student in other than school contests during the season of sport provided the student enters in the individual sports of badminton (singles and doubles), cross country, golf, gymnastics, skiing, swimming and diving (including unattached entry on relays), tennis (singles and doubles), track and field (including unattached entry on relays) and wrestling.~~
- ~~(3) **Certification of Unattached Athletes**
No official recognition or certification on the part of the CIF member school or personnel of the CIF member school may be given in order that unattached athletes may participate in contests.~~
- ~~(4) **Representation in CIF Competition**
Unattached competition is not permitted in any CIF competition (See Bylaw 503.D.). Individuals or teams entered in CIF competition must represent a CIF member school. No other form of representation shall be permitted in CIF competition.
NOTE: Alpine, Nordic Skiing and Snowboarding are exempt for this Bylaw as the season of sport is not defined and listed under Bylaws 503.D. and 504.H. and that all competitions are done in conjunction with the Nevada Interscholastic Activities Association.~~

600.1 IN THE CIFSDS DURING SEASON OF SPORT

- ~~**School Team – The current-year San Diego Section Master Schedule, approved by the Board of Managers, sets the official commencement and conclusion of each sports season within the San Diego Section.**~~

- ~~Outside Team~~—During a San Diego Section athlete's season of sport, he or she may not compete on an outside team in the same sport (Approved January 21, 2003 Board of Managers). For the purpose of this rule, an outside team is defined as a non-CIF team consisting of half or more of the number of players required to start a contest by the respective National Federation rules book. Tackle football is considered to be a sport separate from touch or flag football. Examples of outside team sports that would be in conflict include (but not limited to) 3 on 3-basketball, slow pitch softball. Examples of outside team sports that would not be in conflict would be 2-person volleyball, 5 on 5-indoor soccer, and over the line. As two exceptions to this rule, athletes participating in the individual sports of swimming, diving, and gymnastics may practice during their season of sport, as unattached athletes, with club teams, which are established under the National Governing Board for that sport, so long as the athlete also practices with the school team, and the athlete is entered to compete as an unattached athlete in the CIF-approved competitions at Bylaw 600. (Approved June 3, 2003 Board of Managers)

~~c. During a San Diego Section athlete's season of sport, he or she may not practice with an outside team or in any group setting in the same sport and may not attend a tryout or "showcase" for any club, organization or outside team in the same sport. In the CIFSDS, practice is defined as organized, systematic exercise to become proficient in a sport with more than one student-athlete. Prohibited activities in the CIFSDS include, but not limited to, skill drills, game situation drills, scrimmages and games, or any other directed or supervised instruction of more than one student-athlete by any individual associated with an outside team, organization or "club". One on One (Instructor and student) lessons are permissible during the season of sport.~~

~~Attendance at College ID camps in all sports~~

- ~~1. With CIFSDS prior approval, student athletes are permitted to attend two college ID camps in any given season of sport. Attendance at any camp beyond two ID camps is a violation and would result in the penalties described in 601.A.~~
- ~~2. A College ID camp is defined as a sport specific camp, held on a college campus under the direction of a college coach.~~
- ~~3. Student athletes must receive permission from the site sport head coach and the Athletic Director/Administrator prior to attending the ID camp. ID camp participation form must be completed, signed and approved by CIFSDS prior to a student attending. Participation in an ID camp without prior approval would result in the penalties described in 601.A.~~

- ~~During School Day (includes extended school day) - An athlete may not participate in a regular physical education class or an independent study physical education class or an independent study physical education class in which more than one- half of the course offering outside the season of sport is in the sport in which he or she has competed interscholastically. For example, a basketball player could enroll and participate in a summer school physical education class that had 50 percent of its time allotted for weight training, running, racquetball, etc. Students who had not yet competed on an interscholastic level in the sport concerned and students enrolled in off-campus independent study physical education classes in the individual sports (swimming, gymnastics, golf, tennis, etc.) would be exempt from this restriction.~~
- ~~Outside School Day (Includes after-school hours, weekends, holidays, and all vacation periods including intercessions)~~
 - (1) ~~CIFSDS athletes may practice with, or compete on, outside teams which are:~~

- (a) Established under some governing authority.
- (b) Open to all interested students.

(Approved January 21, 2003 Board of Managers)

(2) Other than illegal all-star activity, CIFSDS coaches may coach their own athletes as individuals or as members of outside teams except during the schools declared dead period (see Out-of-Season Policy) and provided there is no requirement or official involvement of their school including sponsorship, publicity, identification of school, uniforms, balls and other equipment, transportation, finances, entry fees, etc. Uniforms, warm-ups, and other apparel bearing the name or abbreviation of the student's school may not be worn (see #6). Nicknames and their abbreviations are permitted.

(3) School facilities and equipment, including protective gear such as shoulder pads, helmets, hip pads, may be utilized by CIFSDS coaches and athletes if they are acting as individuals or outside agencies disassociated from the school and receive written permission on forms provided by the school or district for public use of the equipment or facilities. If charges are normally made, then charges must also be made to the applicant concerned. In all cases of facility and/or equipment usage, no special treatment or favoritism must be shown to applicant coaches or athletes; the normal procedures for processing applications for any outside individual or agency must be followed. Uniforms, warm-ups, and other apparel bearing the name or abbreviation of the student's school may not be worn, and uniforms, warm-ups, and other apparel that are no longer the property of the school must have the school name or abbreviation removed or completely covered.

(4) Organizational meetings of the high school coach and potential team members are permitted prior to the first official school practice. These meetings are for the purpose of information and planning only, regarding the upcoming season. No tryouts, chalk talks, sports films, drills, exercises, strategy, etc., are to be included.

(5) Fundraising activities such as "a-thons" etc., which place emphasis upon endurance rather than skills may not be in violation of CIF or CIFSDS rules regarding either out-of-season or amateur rules (should prizes be given).

(6) Violations of any of the foregoing restrictions are subject to Rule 604.

601. PENALTIES FOR VIOLATION OF BYLAW 600 A. Individual

— (1) **First Offense in High School Career in Any Sport**

The student becomes immediately ineligible for participation upon return with his/her high school team for a number of contests equal to twice the number of contests of outside competition in which the student participated.

— (2) **Any Subsequent Offense in High School Career in Any Sport**

The student becomes immediately ineligible for one (1) year (365 days) from the second infraction in all sports.

a. Appeals

Upon written appeal to the Section Commissioner, the student may petition his/her Section for reinstatement of his/her eligibility status.

OLYMPIC DEVELOPMENT PROGRAMS~~~~During their high school season of sport, a high school student who has been selected or qualified for an Olympic Development Program (ODP) by the respective National Governing Body for that sport, shall be permitted to participate in such a program without loss of interscholastic eligibility, if the following conditions are met:~~

 - ~~— (1) Verified as such by the CIF; AND~~
 - ~~— (2) a. Conducted or sponsored by the United States Olympic Committee; OR~~
