WHAT IS AGES?

Advanced **GE**riatrics **S**kills (AGES) program is a continuing education course that increases the competency of all health professionals who care for older adults. The course is evidenced-based and presented in a comprehensive modular format that enhances the skills and understanding of major geriatric syndromes and diseases, psycho social and ethical issues in aging, as well as, interprofessional models of care.

The overall goal of **AGES** is to promote excellence for practitioners, faculty and others who care for older adults. It extends the understanding of aging while strengthening the skills of health professionals who work with older adults.

Physicians, Physician Assistants, Pharmacists, Consultant Pharmacists, Nurses, Advanced Practice Nurses, Social Workers, Physical Therapists and other health professionals

Objectives for Presentations
