Walt Disney Co. is the largest public company headquartered in the L.A. area. The Burbank company saw its market capitalization as of June 30 increase to \$166 billion from \$159 billion a year earlier. Revenue increased from \$52.5 billion in 2015 to \$55.6 billion in 2016.

IPO: Snap Inc. had an initial public offering in March.

MERGER: Colony NorthStar Inc. was formed by the merger of Colony Capital Inc., NorthStar Asset Management Group Inc. and Northstar Realty Finance Corp. in January.

ACQUISITION: VCA Inc. announced in February that it will be acquired by Mars Inc. for \$7.7 billion, plus debt.

EL SEGUNDO: Toymaker Mattel Inc. hired Margo Georgiadis as chief executive in January.

DOWNTOWN: Richard Goudis became chief executive of Herbalife Ltd. this year.

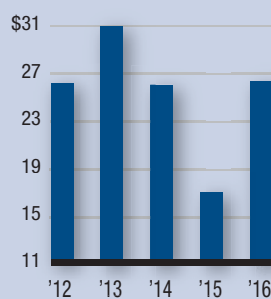

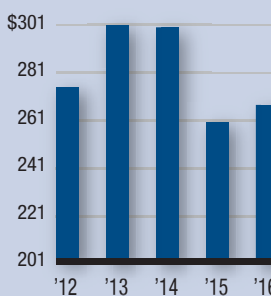

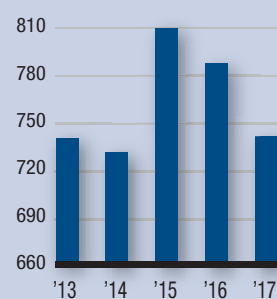
