In December, 1966 he took the Director of Planning position in Ames, Iowa, and in March, 1970 John moved to California to be the Director of Planning & Development in Inglewood. In 1974 he moved to the Santa Monica Director of Environmental Services post. John was appointed Santa Monica Assistant City Manager in June, 1979 and in December, 1984 he was promoted to the City Manager position where he served unit retirement at the end of 1999. John just recently concluded an Interim City Manager assignment in Lomita. He has a BA from Colgate University and an MA from the University of Oklahoma. He earned a 35-year ICMA Service Award.

Brock retired last month. He has a BA from the University of California, Santa Barbara , an MS from California State University, and an MPA from USC. 3rd Installment: City Managers Still Serving 25-years Later



In 1985 **Kevin O'Rourke** was the City Manager in the City of <u>Stanton</u> and in November, 1985 he was appointed City Manager in <u>Buena Park</u>. Kevin began his public management career journey following a

couple of years in the private sector in 1977 as the Director of Human Resources in Stanton. In January, 1981 he was appointed Assistant to the City Manager, and in 1982 Kevin was appointed Stanton City Manager/City Clerk. In November, 1985 he moved to the City Manager post in Buena Park. Kevin served in the "Home of Knott's Berry Farm" for nearly a dozen years before moving to Northern California to be the City Manager in Fairfield in March, 1997. Kevin retired from his Fairfield post in 2008, and became associated with Urban Futures, Inc. He jumped back into public management though, and is currently serving as the Interim City Manager in Stockton. Kevin has a BA from La Salle College, Pennsylvania. He served on the ICMA Executive Board from September, 2000 to September, 2003 as a West Coast Regional Vice President. Kevin is a past-President of the City Managers' Department of the League of California Cities (1997 -98). He has also served on the Cal-ICMA Board, and he Chaired the ICMA Committee on Government Affairs (formerly Public Policy). He is an ICMA Credentialed Manager and earned his 30-year ICMA Service Award in 2007.

In 1985 Stephen L. Wright was the City Manager in Taft. Steve began his public management career in 1967 as an Administrative Assistant in Signal Hill, and he was appointed Assistant Administrative Officer in 1970. Steve was selected for the Assistant City Manager post in Lynwood in February, 1972 and was elevated to City Manager in December of that year, serving in that position until November, 1976. In 1977 Steve was appointed City Manager in Taft, where he served for a few months more than a dozen years. He moved to Big Bear Lake as City Manager in September, 1989, and in 1993 Steve moved north to become the first Truckee Town Manager. Truckee grew as a railroad town originally named Colburn Station, starting with the Transcontinental Railroad project. Steve retired from Truckee in 2005, and is listed as the Wheatland City Manager in the League's City Manager Directory starting in 2006. He has a BA from California State University.

In 1985 Torrance City Manager LeRoy J. Jackson was the City Manager in Torrance. He began his public management career in 1965 as an Administrative Intern in Pasadena. In August, 1966 he joined the Torrance city staff as a Personnel Analyst, and has been with the city since holding a number of positions, including: Senior Administrative Assistant, 1968; Assistant to the City Manager, 1971; Chief Assistant to the City Manager, 1979; and Assistant City Manager in June, 1981. LeRoy was appointed Torrance City Manager in January, 1983. He has a BPA and MPA from California State University, Long Beach, and he earned a rare 40-year ICMA Service Award in 2006. He is a member of the 17-member Board of Directors for the Los Angeles Regional Interoperable Communications System (LA-RICS).

Bill started his public management career in November, 1970 as an Administrative Assistant in Simi Valley. In June, 1972 he was promoted to Assistant to the City Manager, and in 1975 he left Simi Valley to take the Assistant City Administrator job in Millbrae. In October, 1978 he was elevated to Millbrae City Administrator. In 1981 Bill returned to Southern California as the Tustin City Manager and he has served there since. He has a BA from the California State University, Northridge and an MPA from **USC**. He has earned a 35-year ICMA Service Award.

<u>Tustin</u> incorporated in 1927 with a population of about 900. During <u>World War II</u>, a <u>Navy</u> antisubmarine <u>airship</u> base (later to become a <u>Marine</u> <u>Corps</u> helicopter station) was established in unincorporated land south of the city; the two blimp hangars are among the largest wooden structures ever built and are listed on the <u>National Register of</u> <u>Historic Places</u>. After the war Tustin annexed nearby unincorporated land including the base.

In January, 2009 Jim returned to Victorville as the Interim City Manager, and in no time at all the "Interim" was dropped from his title. 

In 1985 Ted Gaebler was the City Manager in He was listed on our "Oregon Visalia. experience" list already, but we cannot leave him off this "quarter century" list. It was in 1992 when Ted co-authored "Reinventing Government" with David Osborne earning some celebrity. Ted began his career in 1963 with a 3-month paid internship in Oxford, Ohio. In 1964 he served 6-months as an Administrative Assistant in Dayton, Ohio, and in June, 1965 he accepted an Administrative Assistant post in Salem, Oregon. He was appointed Assistant to the City Manager in 1969. In June, 1970 Ted headed east to become the Assistant Manager in Columbia, Maryland, and after nearly two years in that position he was appointed City Manager in Vandalia, Ohio in June, 1972. Ted moved back to California in November, 1975 to accept the Assistant City Manager post in Visalia, and in 1978 he was appointed Visalia City Manager. Ted served in Visalia until the summer of 1985 when he served five months as the San Rafael City Manager prior to taking the reins as President of The Gaebler Group, Inc. in December, 1985. Ted served a three-month assignment at Interim City Manager in Hercules in 1987, and a 6-month assignment as the Assistant Chief Executive Officer in Washington, D.C. in 1998. In January, 2000 Ted moved back into full-time local government employment as the County Executive Officer in Nevada County, California where he served until 2003. After a 6-month Interim City Manager assignment in East Palo Alto in 2003, Ted was appointed to his current post as Rancho Cordova City Manager in October, 2003. In addition to the BA from Miami University, Ted earned a MGA from the University of Pennsylvania. Besides his 30-year ICMA Service Award, Ted is the 1979 recipient of the ICMA Management Innovation Award, and the 2009 recipient of the ICMA Career Development Award in Memory of L. P. Cookingham.
