## Question 1

The line passes through $(0,3)$ and $(-6,0)$

$$
\begin{aligned}
\text { gradient } & =\frac{3-0}{0-^{-} 6} \\
& =\frac{3}{6} \\
& =\frac{1}{2}
\end{aligned}
$$

The gradient of the line that is perpendicular to this line is -2 because $-2 \times \frac{1}{2}=-1$.
The answer is A .

## Question 2

If the function $y=\frac{1}{\sqrt{4-x}}$ is to exist then

$$
\begin{gathered}
4-x>0 \\
-x>-4 \\
x<4
\end{gathered}
$$

$$
\text { So } x \in(-\infty, 4)
$$

The answer is A .

## Question 3

f(g(x)) & =e^{2 \times\left(\frac{2}{x}\right)} \\
& =e^{\frac{4}{x}} \\

The answer is D.

## Question 4

## Method 1 - using CAS

Let $y=(x-1)^{3}+2$
Swap $x$ and $y$ for inverse.
Solve $x=(y-1)^{3}+2$ for $y$.

The answer is E .

Method 2 - by hand
Let $y=(x-1)^{3}+2$
Swap $x$ and $y$ for inverse.

\sqrt[3]{x-2} & =y-1 \\

r_{h} & =[2, \infty) \\
\text { So } d_{h^{-1}} & =r_{h}=[2, \infty) \\

\end{aligned}

The answer is E .

## Question 5

\end{aligned}

The answer is D.

## Method 2

\text { Let } y & =e^{3 g(x)} \quad \frac{d u}{d x}=3 g^{\prime}(x) \\
& =e^{u} \\
\frac{d y}{d x} & =\frac{d y}{d u} \cdot \frac{d u}{d x} \text { (Chain rule) } \\
& =e^{u} \cdot 3 g^{\prime}(x) \\
& =e^{3 g(x)} \cdot 3 g^{\prime}(x) \\
& =f(x) \cdot 3 g^{\prime}(x)
\end{aligned}
$$

So $f^{\prime}(x)=3 g^{\prime}(x) f(x)$
The answer is D.

## Question 6

## Question 7

The period of the graph is $\frac{2 \pi}{8}=\frac{\pi}{4}$.
The period of the graph of $y=\tan (n x)$ is $\frac{\pi}{n}$.
Let $\frac{\pi}{n}=\frac{\pi}{4}$ so $n=4$.
The graph of $y=\tan (4 x)$ has been reflected in the $x$-axis to obtain the graph shown.
The rule $-y=\tan (4 x)$ would define this reflection. So the graph shown could have the rule $y=-\tan (4 x)$
The answer is B.

## Question 8

\end{array}\right] \\
&(a+1)(a-3)-5 \times 1=0 \text { for no solution or infinitely many solutions } \\
& a^{2}-2 a-3-5=0 \\
& a^{2}-2 a-8=0 \\
&(a-4)(a+2)=0 \\
& a=4 \text { or } a=-2 \\
& \text { If } a=4, \text { we have } \\
& 5 x+y=1 \\
& 5 x+y=10
\end{aligned}

Therefore there are no solutions since these equations represent parallel lines.
If $a=-2$, we have

-x+y=1-(A)
$$

$$
5 x-5 y=-5-(B)
$$

$(A) \times-5 \quad 5 x-5 y=-5-(C)$
$(A)$ and $(C)$ represent the same line so there are infinitely many solutions.
So for no solutions $a \in\{4\}$.
The answer is B.

## Question 9

> Let $T=\left[\begin{array}{ll}0.6 & 0.7 \\ 0.4 & 0.3\end{array}\right] \begin{gathered}H W \\ \text { no } H W\end{gathered}$ next day
be the transition matrix representing this situation.
Let $S_{1}=\left[\begin{array}{l}1 \\ 0\end{array}\right] \begin{gathered}H W \\ \text { no } H W\end{gathered}$ be the initial state matrix.
Note that if you use $\left[\begin{array}{l}0 \\ 1\end{array}\right] \begin{gathered}H W \\ \text { no } H W\end{gathered}$ as your initial state matrix you will get the same result.
Now, using CAS,
$T^{20} \times S_{1}=\left[\begin{array}{l}0.636364 \\ 0.363636\end{array}\right]$
$T^{21} \times S_{1}=\left[\begin{array}{l}0.636364 \\ 0.363636\end{array}\right]$
So we have found a steady state.
So over the long term, the probability that George does his homework is 0.636364 .
The closest answer is 0.64 .
The answer is E .

$$

\text { So } V=\frac{2}{3} h^{3}
$$

$$
\frac{d V}{d h}=2 h^{2}
$$

$$
\text { Also, } \frac{d V}{d t}=0.1 \quad \text { (given) }
$$

$$
\text { So, } \frac{d h}{d t}=\frac{d h}{d V} \cdot \frac{d V}{d t} \text { (Chain rule) }
$$

$$
=\frac{1}{2 h^{2}} \cdot 0.1
$$

$$
=\frac{1}{20 h^{2}}
$$

When $h=0.2$,

$$
\frac{d h}{d t}=\frac{1}{20 \times 0.04}
$$

=1.25
$$

The answer is D.

## Question 12

Draw a diagram.


The area representing $\operatorname{Pr}(-1<Z<3)$ is shaded.
This area could also be expressed as $\operatorname{Pr}(12.5<X<22.5)$ however this is not offered as an alternative.
Because of the symmetry of the normal curve, an equal area could be given by the shaded area below.


This area is given by $\operatorname{Pr}(7.5<X<17.5)$.
The answer is $B$.

## Question 13

Since $f=g \times h$

Use CAS to sketch the graph of $f$
that is, $f(x)=\log _{e}(x) \times|x|$
Since $d_{f}=[1, \infty)$, from the graph, $r_{f}=[0, \infty)$.
So $d_{f^{-1}}=r_{f}=[0, \infty)$
The answer is C .

Let $m$ be the median we want to find so that the shaded area $=0.5$.

The closest answer is 1.7 .
The answer is D.


## Question 15

$y=\log _{e}(\sqrt{x})$
At $x=4, \frac{d y}{d x}=\frac{1}{8}$ (using CAS).
We are looking for a line with a gradient of $\frac{1}{8}$.
The line $y=\frac{x}{4}$ has a gradient of $\frac{1}{4}$.
The line $y=8 x$ has a gradient of 8 .
The line $y-8 x=1$ becomes $y=8 x+1$ and has a gradient of 8 .
The line $8 x-8 y=1$ becomes $8 y=8 x-1$.

$$
y=x-\frac{1}{8} \text { and has a gradient of } 1 .
$$

The line $x=8 y$ becomes $y=\frac{x}{8}$ and has a gradient of $\frac{1}{8}$.
The answer is E .

## Question 16

$\left(\frac{1520}{5000} \times \frac{100}{1}\right) \%=30.4 \%$ of packets weigh more than 375 g.
Draw a diagram.


So $\operatorname{Pr}(X<375)=1-0.304$

=0.696
$$

Using CAS and Inverse Normal find $\operatorname{Pr}(Z<z)=0.696$ where $Z$ is the standard normal distribution (i.e. with mean of zero and $\sigma=1$ )

\text { So } \quad z=0.51293
$$

Now, $\quad z=\frac{x-\mu}{\sigma}$

## Question 17

Option A describes the shaded area as does option B.

The graph of the function $y=\frac{4}{x+1}-1$ is the graph of $y=\frac{4}{x+1}$ which has been translated 1 unit down. The integral $\int_{0}^{3}\left(\frac{4}{x+1}-1\right) d x$ gives the area which is equivalent to that part of the shaded area in the question above the rectangle with corner points $(0,0),(3,0),(3,1)$ and $((0,1)$. Since the area of the rectangle is 3 units, then option $C$ does equal the area of the shaded region.

Option D does not equal the area of the shaded region. The answer is D .

## Question 18

The graph below shows the graph of $y=f(x)$.


The graph below shows the graph of $y=f(x)$ after being dilated by a factor of 3 from $x$-axis.


The graph below shows the graph of $y=f(x)$ after being dilated by a factor of 3 from $x$-axis and then reflected in the $x$-axis.

The answer is B.

The answer is C.

## Question 21

We are looking for the antiderivative of $g$. Another way of thinking of this is that the graph of $g$ is the gradient function. From the graph of $g$ we see therefore that the antiderivative graph must have

- a gradient that is negative for $x<0$
- a gradient equal to zero at $x=0$
- a gradient that is positive for $x>0$

Option A does not have a gradient equal to zero at $x=0$.
Option B has a positive gradient for $x<0$ and a negative gradient for $x>0$.
Option D has the same.
Option E has a sharp point at $x=0$ and therefore the gradient at $x=0$ is not defined.
The answer is C.

## Question 22

This is a binomial distribution with $n=n$ and $p=0.4$.

Reject the negative answer.
Test $n=8$ in equation (1) Left side $=0.106376>0.1$
Test $n=9$ in equation (1) Left side $=0.070544<0.1$
So Nick must have played at least 9 games.
The answer is C.

c. The inverse function $f^{-1}$ does not exist because $f$ is not a $1: 1$ function.

x \leq \frac{31}{16}
$$

When $x=\frac{31}{16}, y=-\sqrt{2-\frac{31}{16}}$

$$
=-\frac{1}{4}
$$

The required point is $\left(\frac{31}{16},-\frac{1}{4}\right)$.
c. i. The rescue tunnel is a straight line that runs between the points $P(x, y)$ and $D(2+k, 0)$.
Since $P$ lies on the line representing the shaft with equation $y=-\sqrt{2-x}$, we can express $P$ as $(x,-\sqrt{2-x})$.
(1mark)
So the gradient of the straight line joining points $P$ and $D$ is given by

= & \frac{-\sqrt{2-x}-0}{x-(2+k)} \\

\end{aligned}
$$

ii. Since the gradient of the shaft is given by $\frac{d y}{d x}=\frac{1}{2 \sqrt{2-x}}$ from part $\mathbf{b}$. and since the gradient of the shaft equals the gradient of the tunnel at $P$, we have $\frac{1}{2 \sqrt{2-x}}=\frac{\sqrt{2-x}}{2+k-x}$.
Solve this for $x$ to find the $x$-coordinate of $P$.

Using CAS, $x=-(k-2)$

$$
=2-k
$$

(1 mark)
Substitute this into $y=-\sqrt{2-x}$

$$
\begin{aligned}
& y=-\sqrt{2-(2-k)} \\
& y=-\sqrt{k}
\end{aligned}
$$

The coordinates of $P$ are $(2-k,-\sqrt{k})$ as required.
d.


Method 1
At point $P, x=2-k$ so, $k=2-x$
Now, the domain of the shaft is $x \in[0,2]$.
When $x=0, k=2$.
Victoria can't get to point $G(2,0)$ because of the steepness of the tunnel. The last point she can get to is $\left(\frac{31}{16},-\frac{1}{4}\right)$ so this is the last point that the rescuers should be aiming their tunnel to end at.
When $x=\frac{31}{16}, k=2-\frac{31}{16}$

So $k \in\left[\frac{1}{16}, 2\right]$
Note that the endpoints are included because if the tunnel reaches the shaft at $x=0$ i.e. $k=2$ or at $x=\frac{31}{16}$ i.e. $k=\frac{1}{16}$, then Victoria can escape through it.

At point $P, x=2-k$ and we know that $0 \leq x \leq \frac{31}{16}$.
Solve $0 \leq 2-k \leq \frac{31}{16}$ for $k$. So $k \in\left[\frac{1}{16}, 2\right]$.
(1 mark) - one correct endpoint (1 mark) - a second correct endpoint
e. Since the rescue tunnel is a straight line joining the points
$P(2-k,-\sqrt{k})$ and $D(2+k, 0)$,
the distance $P D=\sqrt{((2-k)-(2+k))^{2}+(-\sqrt{k}-0)^{2}}$

& =\sqrt{(2-k-2-k)^{2}+(-\sqrt{k})^{2}} \\
& =\sqrt{(-2 k)^{2}+k} \\
& =\sqrt{4 k^{2}+k} \mathrm{~km}
\end{aligned}

Victoria can move at $0.5 \frac{\mathrm{~km}}{\mathrm{hr}}$ through the rescue tunnel so the time taken to move through it is
$\sqrt{4 k^{2}+k} \mathrm{~km} \div 0.5 \frac{\mathrm{~km}}{\mathrm{hr}}$
$=\sqrt{4 k^{2}+k} \mathrm{~km} \times \frac{\mathrm{hr}}{0.5 \mathrm{~km}}$
$=\sqrt{4 k^{2}+k} \times 2 \mathrm{hr}$
$=2 \sqrt{4 k^{2}+k} \mathrm{hr}$
Total time taken to move from $V$ to $D$ via $P$ is given by $T=6(\sqrt{2}-\sqrt{k})+2 \sqrt{4 k^{2}+k}$ as required.
f. i. Using CAS

\frac{d T}{d k}=\frac{8 k+1}{\sqrt{k(4 k+1)}}-\frac{3}{\sqrt{k}}

ii. Solve $\frac{d T}{d k}=0$ for $k$.

k=\frac{3 \sqrt{17}+5}{32}
$$

Since $P=(2-k,-\sqrt{k})$

$$
\begin{aligned}
& =\left(\frac{59-3 \sqrt{17}}{32}, \frac{-\sqrt{6 \sqrt{17}+10}}{8}\right) \\
& =(1.46,-0.74)
\end{aligned}
$$

where coordinates are expressed correct to 2 decimal places.
iii. $\quad T\left(\frac{3 \sqrt{17}+5}{32}\right)=6.68877 \ldots$

It takes 6.69 hours (correct to 2 decimal places) for Victoria to escape.
