# SCOUTMASTERS MERIT BADGE COUNSELORS and the SCOUTING FAMILY

As you review the new **2015-2016 Merit Badge Counselor Directory and Guide**, note that information has been included for Scouters and Merit Badge Counselors to understand this form of Advancement. Most important to the new members of the Scouting Family is how to properly fill-in a Merit Badge Card Application.

Included is the most current list of merit badge counselors available to our Scouts in the Pathfinder District along with a listing of merit badges that are without counselors. Also, note that BSA-National is continuing to revise and update all the merit badges in the system. A number of merit badges have already been extensively rewritten or revised. Included with the 2015-2016 release of the *Pathfinder District Merit Badge Counselor Directory and Guide Book* is the accompanying booklet *Pathfinder District Advancement Changes 2015*. This will help the Scoutmasters/Advisors with new revisions and new Merit Badge pamphlets (or e-books). This information was found online at <http://usscouts.org/meritbadges.asp>. This accompanying booklet was put together so that Scoutmasters/Advisors will have all current merit badge information readily available.

***"When there is a conflict between two different sets of requirements, such as the Requirements Book and the Merit Badge Book the Requirements Book shall be the controlling document BSA-National will publish the Requirements book annually (each January) with the most current information on the merit badge revisions and Scout rank advancement."***

An application to become a Merit Badge Counselor and National Council's Adult Merit Badge Counselor Application are located in the back of this guide. ALL Merit Badge Counselors MUST be registered with BSA-National and have taken the current BSA Youth Protection Certification course. Merit Badge Counselors do not have to have a unit affiliation, BUT they must be registered.

If you are a Counselor and wish to make changes or update your information you will find that form at the end of this guide. Merit Badge Counselors must use the current applications in the back of this guide. Old applications will not be accepted.

## IMPORTANT INFORMATION

	Age
<b>REQUIREMENT</b>	
Eligibility	

*Merit badges, badges of rank, and Eagle Palms are for boys who are registered Boy Scouts or Varsity Scouts. Any registered Boy Scout or Varsity Scout may earn these awards until his 18th birthday. Any Venturer who achieved the First Class rank as a Boy Scout or Varsity Scout in a troop may continue working for the Star, Life, and Eagle ranks and Eagle Palms while registered as a Venturer up to his 18th birthday.*

## **Rank Advancement For Venturers**

Any male Venturer who has achieved the First Class rank as a Boy Scout in a troop or Varsity Scout in a team may continue advancement toward the Star, Life, and Eagle Scout ranks up to his 18th birthday. He must meet the requirements as prescribed in the official *Boy Scout handbook* and the current *Boy Scout Requirements* book. The Venturer may fulfill leadership requirements by serving as president, vice president, secretary, or treasurer of his crew, or as boatswain, boatswain's mate, yeoman, purser, or storekeeper for his ship.

The Scoutmaster conference will be conducted by the Advisor or Skipper. As the Venturer meets requirements for the Star and Life ranks, a board of review will be conducted by the crew or ship committee. The Eagle board of review should follow the procedures established by the local council.

## Information for Merit Badge Counselors

### MERIT BADGE COUNSELING

The merit badge program is part of the advancement plan of the Boy Scouts of America. It has guided the interests and energies of Boy Scouts for 100 years and is one of the most unusual educational programs ever devised. A merit badge is an award that is presented to a Boy Scout when he has completed the requirements for one of more than 120 subjects in a wide variety of arts, crafts, hobbies, sports, trades, professions, agribusiness, service, or self-improvement areas. The badge is only a small piece of cloth with a design embroidered in color but its significance is as large as the interest of the merit badge counselor who helps a Scout earn it. This could not have happened without the service of thousands of merit badge counselors like yourself an expert in a particular subject and interested in helping Scouts grow into men of character, ready to take their place in the world of work as participating citizens. You're probably saying, "That's all great, but what do I do, and how do I do it?"

### WHAT'S MY JOB?

Your job is to satisfy yourself that each Scout who comes to you meets all the requirements for the merit badge. In this sense you are an examiner. But, your larger opportunity lays in coaching-helping the Scout over the different hurdles of the requirements and making him aware of the deeper aspects of the subject from your knowledge and experience.

### WHAT DO I AGREE TO?

As a merit badge counselor, I agree to:

Follow the requirements of the merit badge, making no deletions or additions, ensuring that the advancement standards are fair and uniform for all Scouts. Have two or more Scouts present at all instructional sessions. Renew my registration annually if I plan to continue as a merit badge counselor.

### DO MORE OR DO LESS?

The Scout is expected to meet the requirements as stated, no more and no less. Furthermore, he is to do exactly what is stated. If it says, "show or demonstrate," that is what he must do. Just telling about it isn't enough. The same thing holds true for such words as "make," "list," "in the field," and "collect, identify, and label."

On the other hand, you cannot require more of a Scout than stated. You must not, for example, say, "I want to be sure you really know your stuff, so instead of the 20 items in your collection, you must have 50 to get my signature." You can suggest, encourage, and help the Scout to get 50 things, but you must not require it.

You might wonder, then, if the requirements as stated are the limits, what there is for you to do other than help the Scout with the specifics of these requirements? Actually, you can go far beyond them in your discussions with the Scout. He probably will welcome your willingness to share with him your knowledge well beyond the requirements, and you will be making a real contribution to him by doing so. But it isn't required. That's the key. The Scout does not have to show his knowledge of those things beyond the requirements.

You might stress the fact that while knowledge is necessary, whether he can put his knowledge to work is the important thing in life. As you work with the Scout you can give him indirect career guidance. Many merit badge subjects can acquaint a Scout with the job opportunities in various fields. In these cases the merit badge work is a real exploration in an adult work experience, showing him whether or not he has the interest or ability along such lines. His activity also can show him what educational requirements a subject area has.

You can provide the Scout with valuable information on job possibilities; show him what is most interesting to you and what is difficult. The final choice-the selection of what he is going to do with himself in life-is up to one person. That person is the Scout himself. However, he will appreciate your help in showing him the relationship of his merit badge work to his life as he goes to school, into business or a trade, and on into adult life.



## **Information for Merit Badge Counselors**

### **WERE DO YOU MEET?**

If the merit badge subject relates to your job or profession, then your place of work is probably the place to meet with Scouts.

Subjects that are related to your hobbies usually will be handled in your home. Here you will have hobby-related materials to use in your coaching of Scouts.

For a few subjects, coaching will happen in the field or where special equipment is at hand. Rowing, Rifle Shooting, Swimming, and Astronomy are good examples.

### **CAN YOU PROMOTE YOUR SUBJECT?**

Scout troops and Venture Crews are constantly seeking program material for meetings.

If you would like to expand interest in your subject and to attract more Scouts to earn the merit badge, contact Scoutmasters and Venture Advisors in your area and offer to come to a Troop or Crew meeting to "sell your subject."

All Scouts won't be interested in the subject, so plan an exciting 10 or 15-minute presentation designed to tickle the fancy of your audience. Then offer to meet with those who are really interested after the meeting to plan for your next get-together.

### **DO YOU NEED A MERIT BADGE PAMPHLET?**

The information in the pamphlet is probably familiar to you, but it will help you to know what the Scout is told to do. They are written for Scout-age boys. They also contain suggestions for projects that might give you ideas for being helpful.

It's a good idea to obtain the latest printing of the pamphlet on your subject. It will contain the latest requirements and information on meeting them. The printing dates are in each pamphlet. A complete list of merit badge pamphlets is printed on the inside back cover of all pamphlets with the latest revision date of each. By checking this list in any current year's pamphlet, you can find out whether your pamphlet is updated. Most pamphlets are reprinted each year, and the contents are updated periodically. Several pamphlets are available as an eBook through [www.Amazon.com](http://www.Amazon.com).

### **HOW MANY AT A TIME?**

Frequently the skills of a subject can be taught to several Scouts at one time, and are always taught to at least two individuals (remember the Scout buddy system). The completion of the requirements must always be done on an individual basis. Scouts cannot qualify for a merit badge by just being a member of a group that is instructed in skills. They must qualify by personally satisfying you that they can meet all the requirements.

Scouts learn at their pace and should not be held back or pushed ahead by his associates in the group.

So remember- you can coach more than one at a time, but only one Scout at a time can satisfy you that he can meet the requirements.



## **Information for Merit Badge Counselors**

### **HOW THE SCOUT EARNS A MERIT BADGE**

These are the steps that a Scout takes to earn a merit badge, as outlined in the *Boy Scout Handbook*. Also, please refer to the new *A Scout's Guide to Merit Badges* for additional information.

- Gets a signed merit badge application from his Scoutmaster or Venture Advisor and finds a buddy who can attend the merit badge counselor meetings with him.  
His buddy can be another Scout, a parent or guardian, a brother or sister, or a relative or friend.
- Gets the merit badge pamphlet on his subject.
- Contacts the merit badge counselor and explains that he would like to earn the badge. The Scout should dress in full Scout Uniform. No sneakers or white socks.  
Along with his buddy, meets the Counselor and discusses how he can get the most out of the time he spends working on the badge.
- Learns and does the things that the pamphlet explains. He goes far as he can to fulfill the requirements on his own.
- When he is ready, he and his buddy make another appointment with the Counselor.  
The Counselor will spend time with him going over the important parts of the subject.  
A good Counselor will also help him see beyond the requirements and discover ways to continue learning about the subject.  
When the Counselor is satisfied that the Scout has completed the requirements, he will then sign the merit badge form. The Scout gives the signed form to his Scoutmaster or Venture Advisor.  
They will get the merit badge for him and present it to him during a troop or crew ceremony.

### **HOW DOES THIS RELATE TO YOU - THE MERIT BADGE COUNSELOR**

1. A buddy must accompany the Scout to visit you. The Scout should also bring a merit badge application signed by his Scoutmaster or Venture Advisor.
2. The Scout contacts you, probably by phone or email. You may tell him what is expected of him over the phone, or you may want to make an appointment to discuss this with him face-to-face. Personal contact will make earning the badge a better experience for both you and the Scout.
3. In your discussion of what is expected, you may want to start by finding out from the boy what he already knows, so you can spend your time on helping him learn the remaining items, or give guidance in completing projects. You can set up additional meetings with the Scout-not only for the purpose of passing him on the requirements, but rather to help him in his understanding of the subject.
4. The Scout, along with his buddy, should make another appointment with you when he thinks he is prepared to prove his ability. You set the date, time, and place.

5. The Scout with some apprehension will approach this session. He is familiar with final exams in school and may look on this meeting with you as another such experience. You can help a great deal by putting the boy at ease. Talk with him rather than examine him. There is a big difference, yet you can find out what the boy knows. Express honest enthusiasm for the things he has done, particularly if projects are involved. Your approval will give confidence to the Scout.
6. When he meets you, he should bring with him the projects required for completion. If the things he has done cannot be transported, he should present you with satisfactory evidence, such as a photograph of the project or adult certification. His Scoutmaster or Venture Advisor might, for example, certify that a satisfactory bridge or tower has been built for Pioneering, or that the required meals were prepared for the Cooking merit badge. Your job, in addition to coaching, is to satisfy yourself that the requirements have been met. Question the Scout and, if you have any doubts, contact the adult who signed the statement.
7. When you are satisfied that the Scout has met the requirements; you sign his merit badge application. You may work with many Scouts each year as they earn merit badges. Your contact with these Scouts is tremendously important. Your influence is measured not by how many Scouts you work with, but the effect upon the lives of those you have an opportunity to work with.
8. Throughout your association with the Scout, keep in mind that you are in reality assisting the Scoutmaster and the Venture Advisor in the program of advancement, which the Scoutmaster or Venture Advisor helps each of his Scouts plan. Often, the Scoutmaster or Venture Advisor will help the Scout select the merit badges he will earn for a particular award. Whether he does or not, he is always interested in the Scout's progress. You should feel free to discuss the Scouts work with his unit leaders at any time.







# The Merit Badge Process

1. A Scout is guided to the requirements for a Merit Badge. He can also review *A Scout's Guide to Merit Badges*.
2. The Scout finds the requirements in:
  - A. **Boy Scout Requirements**
  - B. Merit Badge Pamphlet (or eBook)
  - C. Internet
3. The Scout indicates his interest in a particular Merit Badge to his Scoutmaster/Advisor, who:
  - A. gives him an interview to determine interest, enthusiasm, and preparedness
  - B. gives him a signed **Application for Merit Badge (aka Blue Card)**
  - C. with the District Merit Badge Counselor List, helps the Scout locate the name, phone number and email address of the district/council approved Merit Badge Counselor
  - D. encourages the Scout to wear his Class A uniform when he visits the counselor with his buddy
4. The Scout telephones or emails the Merit Badge Counselor and makes an appointment.
5. The Merit Badge Counselor sets the date and time for the Scout and his buddy and suggests the Scout:
  - A. bring the Merit Badge Pamphlet (eBook device)
  - B. bring the Application for Merit Badge
  - C. prepare by reading over the requirements and start working on some of the areas
  - D. bring the work he has started or accomplished
  - E. bring any other documentation he may have
6. At the first meeting, the Merit Badge Counselor and the Scout decide upon:
  - A. verifies the current requirements for the Merit Badge and any projects that will be required
  - B. a tentative schedule for completing the requirements both short-term and long-term, keeping the other obligations (Scout, school, church, etc.) in mind
  - C. dates, times and location for future meetings
7. The number of counseling sessions depends on the difficulty of the Merit badge requirements and the preparation and ability of the Scout.
8. The Scout is expected to meet the requirements for the Merit Badge as stated—no more and no less.
9. The Scout is coached and encouraged with a buddy present. The Merit Badge Counselor may expand on the information in the Merit Badge Pamphlet based on his knowledge, experience and expertise in the subject. He is encouraged to tell about his own experiences that positively reinforce the subject matter of the Merit Badge requirements.
10. The Merit Badge Counselor assists the Scout to meet the requirements.
11. The Scout is always tested individually, but with a buddy present, and as each requirement is completed the Merit Badge Counselor marks it on the application.
12. The Merit Badge Counselor certifies when the Scout has completed the requirements and hardily congratulates him on completing the requirements.
