She wanted to play like other children, but could not lift anything or even raise her arms. Researchers at Nemours/Alfred I. duPont Hospital for Children 3D-printed a custom exoskeleton with tiny, lightweight parts. Now, she can play like other children, with the help of the Wilmington Robotic EXoskeleton, or WREX. Or, as she calls them, her "magic arms." ## Johnny Holloway: Continuing a Legacy of Giving Back

Johnny Holloway is a respected Orlando philanthropist who has a love of children, families and the community. He is a compassionate and engaged partner and a valued friend to Nemours Children's Hospital (NCH) in Orlando. He supported NCH with personal gifts, and as a true community leader, he is inspiring others to follow his lead.

In 2014, Johnny made a personal contribution of \$50,000 for *A Night with Nemours: La Vie En Couleur*, NCH's fundraising gala. His sponsorship inspired other gifts, and *A Night with Nemours* ultimately raised a record-breaking \$580,000. Those funds are being used to build a customized pediatric ambulance, which will help NCH fulfill its vision of a world-class transport system. This new ambulance will ensure that patients receive expert, family-centered care while they are en route to the hospital.

Johnny's support of Nemours is a family affair. One of his sons, Chad, is a member of the Family Advisory Council. Also, much of what Johnny does is to further the legacy of his father, Jack Holloway. Jack founded ABC Fine Wine & Spirits, starting with a single bar in downtown Orlando in 1936. A foundation was later established in his father's name.

Johnny himself knows the sting of childhood illness. One of his brothers had cerebral palsy and died at a young age. This is one of the many reasons that Johnny is so passionate and committed to helping children who are sick or injured. Ultimately, Johnny says he is trying to make a positive impact, and to continue his father's legacy of goodwill.

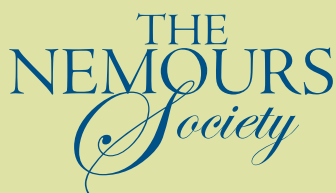

## Patient Care and Services



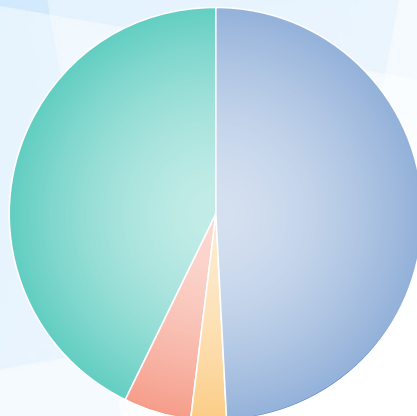
- Expanding the pet therapy program to additional patient care areas. Interacting with pets has been proven to help children with pain and stress management.

- Conducting a food allergy cooking demo, which is an increasing need, as families become more aware of their children's allergies.

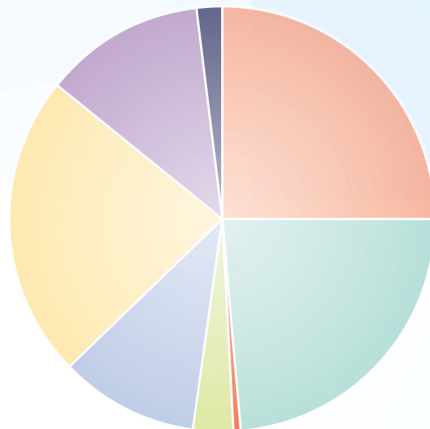


# Biomedical and Clinical Research

- Developing adaptive technologies such as ModelTalker Text-to-Speech, a program that provides lifelike voices for children who are unable to speak.

## A Focus on Central Florida

Nemours Children's Hospital (NCH) in Orlando has few partners more dedicated than the Edyth Bush Charitable Foundation. The foundation was one of the first groups to advocate for the construction of NCH. To date, the foundation has donated more than half a million dollars to Nemours, including a highly visible challenge grant, which inspired additional philanthropy from the community.

The Edyth Bush Charitable Foundation was created in 1973. Edyth Bush was a ballet dancer, actress, musician, composer and playwright. The foundation works to fulfill the direction from Edyth Bush to "make Central Florida a better place for all of its citizens." The foundation supports the high quality pediatric care provided by Nemours, realizing the benefit it provides to the community and to the state.

Most recently, the foundation provided a generous \$50,000 sponsorship for *A Night With Nemours: La Vie en Couleur*. This event ultimately raised more than \$580,000. These funds will help NCH secure a new, state-of-the-art ambulance for its transport program. This vehicle will be the first of a fleet, which will transport children to NCH from nearby partnering hospitals and medical centers when they require specialty care.

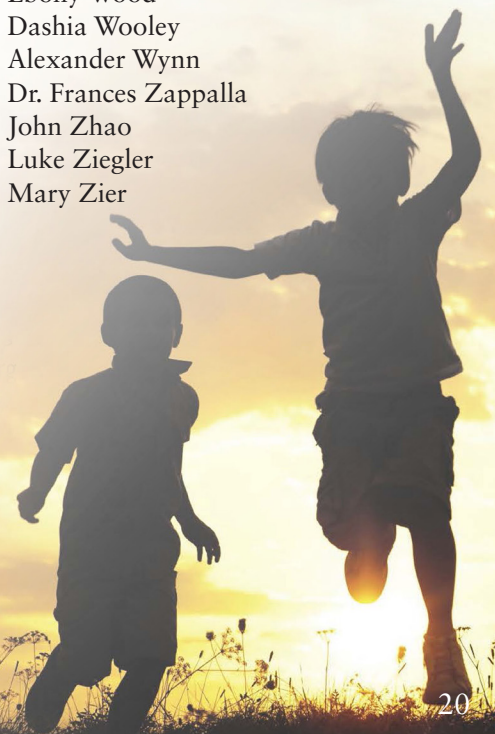
