2014 BMW Purchase Program

For the calendar year 2014, all individuals eligible for the BMW-USOC Purchase Program can receive dealer invoice pricing on the lease or purchase of eligible new 2014 and 2015 BMW/MINI vehicles and BMW SAVs. Additional cash allowances between \$500-\$3,000 below dealer invoice are available depending on model and financing.

Eligibility is limited to one (1) lease or purchase per calendar year, and is restricted to (USOC Executive Directors, USOC employees, partner NGB (USA Swimming, USA Bobsled & Skeleton, U.S. Speedskating, or USA Track & Field) Executive Directors, partner NGB Board of Directors, partner NGB employees, U.S. Olympians, U.S. Paralympians, U.S. Olympic and Paralympic Team Coaches, and BMW Performance Team members). Participation in the BMW Purchase Program does not preclude eligible individuals from participation in additional dealer incentives/programs throughout the year.

To enroll in the program:

2. Log on to www.BMWGroupPurchaseProgram.com and select “sign up” to create a new account
3. Along with your personal code, input all of the pertinent account information to create a new account
4. Sign in to your new account and print the appropriate form under “Vehicle Lease/Purchase Form”
5. Provide the form to your local dealer upon arrival (please be sure to save one copy for your records as well)
