Ms. Almquist is a marketing, fundraising and community outreach consultant specializing in Southern Arizona communities.

In 2007, Arizona Governor Janet Napolitano appointed her Director of the Governor's Southern Arizona Office. The Tucson-based office is directly responsible for community outreach, legislative advocacy, and constituent service across five counties: Pima, Pinal, Cochise, Santa Cruz and Yuma. Service in that position ended with the appointment of Governor Napolitano as U.S. Secretary of Homeland Security. William Bowen

When Mr. Bowen retired from Heidrick & Struggles, the world's leading executive search firm, he and his wife moved to Tucson and he volunteered to be an Executive in Residence at the Eller College of Management. 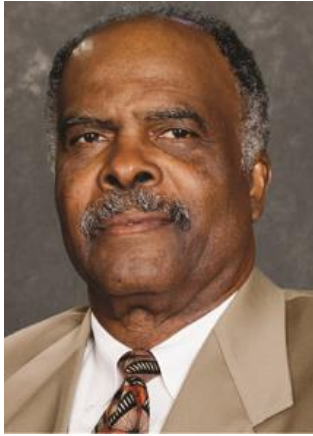

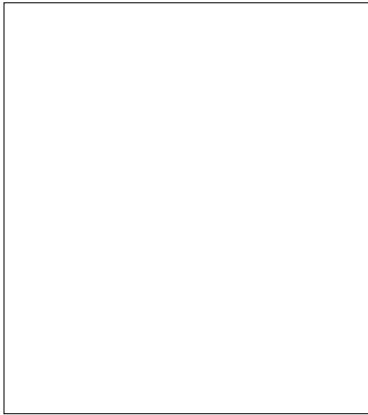

John Hildebrand

John G. Hildebrand joined the faculty of the University of Arizona in Tucson in 1985 after serving as a faculty member at Harvard (1970-80) and Columbia (1980-85) Universities. He is Regents Professor of Neuroscience and Professor of Chemistry & Biochemistry, Entomology, and Molecular & Cellular Biology. He earned his baccalaureate degree at Harvard University (1964) and his Ph.D. (in biochemistry, 1969) at the Rockefeller University. He was founding Director of the ARL Division of Neurobiology at the University of Arizona (1985-2009) and subsequently founding Head of the Department of Neuroscience after the Division of Neurobiology became the Department of Neuroscience (2009-13).

Hildebrand and his coworkers study insect nervous systems, with a current focus on the neurobiology of the olfactory system and its roles in behavior as well as related areas of chemical and sensory ecology. This work teaches us about mechanisms that are common to vertebrate and invertebrate nervous systems and at the same time contributes to knowledge that will help alleviate the harm done by insects that are predators of the human food supply or vectors of disease. He is author of more than 210 peer-reviewed research papers and reviews and editor of five books.

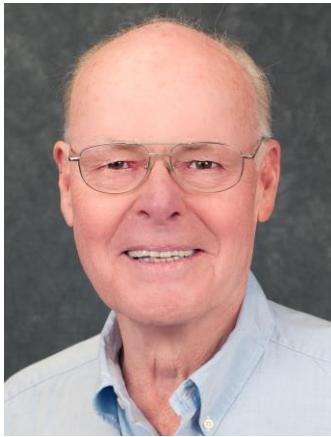
Hildebrand is past president of several scientific societies, including the Association for Chemoreception Sciences (AChemS), International Society of Chemical Ecology, and the International Society for Neuroethology, and a frequent consultant to federal agencies, private foundations, and companies. Among his strongest interests is education at all levels, and in that connection he served for many years as chairman of the Board of Neuroscience Schools of the International Brain Research Organization (IBRO) and as a member of the Training Advisory Committee of the APA/ANDP/NIH Diversity Program in Neuroscience. He is a member of the National Academy of Sciences and currently serves as an elected member of the Academy's Council. He also is a member of the American Academy of Arts and Sciences and the German National Academy of Sciences 'Leopoldina'; a foreign member of the Norwegian Academy of Science and Letters and the Royal Norwegian Society of Sciences and Letters; an Honorary Fellow of the Royal Entomological Society (UK), and a fellow of the American Association for the Advancement of Science, the Entomological Society of America, and the International Society for Neuroethology. Among his other honors are an Einstein Professorship in the Chinese

Academy of Sciences, the Outstanding Service Award for Contributions to the Biological Sciences from the American Institute of Biological Sciences, the Silver Medal of the International Society of Chemical Ecology, the Founders Memorial Award of the Entomological Society of America, and a Max Planck Research Award and a Humboldt Research Prize from the Alexander von Humboldt Foundation.

In addition to his extensive activities as an academic scientist, Hildebrand serves as a consultant to the Sherman Fairchild Foundation, a member of the Advisory Board of UApresents (the performing-arts presenting organization of the University of Arizona), and a community volunteer at Tucson's J.B. Wright Elementary School. In 2013 he was elected to membership in the Cosmos Club in Washington DC. For thirty years until 1985, he enjoyed a parallel career as a free-lance professional musician in Boston and New York City. He is included in several versions of *Who's Who*.

K. Tsianina Lomawaima is Professor at the ASU School of Social Transformation.

Born in Kansas City, Kansas; Tribal affiliation Muskogee/Creek Nation of Eastern Oklahoma (not enrolled) on father's side; mother's side German Mennonite.

Prof. Lomawaima earned her graduate degrees (M.A. and Ph.D.) in anthropology from Stanford University, where she was a Ford Fellow & a Dorothy Danforth Compton fellow. In 1988, she was hired as an Assistant Professor in the Anthropology Dept./American Indian Studies Center at University of Washington, Seattle, where she taught for six years and was tenured. Moved to University of Arizona, American Indian Studies Program in 1994; Head 2005-2009. She transitioned to her current position January 2014.

An interdisciplinary scholar whose work straddles Native Studies, anthropology, education, ethnohistory, and history, Lomawaima focuses on the early 20th century, examining the “footprint” of federal Indian policy and practice in Indian country, and the creative, persistent ways Native peoples have asserted sovereignty, protected language and culture, and resisted and co-opted federal agendas. Research on the experiences of American Indian alumni of a federal off-reservation boarding school is rooted in the experiences of her father, Curtis Thorpe Carr, who was raised from age 9 at Chilocco Indian Agricultural School in Oklahoma. Interviews with her father and sixty of his contemporaries, plus information from federal policy and archives, appear in *They Called it Prairie Light: The Story of Chilocco Indian School* (1994, University of Nebraska Press), winner of the 1993 North American Indian Prose Award, and the American Educational Association's 1995 Critics' Choice Award.

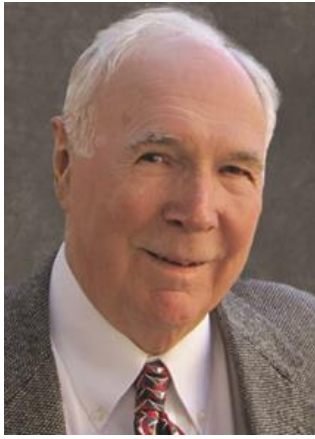

In 1953 he became Assistant Professor of Metallurgical Engineering at Carnegie Institute of Technology, subsequently Carnegie Mellon University, and became Head of the Department of Metallurgy and Materials Science and Director of the Metals Research Laboratory at Carnegie Mellon in 1966. He was Visiting Professor of Metallurgy and Materials Science at Imperial College, London, in 1962-63 and at the Massachusetts Institute of Technology in 1970 and served two years at the first Director, Division of Materials Research, National Science Foundation 1971-1973. He is a consultant to industry and has authored many technical papers, primarily in the field of physical metallurgy. He also co-authored a book, "Alloying Elements in Steel", with the late Dr. E.C. Bain. From 1974 to 1986, he was associated with the United States Steel Corporation, serving as V.P. Research and eventually V.P. Corporate Research and Technology Assessment. Dr. Paxton received the Bradley Stoughton Award for Young Teachers of Metallurgy in 1960. He is a Fellow of the American Association for the Advancement of Science, member of the National Academy of Engineering, Fellow of the American Society for Metals and The Mining, Metallurgical and Materials Society of AIME (TMS); Past President of TMS; Past Chairman of the General Research Committee of the American Iron and Steel Institute; and 1982 President of American Institute of Mining, Metallurgical, and Petroleum Engineers.

Dr. Paxton was selected as the 1978 ASM Edward DeMille Campbell Memorial Lecturer. In 1982 he was the BCRA Carbonization Science Lecturer and also the Australasian Institute of Mining and Metallurgy Lecturer. In 1983, Dr. Paxton gave the ASM Zay Jeffries Lecture. Late in 1983 he received the ASM Gold Medal for the Advancement of Research. In 1985, he was elected an Honorary Member of the Iron and Steel Institute of Japan, and delivered the Yukawa Memorial Lecture to that Institute. In 1987 he gave the Harold Moore Lecture to the Institute of Metals (London). In 1990, he was invited to give one of the keynote lectures at the 6th International Iron & Steel Congress in Nagoya, Japan, was an AIME Krumb Lecturer, Andrew Carnegie Lecturer, and Sauveur Lecturer. In 1991, he was elected an Honorary Member of AIME. He has also lectured in France, the U.K., Holland, Argentina, Brazil, Mexico, Poland, China, and the former USSR. In 2010 he was invited as the keynote speaker to an International Conference in Iran, but could not attend due to political strains.

For the last several years, he has been Chief Scientist on a program with ATI to enhance opportunities for high strength low-alloy vanadium steels in both government and industry

Since arriving in Green Valley in 2005, he was elected to the board of CPAC in late 2008 and became Chair in January 2009. The Center opened in the spring and since then has become established as a leader in all forms of art – theater, music, visual arts, lectures etc., with a strong outreach to children in the area. We believe it has made a noticeable difference to the community, and we plan to continue a diverse program as funds permit.

Gibson earned a Bachelor of Science Degree in Broadcasting with a minor in Management/Marketing from the University of Florida and is a graduate of the Corporation for Public Broadcasting's Executive Management Institute at the University of Wisconsin, Madison.
