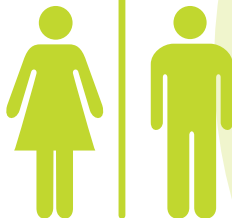


CVI reached **1,962** people in the community through public education activities like CVI tours, health fairs and United Way events.

Approximately 2/3 of CVI clients are low income (earning less than 200% of the federal poverty guidelines.)



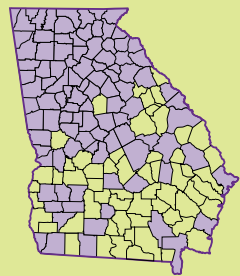

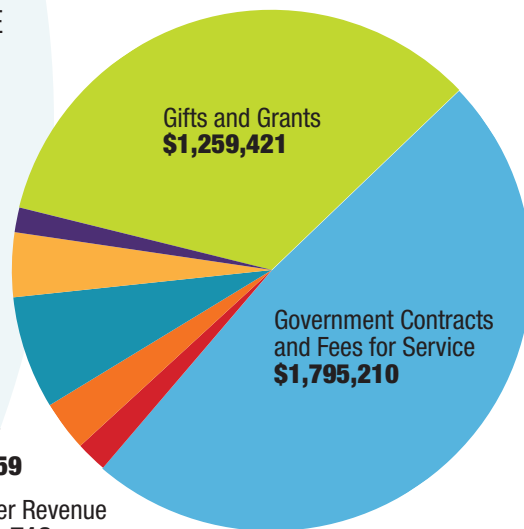

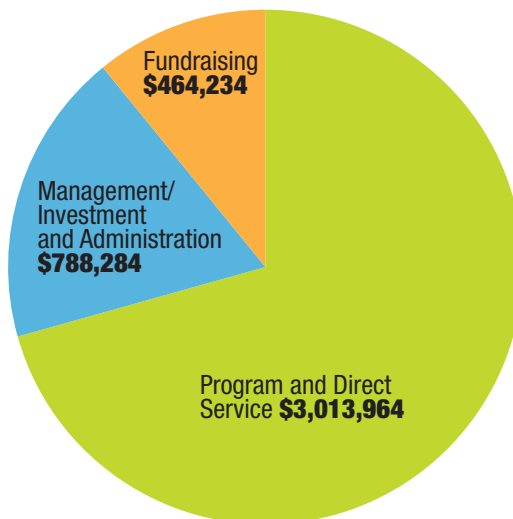
