

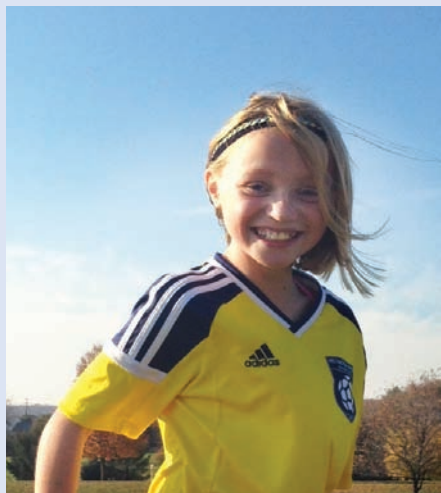

Four years ago, our family walked through the doors of Nemours for the first time. I was hand-in-hand with my daughter, Ava. Both of us were petrified.



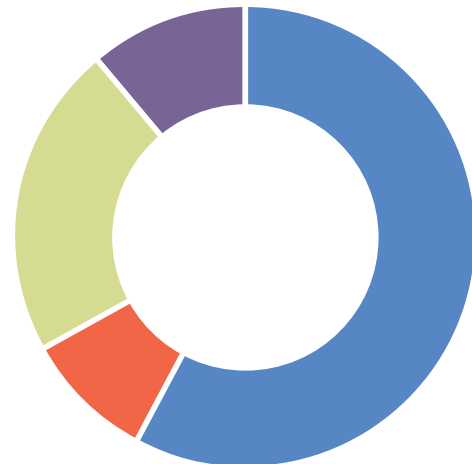

- Established the Katzin Diagnostic & Research PET/MR Center. The PET/MR allows neurosurgeons to perform more targeted, world-class epilepsy surgery and facilitates groundbreaking autism research.
- Achieve FDA approval for nusinersen – the first drug for the treatment of spinal muscular atrophy (SMA).
- Continue critical research on acute myeloid leukemia (AML).
- Purchase specialized vision testing equipment for children in Jacksonville, Fla.
- Conduct specialized trainings for the air medical crew in Orlando, Fla., to increase their skills when transporting critically ill children via helicopter.
- And much, much more.
