Our services to victims of domestic violence and sexual violence include:

- ▶ A confidential Domestic Violence/Sexual Violence Hotline, available 24/7.
- ▶ A team of certified, specially-trained advocates.
- ▶ Safety planning, crisis counseling, resources and referrals, and information.
- ▶ Advocacy and accompaniment in the courts, hospitals, law enforcement agencies, and on college campuses.

CHILD ADVOCACY CENTER AND SEXUAL VIOLENCE CRISIS SERVICES IN HERKIMER COUNTY

As part of a multidisciplinary team (MDT), our staff provides accompaniment and advocacy during the traumatic process of reporting, as well as counseling, support, comfort, and healing to child victims of sexual abuse and extreme physical abuse, and to adult victims of sexual violence.

PREVENTION EDUCATION & OUTREACH PROGRAM IN HERKIMER AND ONEIDA COUNTIES

Our Prevention Education and Outreach program serves as a voice for our mission and services by building community ties and promoting healthy lifestyles, in Herkimer and Oneida counties.

We promote awareness and community action around issues of racism, bullying, dating violence, domestic violence, sexual violence, sexual harassment, child abuse, and LGBTQ rights.

In 2016:

We continued to strengthen our

Social Justice

program with events like Stand Against Racism; by holding public gatherings for people to unite in support of women's issues; and by attending rallies and marches in support of women's rights and human services agencies we work with regularly.

We connected with

nine

private and state-funded institutions of higher learning through the Enough is Enough Initiative, providing advocacy and education for victims of sexual violence.

We provided outreach to more than

10,837

individuals, from kindergarten to senior citizens, living and working throughout Herkimer and Oneida counties.

RESIDENTIAL CRISIS SERVICES IN ONEIDA COUNTY

In 2016, we provided the opportunity of a second chance at life for approximately 206 adult and child victims of domestic violence through our emergency shelters and transitional housing programs.

A SURVIVOR'S SUCCESS STORY

Jaqueline's first encounter with a YWCA MV advocate occurred in the ER (Emergency Room), where she fled after being raped by her boyfriend. Visits to the ER and encounters with advocates soon became a regular occurrence, as the incidences of domestic violence escalated in Jaqueline's relationship. Finally, she accepted the services that had been offered repeatedly by each advocate responding to the crisis calls.

"I realized this was my life, and I felt he was going to kill me if I continued. The hotline, family court, police department, and support group staff all helped me stay safe with daily safety plans, by helping me get an order of protection, and by providing on-going support. They helped me get my life back, and I became empowered. The help of the advocates made me a survivor."

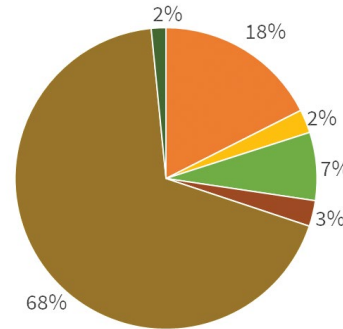

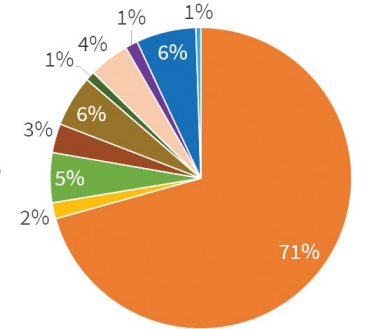
