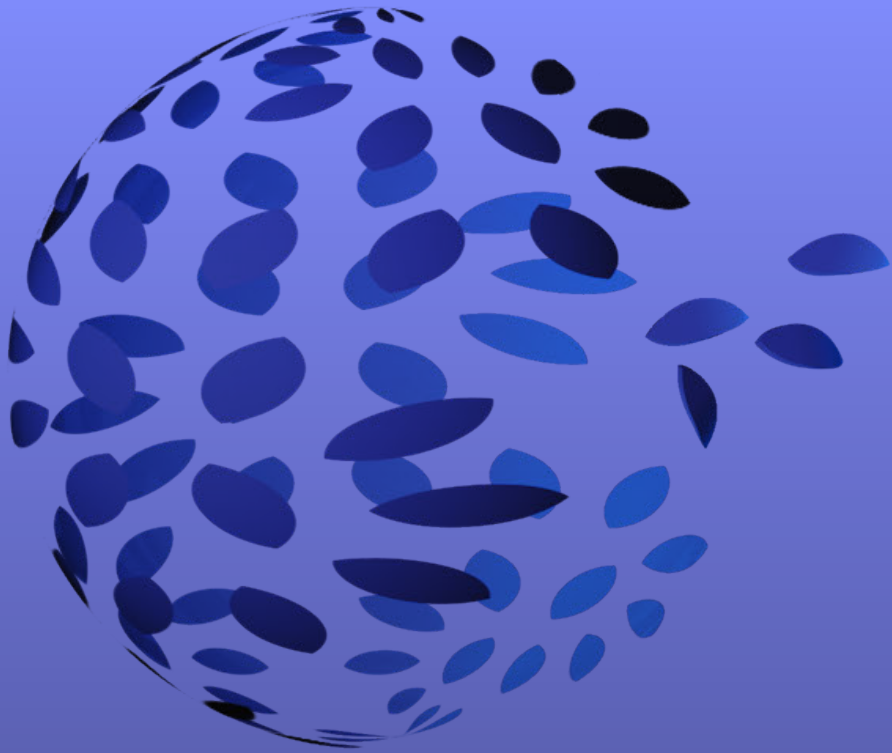

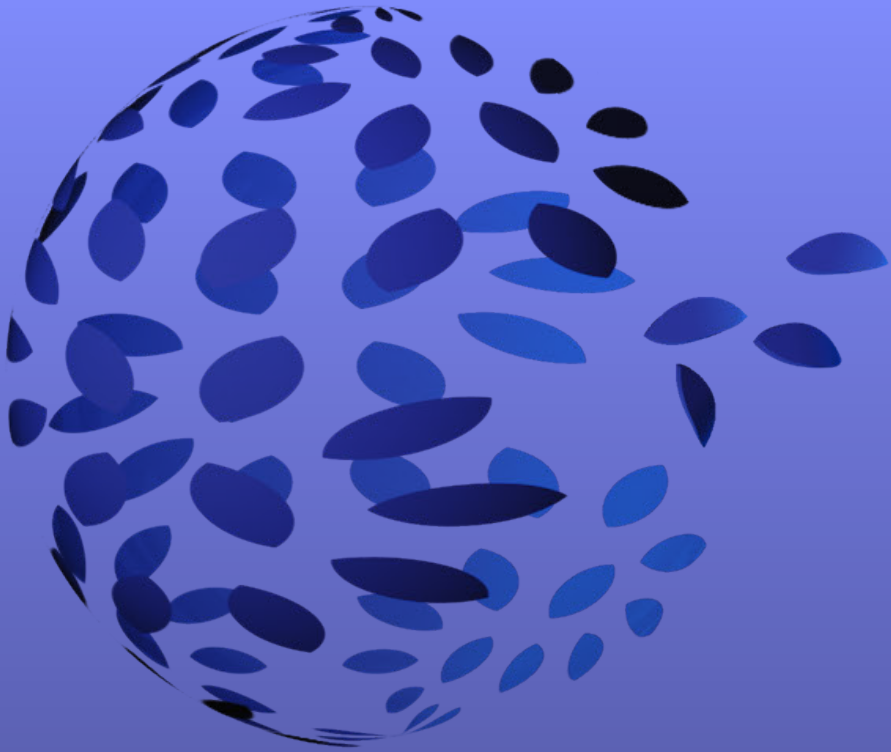
NEXT GEN COMMITTEE CHAIRS

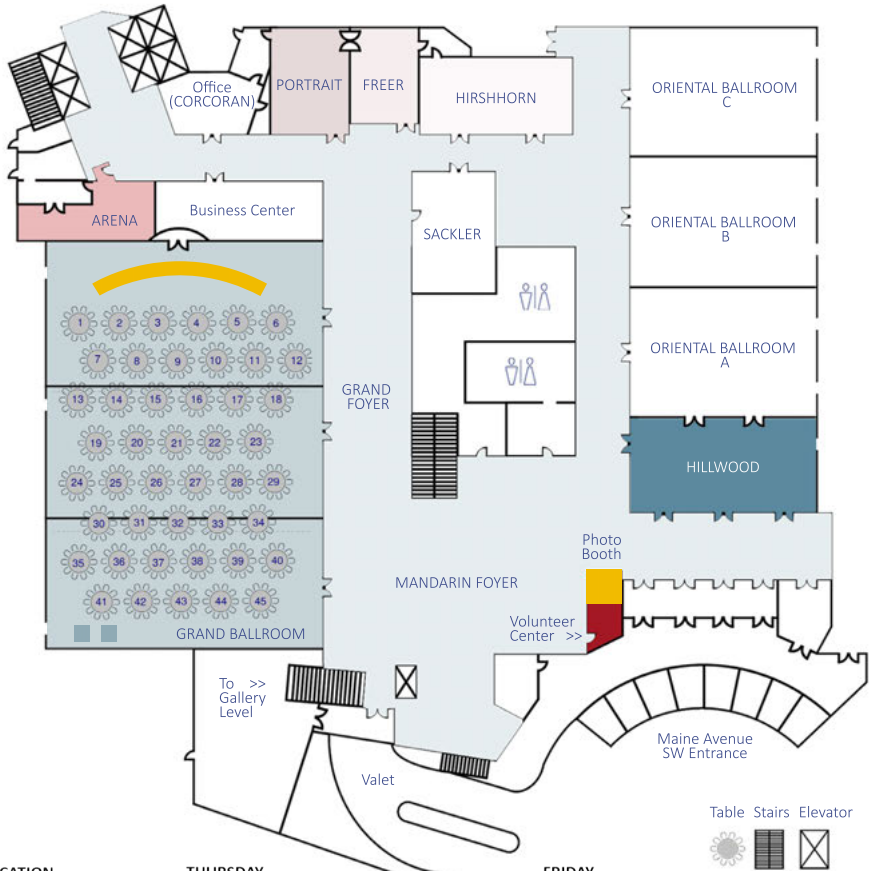

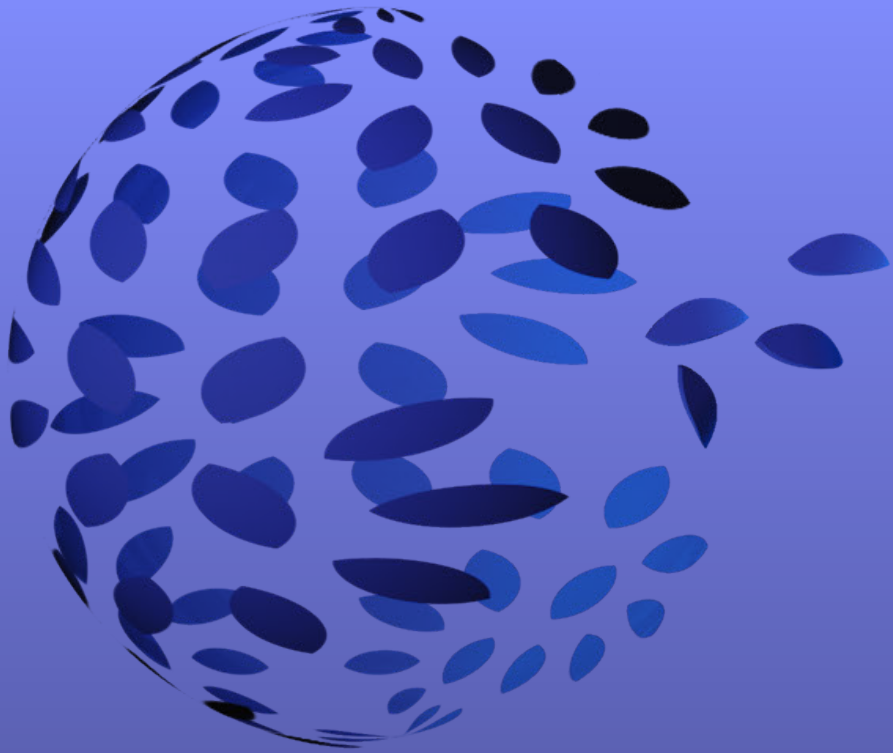

HON. GEORGIANNA BRADEN | ADMINISTRATIVE PATENT JUDGE, USPTO

Georgianna Witt Braden was appointed as an Administrative Patent Judge to preside over trial proceedings under the America Invents Act and to decide appeals arising from adverse decisions of Examiners at the United States Patent and Trademark Office. Judge Braden earned a Juris Doctorate from The University of Houston Law Center, a Ph.D. in Cell and Molecular Biology from the University of Nebraska Medical Center, and a Bachelor of Science in Biology from Saint Louis University. Judge Braden spent ten years in private practice at Howrey, LLP, which later merged with Winston & Strawn, LLP, where she litigated intellectual property cases and prosecuted patent applications.



ERIKA BROWN LEE | CHIEF PRIVACY AND CIVIL LIBERTIES OFFICER, U.S. DEPARTMENT OF JUSTICE

Erika Brown Lee is the Chief Privacy and Civil Liberties Officer of the United States Department of Justice. As the Chief Privacy and Civil Liberties Officer, Erika is the principal advisor to the Attorney General and DOJ senior leadership on privacy and civil liberties matters affecting the Department's missions and operations. Erika also heads the Office of Privacy and Civil Liberties, and oversees the DOJ's privacy and civil liberties programs and initiatives implemented by the Department's 40+ components. Prior to the DOJ, Erika held several positions at the Federal Trade Commission, including investigation and enforcement in the Division of Privacy and Identity Protection, Attorney Advisor to an FTC Commissioner, and Counsel to the Director of the Bureau of Competition. Erika also worked in private practice, specializing in privacy, data security, and competition matters.



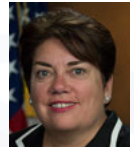
JENNIFER BURDMAN | PARTNER, KING & SPALDING

Prior to joining the Criminal Division, Ms. Caldwell was a partner at Morgan Lewis & Bockius LLP, a position she held since 2004. From 2004 to 2009, Ms. Caldwell was co-chair of the firm's Corporate Investigations and White Collar Practice Group.

Paola Cecchi-Dimeglio's areas of inquiry and expertise focus on Leadership, Gender & Diversity, ADR, and Organizational Behavior. Since joining the faculty at Harvard Law, she has continued to advance the dialogue on diversifying the next generation of lawyers. She has been engaged in the teaching, training and consulting of private and public sector leaders in the United States, Australia, Europe, Asia and the Middle East. She reaches practitioners through print and digital media such as Bloomberg, The American Lawyer, Thomson Reuters, Law Practice Today, ABA and IBA publications.

She started her career as a litigation associate at Heller Ehrman in Silicon Valley then moved to Austin, Texas where she was a patent litigator at Wilson Sonsini Goodrich & Rosati before joining Dell.

Kathi Cover is Vice President – Intellectual Property, and Assistant General Counsel for DTS, Inc., (formerly iBiquity Digital Corporation). DTS is dedicated to making the world sound better, through its pioneering audio solutions for mobile devices, home theater systems, cinema and beyond. In 2015, DTS acquired iBiquity, the developer of HD Radio™ technology for digital AM and FM radio. Ms. Cover has been instrumental in building the HD Radio intellectual property portfolio over the past ten years and contributing to the successful licensing strategy of the business. In her role as Vice President of Intellectual Property for iBiquity and now DTS, Ms. Cover is responsible for all aspects of intellectual property, including protection, strategy, counseling and litigation. She has also worked on privacy issues and export controls.



MARY CRANSTON | BOARD DIRECTOR OF VISA, INC., THE CHEMOURS COMPANY, AND CSAA

Mary B. Cranston is a Retired Senior Partner of Pillsbury Winthrop Shaw Pittman LLP, an international law firm. She was the Chair and Chief Executive Officer of Pillsbury from January 1999 until April 2006, and continued to serve as Chair of the firm until December 2006. Ms. Cranston serves as a director of Visa Inc. (where she is Chair of the Audit Committee), of the Chemours Company, and of CSAA Insurance (where she is Chair of the Nominations and Compensation Committee), MyoKardia, Inc. (where she is Chair of the Audit Committee), and the Aretex Group (where she is Chair of the Risk Committee). She is also Chair of the Board of the Stanford Children's Hospital and Children's Health Network. Ms. Cranston has substantial expertise in complex antitrust, class action, and securities law; and she has been recognized by the National Law Journal as one of the 100 most influential lawyers in America.

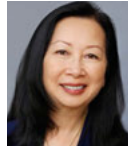


**HON. BARBARA LYNN | CHIEF JUDGE, U.S. DISTRICT COURT FOR THE

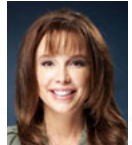
**HON. KIMBERLY MOORE | CIRCUIT JUDGE, U.S. COURT OF APPEALS FOR

AND SENIOR COUNSEL, SAMSUNG ELECTRONICS**

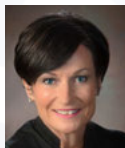

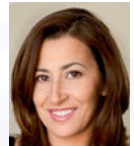

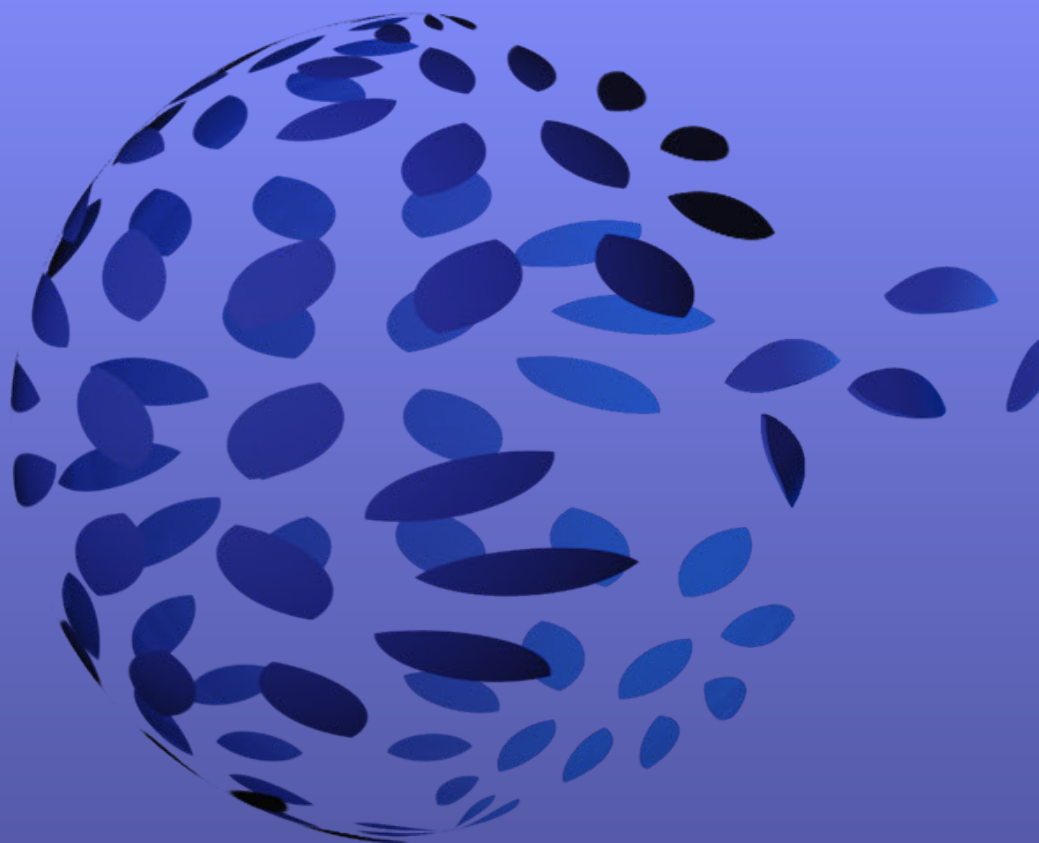
