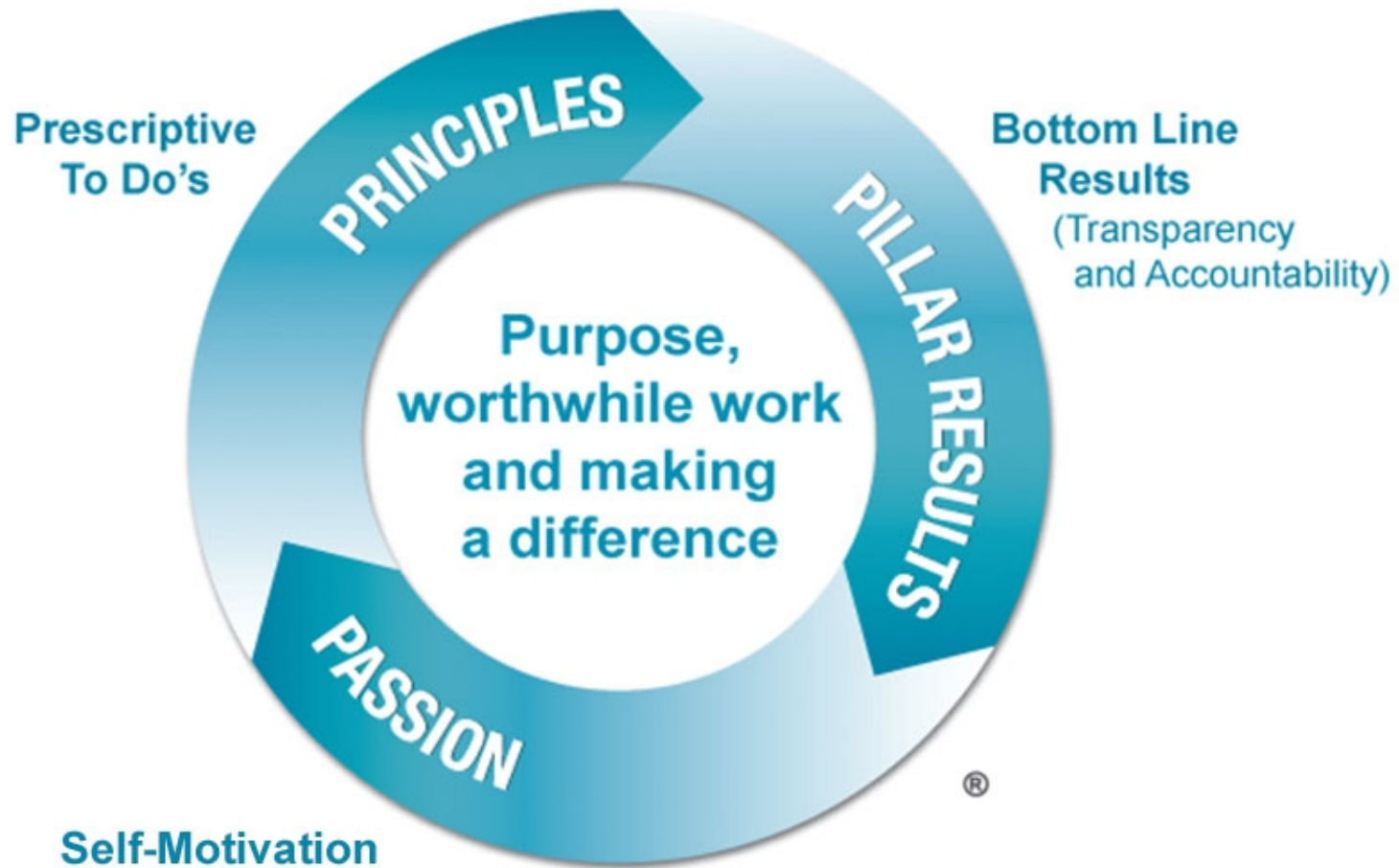

  - Why is the impact important? Outcomes?
  - Is it a one-time impact or recurring impact?
  - How sustainable is the organization?

  - Quality
  - Diversity
  - Financial support
  - Measurement

- Financial integrity
- Mission, vision, values
- Measurement

# Strength of proposal

- Well aligned scope (less ambiguity = greater results)
- Reasonable budget
- Cost and return-on-investment calculations
- Demonstrated need

# Impact of receiving grant

- What need will be met?
  - Number of people impacted
  - Degree of impact
  - Long-term impact
- What will happen if grant request is not funded?

## **Questions to Address if your Proposal includes Construction**

1. What type of construction is this project?
  - a. New Construction
  - b. Adding on to an existing building
  - c. Renovation of an existing building
  - d. Demolishing of an existing structure
  - e. Erecting fabricated structure
  - f. Mobile home set-up
  - g. Other structural changes, such as replacing stairs, handrails, repairs to pools, decks, etc.
2. Is the builder licensed in the counties/cities where work is to be performed?
3. Is there a site plan?

## **Questions to Address if your Proposal includes Construction**

4. Do the architectural plans and specifications meet county/city requirements for permitting? Example: Engineered truss layout, wind loads, etc.
5. Does the builder have the proper amount of Worker's Compensation and Liability Insurance to cover this project?
6. What is the time line for the project and completion date?
7. Will a schedule of payments be set up and who will be responsible for disbursements?
8. Is there a complete breakdown of all costs?
9. Please attach the following documentation:
  - Builder's county and/or city license
  - Certificate of Insurance
  - Site plan
  - Cost breakdown

## Organization Eligibility

- **Tax-exempt public charity under Section 501(c) (3) of the Internal Revenue Code**
- **Based in Escambia and/or Santa Rosa counties, or a recognized local chapter of a state or national charity serving this region**
- **Registered with the Florida Division of Corporations as a nonprofit corporation**
- **Annual filing with Florida Department of Agriculture and Consumer Services**

## **Project Eligibility**

- **Serve residents of, and expend funds fully in Escambia and/or Santa Rosa counties**
- **Be a new program, expansion of an existing program, or a new or expanded collaborative effort of several nonprofit organizations**
- **Have a project budget for the full IMPACT 100 grant amount of \$108,200 for 2016**
- **Expend funds by 30 Sept 2018**

In early May you will be notified by email letting you know if your LOI is complete – you may then begin completing your application at any time (before June 24).
