This report was prepared by the Genesee/Finger Lakes Regional Planning Council for the Genesee Transportation Council under the Unified Planning Work Program (Task # 4220).

Mission Statement

The Genesee/Finger Lakes Regional Planning Council (G/FLRPC) will identify, define, and inform its member counties of issues and opportunities critical to the physical, economic, and social health of the region. G/FLRPC provides forums for discussion, debate, and consensus building, and develops and implements a focused action plan with clearly defined outcomes, which include programs, personnel, and funding.

Abstract

This report provides information on the issuance of building permits in 2018 to identify areas of growth within the Genesee-Finger Lakes Region (G-FL Region) that might require transportation planning and service modifications. The G-FL Region is comprised of Genesee, Livingston, Monroe, Ontario, Orleans, Seneca, Wayne, Wyoming, and Yates Counties. The report analyzes the number of permits issued, total square footage, and total value for buildings for each municipality within the region as well as within the Metropolitan Planning Area (MPA). The MPA is comprised of Monroe County plus the adjacent developed areas of Livingston, Ontario, and Wayne counties. The analysis looks at the following categories and respective subcategories: "residential" (single-family, two-family, three or four-family, five-or-more family, mobile/manufactured homes); "industrial;" "commercial" (offices/banks, retail/service, service stations, hotels/motels); "community service" (hospitals/health facilities, schools/churches, public works/safety, utilities); and "not elsewhere classified."

Introduction

The Genesee Transportation Council (GTC) provides annual funding for the *Regional Land Use Monitoring Report* (LUMR) under its Unified Planning Work Program. The purpose of this report is to provide information for building permits by type, size, and value to identify areas of growth within the Genesee-Finger Lakes (G-FL) Region that may, as a result, require increased transportation planning and services.

The Regional Land Use Monitoring Report includes residential, industrial, commercial, and community service building permit data for all nine counties in the G-FL Region. This includes subdivision applications and permitted demolitions. The categories (and associated subcategories) for building permit data are as follows:

- Residential (single-family, two-family, three-or-four-family, five-or-more-family, and mobile/manufactured homes)
- Industrial
- Commercial (offices/banks, retail/service/restaurants, service stations, hotels/motels)
- Community Service (hospitals/medical facilities, schools, government buildings)
- Not Elsewhere Classified
- Subdivision Applications (containing 4 or more lots)
- Demolitions by permit (for Residential, Industrial, Commercial, and Other structures)

A five-year trend analysis is provided for permitted residential units in all nine counties and industrial, commercial and community service building permits are analyzed over the five-year period. This time-series analysis is based on this year's and the four previous years' Land Use Monitoring Re-

ports produced by the Genesee/Finger Lakes Regional Planning Council (G/FLRPC).

In addition, a time series (historical trend) analysis is provided for residential, industrial, and commercial development and subdivision approvals in the MPA.

The MPA consists of Monroe County plus the adjacent developed areas of Livingston, Ontario, and Wayne counties. Table 1 represents the municipalities that, along with Monroe County, comprise the MPA.

An analysis of the collected data on the number, value, and size of buildings permitted in 2018 is provided for each county as well as the MPA.

The data on permitted building activity are provided in appendices at the end of this report for the reader to use for their own needs and analysis.

<u>Methodology</u>

The building permit data included in this report was collected through surveys sent to the municipal or county officials responsible for the collection and dissemination of such data in the nine counties. In six counties, these officials were often the code or zoning enforcement officers and in some cases were the municipal clerks. In Seneca and Wyoming Counties, building permit application approval and inspection are the responsibility of the respective county building departments and thus these departments provided the relevant data. In Monroe County, the Planning and Development Department's Division of Planning administered the surveys, received the responses from municipal officials in the County, and forwarded the data to G/FLRPC.

As noted above, each municipality other than Seneca and Wyoming Counties received a survey in January of 2019 asking for the requested data. The initial survey was followed up with reminder e-mails and telephone calls to those municipalities that had yet to respond. In some cases, several calls or e-mails were made to the appropriate parties over many months in an effort to acquire the requested information. Overall, 97.87% of the data was collected from 184 of the 188 municipalities within the nine-county G-FL Region.

The survey requested information on the number of permits issued, and the total square footage and total value for buildings in the defined categories and associated subcategories. In addition, the same building permit information for buildings outside of these categories was requested along with a description of the type of building(s) in the

"Other" category. In some cases descriptions were not provided, or items not applicable to the survey were reported. As such, some of the "Not Elsewhere Classified" category data is not completely accurate. The analysis conducted in this report is based on data provided by each LUMR survey contact.

The instructions for completing the survey were as follows:

"Include only permits for the construction of buildings in 2018. Do not include additions, repairs, decks, in-ground pools, etc. or buildings used for storage such as sheds and pole barns. Do not include permits for construction that was completed in 2018 but permitted in a previous calendar year. If the responses below include a town and a village on the same sheet, please denote this by listing them separately on the same line (example: T - 8/V - 12)."

For each of the nine counties, there is a discussion of permitted building activity in 2018 by county and county maps of residential units permitted in 2018 by municipality. Maps 10 – 18 represent each County's residential permits. Map 19 represents permits for residential units for the nine-county G-FL Region. Map 20 represents permitted residential units in the nine-county G-FL Region. Map 21 represents the 5-year residential permitted units in the nine-county G-FL Region. Data of industrial, commercial, and community service building permits issued in 2018 are presented on maps of the nine-county G-FL Region. See Maps 22-24.

The information and data provided for permitted building activity in Monroe County and the remaining portion of the MPA follows the same format. Maps 25 and 26 present the number of residential permits, and permitted residential units respectively in the MPA region in 2018. Maps 27 through 29

present the number of permitted industrial, commercial, and community service buildings in the MPA in 2018. Map 30 shows the distribution of residential building permits among the Transportation Analysis Zones (TAZ) within the MPA outside of Monroe County.

The residential data for MPA municipalities were used in a time series analysis of the number of residential units permitted by municipality for the years 2009 through 2018. The number of permits issued for industrial and commercial buildings from 2009 to 2018 in the MPA outside of Monroe County is also presented and discussed in the same manner.

The data gathered on number of building permits issued, square footage, and value in each category/subcategory by municipality in, and for the MPA, outside Monroe County are presented in Appendices A through H. The Appendices are as follows:

County Building Permit Analysis (2018)

2018 County Building Permit Analysis

Genesee County

Residential Permits:

- Forty five (45) <u>residential building permits</u> representing 107 units were reported in Genesee County in 2018. The largest number of permits, at 16, was reported in the Town of Batavia. The largest number of units, conversely, was 61 units in the Village of Le Roy. The Town of Darien reported the second most permits with five.
- Forty one (41) permits were for single family or mobile/manufactured housing while four permits were for multi-family buildings representing 66 units.
- Map 10 shows the number of residential unit permits in Genesee County in 2018.

Industrial Permits:

- Five (5) industrial building permits were reported in 2018. Four of the permits were equally in Batavia City and the Town of Bergen
- Map 22 shows the number of industrial building permits by municipality in the G-FL Region in 2018.

Commercial Permits:

- There was one <u>commercial buildings permit</u> reported under the sub-category of Retail in 2018, in the Town of Batavia
- Map 23 shows the number of commercial building permits by municipality in the G-FL Region in 2018.

Community Service Permits:

- One (1) <u>community service building permit</u> was reported under the subcategory of medical facility in 2018, in the Village of Le Roy.
- Map 24 shows the number of community service building permits by municipality in the G-FL Region in 2018.

Not Elsewhere Classified Permits:

Ninety-nine (99) permits were reported that would be included as <u>not elsewhere classified</u> for Genesee County municipalities in 2018. A fire department pole barn and various accessory buildings were permitted in 2018. Some of these were permits for additions and repairs that are not included on this survey. The Town of Darien reported a total of 52 "other" permits with remodel permits mixed in. The Town of Bergen reported 38 not specified permits.

Subdivision Applications:

• There were no subdivision applications in 2018.

Demolition Permits:

•Thirty (30) residential demolition permits, two industrial demolition permits, three commercial demolition permits, and 10 other demolition permits for a total of 45 permitted demolitions were reported in Genesee County in 2018. The Village of Le Roy reported seven residential demolition permits.

Livingston County

Residential Permits:

- Fifty-five (55) Residential building permits representing 99 units were reported in Livingston County in 2018. The Town of Livonia had the largest number of permits at 16 and the Town of Caledonia was second with six. The largest number of units reported was in the Village of Livonia (49) and Town of Livonia (16) respectively.
- Fifty one (51) permits were for single family or mobile/manufactured housing while four permits were for multi-family units representing 48 units.
- Map 11 shows the number of residential units permits in Livingston County in 2018.

Industrial Permits:

- There were five <u>industrial building permits</u> reported in 2018. Two (2) permits were in the Town of Livonia
- Map 22 shows the number of industrial building permits by municipality in the G-FL Region in 2018.

Commercial Permits:

- Four (4) <u>commercial building permits</u> were reported in Livingston County in 2018. One retail permit was located in each of the Towns of Avon, Lima, Livonia, and the Village of Dansville
- Map 23 shows the number of commercial building permits by municipality in the G-FL Region in 2018.

Community Service Permits:

- There were no <u>community service building permits</u> reported in 2018.
- Map 24 shows the number of community service building permits by municipality in the G-FL Region in 2018.

Not Elsewhere Classified Permits:

•Nineteen (19) permits that did not correspond to the above-described categories were issued and included as not elsewhere classified. These permits included accessory structures and other unspecified buildings. Fifteen (15) such permits were reported in the Town of Nunda.

Subdivision Applications:

• There were no subdivision applications in 2018

Demolition Permits:

• Twenty (20) residential demolition permits, two commercial demolition permits, and 13 "other" demolition permits were reported in Livingston County in 2018. The Town of Livonia issued 10 residential demolition permits.

Monroe County

Residential Permits:

- Municipalities in Monroe County reported 698 <u>residential</u> <u>building permits</u> for a total of 1,731 <u>residential units</u> in 2018. The largest number of permits reported was in the Town of Webster (120) and the Towns of Penfield and Henrietta with 97 each. The Towns of Greece and Parma reported the next largest number of residential permits with 80 and 47, respectively.

Metropolitan Planning Area (MPA) Analysis

The MPA is comprised of 56 municipalities with two additional villages bisected by the MPA boundaries, the Village of Clifton Springs and the Village of Rushville in Ontario County.

Residential:

- Within the MPA, the municipalities with the highest number of residential permits in 2018 are the Town of Webster in Monroe County with 120 permits followed by the Town of Henrietta and the Town of Penfield, both of Monroe County with 97 residential permits each and the Town of Farmington in Ontario County with 88 residential permits.
- The number of residential units permitted in 2018 in the MPA show 437 units in the City of Rochester in Monroe county with the next highest found in the Town of Henrietta, Monroe County with 259 units, the Town of Webster, Monroe County with 245 units and the Town of Farmington, Ontario county with 235 units.
- The top municipality in Wayne County was the Town of Ontario with 45 residential permits representing 61 units in 2018.
- The top municipality in Livingston County was the Town of Caledonia with 6 residential permits for six units in 2018

Single Family Residential:

• The top three municipalities with single family/mobile/manufactured home permits in 2018 were the

Town of Webster (115), the Town of Penfield (96), and the Town of Henrietta (89) in Monroe County.

The top three municipalities with single family/mobile/manufactured home permits outside of Monroe County in 2018 were the Town of Farmington (67), the Town of Victor (50), Ontario County and the Town of Ontario (43) Wayne County.

Multi-Family Residential:

- The top three municipalities permitting multi-family residential units in 2018 are the Town of Farmington, Ontario County, with 21 permits representing 168 units. The Town of Ogden, Monroe County, issued 12 permits for 84 units and the Town of Sweden, Monroe County, issued 10 permits for 40 units.
- The top three municipalities' permitted units for multifamily residential in 2018 are the City of Rochester, Monroe County, with 416 units, the Town of Henrietta, Monroe County, with 170 units, and the Town of Farmington with 168 units.

Subdivisions:



Addresses were then geo-coded using Geographic Information System software to determine which Transportation Analysis Zone (TAZ) each permit was located in. Some addresses did not geocode accurately and were manually moved to the approximate location based on a review of aerial imagery. As the transportation analysis zones tend to follow road boundaries this should not impact the accuracy of the number of permits per transportation analysis zone.


Map 30: Number of Residential Unit Permits in MPA Transportation Analysis Zones outside of Monroe County (2018)


