Our mission at St. Timothy is "Follow Jesus. Make a Difference." Jesus is the heart of everything we do! HE defines our identity, our calling, and purpose. For the first time in our lifetime, we experienced a world-wide pandemic that literally shut our nation and churches down for months. It stopped our Generations Campaign only two weeks from completion. We learned new terms like social

distancing, PPE, face masks, and even now with our people meeting together, things are very different, and it may continue like this for some time.

Nonetheless, the **season we are in, does not change the mission we are on!** We still care deeply about reaching the five different generations in our church and community. We are still devoted to the Great Commission and to the ministry of prayer, as we Follow Jesus and seek to Make a Difference for His Kingdom.

The previous Annual Reports presented numbers and statistics for Worship, Bible Classes, Sunday School, mid-week events, mission trips, and community outreach events we led or participated in. Instead, we want you to see with us, how God's faithfulness has been beautifully demonstrated through all the challenges and changes this year.

This report is an overview of our vision that challenges us to go Higher, Deeper, and Wider and will show how we have adapted to the unique challenges encountered this year. We

continue to find strength from Paul's prayer in Eph 3: 17-18 "I pray that you, being rooted and established in love, may have power, together with all the saints, to grasp how wide and long and high and deep is the love of Christ, and to know this love that surpasses knowledge, that you may be filled to the measure of all the fullness of God."



Our leaders and staff have worked hard to carry out the mission and vision with a pivot towards reaching generations who interact in the digital world through social media. Bright Beginners continues to be our signature ministry, and even though they were hit hard financially with less students because of COVID, the Board of Directors took quick action to receive a Payroll Protection Program (PPP) loan that kept the school operating through the most difficult times. With Kim Jurischk's excellent leadership and devoted staff, we endured the worst and are growing again, and the entire PPP loan has been completely forgiven.

We developed a Strategic Plan that will show St. Timothy's goals and plans to carry out our Mission and Vision for the next two years. It includes a partnership Manantiales de Vida for outreach to the growing Hispanic community in this area.

Even in the shutdown, your prayerful support and faithful giving allowed us to still fund all the missions and ministries we support. We used funds from Capital Reserve to make needed improvements to the campus, including parking lot and other needed repairs and updates around the campus.

As Senior Pastor, it is my great privilege to work with a devoted staff, gifted leaders on both the Board of Directors and Elders, and a dynamic prayer team that is growing with men and women in prayer. I get to see Jesus take us higher in Worship, deeper in His word and wider in reaching many generations. God is so very faithful!

Although 2020 was very different, many steps were taken during the year to move us forward despite the shutdown. I worked with the staff to begin online worship as well as broadening our social media presence. This crucial step allows our members to continue to worship even if they cannot be on campus because of corona virus.

Our staff continues to carry out ministry regardless of the pandemic. This required us to rethink how ministry was done while still caring for people and reaching our community. We were still able to assist our adopted school, Hancock Elementary, host outreach events, and increased our partnership with Manantiales De Vida.

Once we were able to return to on-campus worship, our staff developed and implemented guidelines for a safe return to worship after quarantine including social distancing measures, mask policies, cleaning procedures, and more.

I worked with Pastor Steve and the staff to develop a two-year Strategic Plan for the congregation. The plan includes engaging members in worship and Bible study, equipping them to minister in their settings, reaching out to the community, incorporating Manantiales De Vida into the life of our congregation, as well as facilitating future growth in our congregation and developing a transition plan for Pastor Steve's retirement in 2 years. I worked with each staff member to develop the individual plan for their ministry that would fit into and help the church accomplish the goals set in the overall strategic plan.

Pastor Steve and I continue to provide pastoral care to the members of our congregation even with restrictions on hospital visitations. We continue to proclaim the Gospel through worship and Bible class. The transition to live-stream has been a huge blessing to the online growth of our church.



Our staff and the leadership of St. Timothy adapted to overcome some very difficult times over the past year. Things did not go as we had planned in 2020, but God is faithful. He equipped and strengthened us to continue to carry out the mission of St. Timothy to Follow Jesus and Make a Difference.

#### Children's Ministry – Caroline Gray

Children's Ministry has continued, in very creative ways, to engage children and families going Higher, Deeper, and Wider to Follow Jesus and Make a Difference even in the year 2020. We held Christmas in



May where families were able to drive through, say "hi" and receive a bag full of "goodies" to help occupy them during stay-home orders. In June, we hosted our first ever Virtual Vacation Bible School. Families received craft supplies and music CDs in advance and watched the crazy antics of Ms. Caroline and Prospector Bart online. We created at-home content for families to download and follow along with the summer Sermon Series to inspire faith-talk at home. In addition to doing a children's message on Sunday mornings, we began showcasing KidZone@Home for kids and families to watch the Sunday School lessons weekly via YouTube. The entire congregation joined together to host an incredible Drive Thru Trick or Treat Festival for our community! We will finish out the year with three awesome Family Advent Services. We look forward to how God is going to move in 2021!

#### Student Ministry – Dan Parker

So much of Student Ministry is done in person, but despite the difficulty of not being able to go on summer mission trips, retreats and other in person events, we still found ways to interact with teens to help them grow in their faith this year. Zoom played a critical role in connecting and communicating with students throughout the pandemic. We had regular Zoom meetings through the summer with Bible studies, game nights and a time of prayer with both Jr and Sr High students. Confirmation continued through Zoom meetings as well. Our confirmation service was delayed until August but we had five students confirm their faith in front of their families. We also celebrated the graduation of ten high school seniors. Starting in July we were able to gather in person for socially distanced Fuel events with high school students. In the new season of Confirmation and Sunday school we continue to offer both in person study and online options. This year has taught us a lot about growing community and we look forward to being able to go out and be the hands and feet of Jesus in our community and world in 2021.

#### Scouting Program (Children's and Student Ministry)



St. Timothy's Boy Scout Troop 626's 2020 roster includes 62 registered Scouts, as well as 41 adults in various volunteer positions. Activities have been very limited since March, but they resumed virtual meetings over Zoom during the summer, and were excited to begin limited in-person activities back on the St. Timothy campus in October - including a skills workshop for first year scouts, a campout on the St. Timothy grounds, and a Webelos open house for recruiting new members.

A major highlight from 2020 was partnering with St. Timothy and Dan Parker leading "God and Life" virtual training class which is part of the BSA Religious Awards program.

Even through the challenges of the pandemic, Troop 626 has produced nine new Eagle Scouts since November 2019, and currently has five more Scouts very likely to be awarded their Eagle Rank before the end of 2020.

The troop is really looking forward to being able to get back outside and active as a group again, and are currently working on plans for summer camp, as well as planning the everpopular wilderness survival campout typically held in the early springtime.

#### Discipleship – Elizabeth Leitko



Missions got very creative this year in the ways that we serve. Instead of sending our members overseas we were able to be the nands and feet of Jesus locally in Houston. We have hosted two

amazing food drives one in June for Centro De Fe Esperanza and one in November with Manantiales De Vida. Through the November food drive, we were able to bless over 100 families in our own community with a complete Thanksgiving Meal. The congregation also responded to the call and we were able to financially bless people, in our congregation and in Manantiales De Vida, who were struggling during the height of the pandemic. The ladies of the congregation made masks for Hancock Elementary students and staff. We sent a 12person team to Louisiana to help with hurricane relief. Our School Supply Drive was an incredible success, donating enough backpacks filled with supplies for over 40 children and teens through Manantiales de Vida. The remainder of the supplies went to Hancock to bless their students and staff. Through another partnership with Pastor Rodrigo and Dayana Fernandez, we helped fill an entire shipping container with supplies, mattresses, and furniture, that went to a congregation in Honduras for families who were barraged with two hurricanes this fall. We were able to Follow Jesus and Make a Difference in new and exciting ways. I look forward to seeing how we can go wider in 2021.



In Adult Bible Study we made a pivot in the Spring to an online Walk Bible Symbol format on Sunday mornings and Wednesday nights. This allowed many people to dig into God's Word all while being apart. We

welcomed two new member classes with eight families which met via Zoom during the height of the pandemic. Since reopening this Summer we started an additional mid-week Bible study in addition to the two others hosted on our campus. Another way we helped members go deeper in 2020 was adding a Greif Support group in partnership with a local counselor that has met monthly in person and via Zoom. I am looking forward to what 2021 will bring and the ways we will be able to go Deeper in our study and grow closer to God as a result of that.

#### A/V and Technology – Patrick Blake

The year 2020, while challenging, has also been a year of exciting blessings in the area of Audio and Video ministry. This year we were able to upgrade and take our online worship experience to the "next level." We



installed new infrastructure and gear in the Life Center as well as in the Sanctuary, and are able to reach not only our congregants in a time of need, but also others across the world with the saving message of Jesus Christ. What a blessing! We also kicked off video series like the weekly Take-Away by Pastor Steve, and Kid-Zone at Home with Ms. Caroline. We have immensely expanded our digital presence on Facebook, YouTube, and our website these past nine months. Vacation Bible School took on a completely digital format this year. I have stepped alongside Manantiales de Vida to help train their volunteers and facilitate their digital worship experience as well. All this video content and creation just further speaks into how God is using St. Timothy and our digital footprint to Follow Jesus and Make a Difference not only in Houston, TX but across our nation and world.

#### **Music Ministry**

Craig Harmann will finish his six-year tenure as Minister of Music at the end of December. He is now teaching music full time at Northland Christian School and we thank God for his years of service here at St. Timothy.

Covid has made singing with choirs and cantatas very challenging yet excellent music of all forms is needed as we move forward. Pastor Steve has recruited a team to evaluate all the needs to help our Music Ministry continue to be a dynamic and worshipful part of both traditional and contemporary worship and our ministry to children.



#### Manantiales de Vida – Pastor Rodrigo and Dayana Fernandez

The year 2020 is a special year; a year that many people want to forget.

Nevertheless, for MDV, it was months of learning, where we have seen

God work like never before. He has shown us that His plans and thoughts are much greater and His ways are different than ours. This year "Stay at

home" was a slogan for many; and the pandemic brought social distancing into our lives.

For us, these restrictions brought us closer to many families. It granted us the possibility to reach people through daily prayer online and opened up ministry area to many different Spanish speaking nations. Prayer is powerful and we have seen the Holy Spirit work miracles through this daily online forum.

The truth is God switched our plans with His! His agenda for us has been different but we have let ourselves be used and He has manifested Himself with power.

We are very grateful for the partnership we've established with St. Timothy, working with the Hispanic community. In 2007's Toys for Joy, we gave out 25 gifts for the Hispanic children. In 2020, we have a list of 280 children who will be receiving a gift and 60 families who are on a waitlist. Thanks to the generosity, care, and love of every member of St. Timothy, we were able to reach 100 families for the Thanksgiving holiday, providing them with a Thanksgiving dinner. Recently, we worked with the community and St. Timothy to help our brothers in Honduras who lost everything due to a natural disaster. The shipping container was sent off completely full of basic necessities.

We thank God, once again, for the opportunities that the Lord gives us to demonstrate our faith in action. St. Timothy and Pastors, we thank you so much for always showing us Jesus through you.

#### Bright Beginners - Kim Jurischk

Bright Beginners continues to carry out our mission of connecting families within our preschool to create a community that not only provides a quality early childhood program but also builds a bridge



for them to the Body of Christ. During the pandemic shut down we still made it a priority to stay connected with our preschool families. The teachers did a fantastic job and offered weekly Zoom classes, videos of themselves either reading stories or doing an activity and lesson plans with ideas for the kids to do at home each week. We also created Easter goodies, with the Easter story, a craft and eggs for each student and dropped it off at their house. The staff all wrote personal notes to the children in the class; each child received a letter from their morning and afternoon teacher. We videotaped our chapel time on Wednesday and posted it on Facebook and provided our Spanish and Music classes through an online format. I am very proud of our staff for stepping outside of their comfort zone to meet the needs of our families and continue to create a community within our school.

COVID has greatly affected how we have to do things and has brought many challenges to our day-to-day operations, but our staff has done a remarkable job stepping up to the plate. Even though we had to make many adaptions we continue to offer the same quality program we had before. We are still able to offer Spanish, Music, Chapel on Wednesday, and the same enriching curriculum in the classrooms. I have been able to offer tours after hours since parents are not allowed in the building during school hours and continue to enroll new families. No matter what has happened we have and will continue to love, educate, and share the Good News of Jesus with each child and family that comes into our school.

### PROPOSED LAND SALE

The Lanier Foundation has offered to purchase the 3.23 acres on the south side of our campus for \$600,000. The Foundation will build a new entrance and parking lot for 120 vehicles along with required detention for the project with an estimated value of \$500,000. The sale and infrastructure will give us a net benefit of 1.1 million dollars

St. Timothy would have "use in perpetuity" of the parking lot and will design the parking in collaboration with The Lanier Foundation. All agreements will be incorporated into the sales contract for the property.

All three architectural master plans we had designed in 2019 recommended using this same area for parking.

The land has an estimated market value of \$611,582.

The Board of Directors will present a motion to sell the land to The Lanier Foundation at the Annual Voters' Assembly on December 13th.
