MHMC talks development, daffodils

The Mount Hope Mount Canterbury Neighborhood Association (MHMC) met last week on Thursday, Oct. 11 and discussed several issues facing the neighborhood.

First, Stella Road resident Amy Devito said the neighborhood has been chosen to participate in Boston Blooms, the yearly daffodil planting beautification project the city runs every year.

“We were selected and on that day, Oct. 27, we’re going to plant them,” she said. “I’m picking them up on Oct. 25.... If you’re interested, we’re thinking since we usually do the cleanups in the late morning and get a good turnout, we thought 9ish would be a good time to start.”

Boston said they have about 300 bulbs to plant on local public greenspace throughout the American Legion corridor.

“Our idea was to plant along the cemetery roads, as they can’t be where trees are,” she said. “They need a good deal of light and we probably don’t want to do it in the middle of American Legion for safety reasons, so if anyone has any ideas for open space areas let me know.”

Editorial

SCHOOL DAZE

You are forgiven if the City's plan for school infrastructure is overly confusing and, perhaps, may even strike you as contradictory.

In recent days, there have been multiple reports of both school closings and grand opening plans. The Boston Globe summed it up this way: "Boston plans to build or renovate a dozen schools." Over at Universal Hub, a different take: "BPS plans to shut West Roxbury high schools; more schools could follow."

So which is it? Well, in the grand tradition of Boston's cluelessness when it comes to its school system, the current, evolving plan calls for both shuttering and opening schools.

Yes, there are closures in the works. Urban Science Academy and West Roxbury Academy will close in June, because of what interim Superintendent Laura Perille described as their deteriorating conditions. The McCormack Middle School in Dorchester is also on the potential chopping block.

What the City takes away, it also gives. Mayor Walsh has announced plans to spend as much as \$1 billion to rebuild and reconfigure 125 schools. An early recipient of that funding: the brand new Boston Arts Academy in the Fenway.

We do not dispute that tough decisions are par for the course when managing a school system as large as the one Boston grapples with. We do, however, have questions.

What will happen to the 750 students, many of them with special needs, who will be displaced from their schools in West Roxbury?

Are some students, under this new plan, rewarded with stability while others face uncertainty and being pushed into classrooms throughout the system?

Why is the city, according to its current strategy, so focused on closing middle schools?

Is either extending lower-grade schools to eighth grade, or starting secondary schools as early as seventh grade, a smart move that is in the best interests of students?

How will teachers be reassigned?

What effects will all this have on exam schools (if any)?

To what degree is deferred spending in maintenance responsible for the poor condition of many schools?

In the coming weeks, expect plenty of discussion on this evolving school plan, both favorable and irate. When it comes to local education, there is no way to please everybody. Many mayors and school superintendents have learned that the hard way over the years. What we do hope is that our elected officials craft and pitch a defensible plan, one that makes sense both fiscally and educationally.

How we're creating more affordable housing

Boston is going through a period of historic growth—the kind our city hasn't seen in decades. More people are choosing to put down roots and start families here. More businesses are choosing to open their doors here. Students from all over the world come to attend our universities and colleges each year. As Boston grows, we must keep our focus on the families and communities that make our city the diverse, welcoming and world-class place it is. To do that, residents must be able to afford to live here in the city they love, families must be able to grow, and young people must be able to make our city their home.

To achieve that, we're working hard to increase Boston's affordable housing stock — that includes building housing across a range of incomes, and focusing on ensuring there are income-restricted homes being built throughout Boston.

Just last month, we increased our overall housing goals from creating 53,000 units to 69,000 units by 2030 to meet Boston's growing population and increase the number of housing opportunities available to residents. These new housing goals, which were first set in 2014 through our housing plan, build on our commitment to

increasing access to home ownership, preventing displacement and promoting fair and equitable housing access.

As we build more housing in Boston to relieve housing pressure, our regional partners are also working to ensure their cities and towns keep up with the demand for affordable housing. Boston can't do this alone — and that's why I'm proud earlier this month, I joined leaders from 14 surrounding communities who are part of the Metro Mayors Coalition to announce a new regional housing production goal for coalition cities and towns to meet the demands of a robust regional economy and a growing population in Boston and surrounding areas. Together, the 15 members of

the Metro Mayors Coalition announced a target to create 185,000 new units of housing across the region by the year 2030.

We are at a pivotal time in Greater Boston as our economy continues to grow and thrive, and more people move to our communities. I know housing is the number one concern for so many families in Boston, and addressing it is my top priority. Of the 69,000 new units that will be created by 2030, 15,820 of them will be income restricted. By 2030, the total number of income-restricted housing units in Boston will be nearly 70,000. We are also committed to acquiring 1,000 market-rate rental units from the housing market and making them income restricted units.

If you think finding affordable housing, or becoming a homeowner, isn't a reality for you — explore the resources the City of Boston offers. Take a home buying class. Apply for an affordable home buying opportunity. Apply for an income-restricted apartment. All our resources are available at <https://www.boston.gov/departments/neighborhood-development>, and we'll continue to work hard to make sure all families who want to live in Boston are able to.

the Roslindale Substation. They held the event there this year and at the current site of the Distracted Brewery on Birch Street last year. The idea is to give kids the tools to create their own Rube Goldberg machines out of cardboard and plastic. And then watch what happens.

RWP co-founder Chris Kollett said the idea was to allow kids to set up their own “experiments” and gain insight into the physics of the world they live in and how to manipulate them. He said he’s glad they were able to utilize the space again

and, though the Substation will hopefully have a permanent tenant sometime soon, RWP will still try to hold the event at different locales in the future.

“We don’t have any long-term plan, and if this space isn’t available we’ll take a look at what is available and if we find a space that makes sense we’ll try to figure something out,” he said. “Having this space is amazing, and when it stops being available we’ll find another space.”

About 100 children and parents were at the event with more going in and out as the day progressed. Kollett said he hopes the event continues in popularity.

“I like to think that people are aware of what this event is and who we are. Every time we run one we’re building on the success of the previous one,” he said. “We’re aiming to be a consistent presence in the community.”

The idea for the event came from resident Cora Carey almost two years ago, and RWP has continued to make it happen.

Residents Deborah Kronenberg and Sarah Ekholm-Jacobson said it was an amazing event. Both are friends, and Kronenberg said Ekholm-Jacobson first told her about it.

“My friend told me about it and it sounded really cool and I have kids; they needed to do something,” she said.

“It’s just wild,” said Ekholm-Jacobson. “The infrastructure; the kids are all engaged, it’s just

great. There’s no rules here and everyone just starts going and being kind to each other and it’s absolutely incredible for them to do whatever they want, and everything is pretty safe. I mean there’s risk, but there’s nothing that could actually hurt them.”

Residents David Sandak and Greg Loftus said

“This organization, RWP, does a good job of creating these types of events for kids and getting the word out, I follow them pretty closely,” Sandak said. “It’s fantastic, the kids have an opportunity to learn and grow and explore and learn on their own and do their thing.”

“I’ve never seen anything like this, except here,” Loftus said.

Peter Castellucci said he loves the independent learning aspect of the Build Zone Day in Roslindale, as it can help to give kids confidence in other activities by doing this on their own.

“My wife heard about it from a friend and we have been to one of these before,” he said. “It’s a great use of the space and it’s perfect, especially on a rainy day, and I think the last one was on a rainy day too. It’s amazing how you can actually hope for rainy weather. I’ve never seen anything exactly like this. It’s just a bunch of pieces the grownups have made and the kids can put it together and make these ball races and all sorts of stuff, it’s just really cool.”

Each of the 20 sites featured in the campaign played a role in the development of a diverse nation or the struggle for equal rights.

Partners in Preservation: Main Streets seeks to inspire long-term support from local citizens for sites on Main Street. Each local partner is receiving an initial grant of \$20,000 to increase public awareness of the importance of these historic places and build grassroots support for their Main Street district. The

public will decide which historic sites will receive a share of \$2 million in preservation funding by voting for their favorite main streets through October 26 at VoteYourMainStreet.org, hosted by media partner National Geographic. Winners will be announced on October 29.

Roslindale Village Main Street will host an Open House Weekend event on October 20th for the public, highlighting the importance of Main Street preservation efforts in Boston. Roslindale Village Main Street is one of twenty diverse and historic Main Street districts across the country participating in the Partners in Preservation: Main Streets Open House Weekend.

As part of Roslindale Village Main Street's Open House Weekend, residents and guests of Boston will not only learn about this important accessibility project, but attendees will also enjoy Roslindale Open Studios that same weekend (<https://roslindaleopenstudios.org/>). The Roslindale Congregational Church, UCC is one of the group sites and will showcase

10 artists, live music, and the RCC Café.

Open House Weekend activities in Roslindale Village Main Street are one of many local events taking place nationwide on October 20th and 21st.

group site,” she said. “The home studios are spread out and, especially if you’re playing our home studios bingo game for prizes, you could easily walk to a cluster of the home studios.”

She added that because of the new installation of Blue Bikes in the Roslindale Square, this allows participants to bike to each studio.

Appleman said it’s good for the artists too. Not only does it allow them to showcase their work without organizing a gallery or potentially lifting some of the heavier pieces, it also, at least for her, gives the opportunity to grow as an artist.

“It makes me feel really connected to this community in a deeper sense, and it also has helped build my artistic practice,” she said. “In so many ways I’ve grown with the event and become more rooted in Rosalind and, for me, as a home studio participant, it’s just a tradition for my family now to have friends family visitors and neighbors come. I have larger works, and that’s another benefit to home studios; we don’t have to carry around out large work. I make mixed media assemblage, found object sculpture that kind of thing. People who are obsessed with miniatures and the found objects come to see my work every year.”

Appleman works with a dedicated group of Roslindale artists every year to make the event go off without a hitch.

“We’ve been planning the event since March or April and we’re all getting really excited now that it’s this weekend. I can’t believe it, and I love meeting every month with a group of residents who are passionate about local art and supporting local artists,” she said. “It’s just really meaningful for me as a resident.”

Risa Edelstein, at 289 Poplar St., said she’s been welcoming residents to her home for years now and is also opening her studio to another local artist.

Open Studios each year because it is a great way for me to meet all kinds of people from my neighborhood and surrounding towns. Yoder pointed out that the new park at the intersection of Mount Hope and Hyde Park Avenue would be an ideal place to plant them.

“There’s a lot of sun there,” he said.

State Rep. Russell Holmes also came to the meeting to discuss legislation going through the statehouse for next year.

“We get about 8,000 proposals per year on laws we think we should change in the Commonwealth, and we generally would

get through passing about 400 to 500 of them,” he said.

Holmes said they have landed on increasing the minimum wage in the state, however not without some compromise.

“Nobody’s happy in this deal, but that’s how we go to this deal,” he said.

The minimum wage, currently set at \$11 an hour, would increase to \$12 in 2019 and increase by \$.75 increments every year until in 2023 it gets to \$15 an hour.

“To get that deal the retailers said, ‘if you want us to raise the minimum wage, don’t force us to pay time and a half to workers on Sundays,’” he said. Like I said, nobody’s happy with this deal.”

Holmes said the feeling was that since most stores are open on Sundays, it’s not a big ask to pay the regular wage on those days. He added that hours after 40 hours a week will still get time and a half. He said they also increased the minimum wage for tipped workers.

“For tipped workers, \$9 an hour was the goal and we had to negotiate to \$6.75, and you can still get tips, which is a large jump from where they are now,” he said, noting the minimum wage for tipped workers is \$3.75.

Holmes also said they have worked on a paid family leave proposal that would give any worker in 2021 the ability to take 12 weeks of paid family leave and 20 weeks of paid medical leave.

“But you can’t do more than half of both in one year,” he said.

Holmes said that to make this work, the state government will take an additional \$4 out of ev-

ery worker’s paycheck, to be matched by the employer, to pay the family leave.

“Even though the governor said he was never going to raise taxes, he signed the bill,” he said.

Office of Neighborhood Service Roslindale Representative Joe Coppinger also introduced himself to the neighborhood during the meeting and he said the number one thing he’s noticed in his three months in the neighborhood was development.

“We really do appreciate your input on these development projects,” he said. “We have a new project coming up, 650 Hyde Park Ave., and they’re looking to present in the coming months... They are looking to gut and renovate an existing six-family to an eight family for rental units. It’s not much of a difference of what’s there now, and I hope they get a chance to come and talk to you soon.”

Speaking of development, Yoder said that City Realty will be coming back to the group to present its plans for 920 American Legion Highway. Earlier, the group had proposed 59 units of rental units there after coming down from more than 100 last year. Residents were concerned then about parking on American Legion as well as the loss of the trees and greenery at the site. He said the Home for Little Wanderers at 780 American Legion is also looking to come back to the neighborhood soon with its development plans for more than 100 units of housing and supported housing for youth. The next MHMC meeting is scheduled for Nov. 8 at 6 p.m. at the Homes for Littler Wanderers

F. Washington Jarvis III died October 7, 2018, at CareDimensions Hospice Home in Lincoln, MA after a long illness. Tony was born to Frank Washington Jarvis and Prudence Crandall Jarvis in Pittsburgh, PA on June 24, 1939. After growing up outside of Cleveland, OH Tony attended St. Mark's School in Southborough, MA and graduated with honors from Harvard College. He received his M.A. from Cambridge University in England, and his S.T.B. from

the Episcopal Theological School in Cambridge, MA. He was awarded honorary doctorates by Bowdoin College (L.H.D., 1998), Middlebury College (D.Litt., 2004), and the Berkeley Divinity School at Yale (D.D., 2016). Tony was an Episcopal priest. From 1964 to 1971 he served as Curate at St. Paul's Church in Cleveland. He had special interest in and responsibility for the youth of this large parish, and the program he developed attracted young people from all over the city. In 1971 he was appointed Chairman of the History Department at University School in Cleveland, and the following year Assistant Director, Upper School. For thirty years, from 1974 to 2004, Tony was headmaster of The Roxbury Latin School in Boston. Founded in 1645, Roxbury Latin is the oldest school in continuous existence in North America. After retiring at age 65 from Roxbury Latin, Tony served twice as a chaplain and master at Eton College in England, and as scholar-in-residence at schools in Perth and Sydney, Australia. He spoke at numerous educational conferences and schools—and served as a guest preacher and speaker—across the US and abroad in Australia, Canada, New Zealand, South Africa, and the United Kingdom. He delivered the Pitt Lecture at Yale in October 2012. From 2008 to 2016, Tony taught at Yale University, where he was founder and Director of the Educational Leadership and Ministry Program at the Berkeley Divinity School. Tony was past President of the Headmasters Association of the United States and of the Country Day

School Headmasters Association, and he was the former Chairman of the Commission on Independent Schools of the New England Association of Schools and Colleges. He served a five-year term as member of the Massachusetts State Ethics Commission. He was a trustee of the Independent School Association of Massachusetts, Winsor School, the American Friends of Maru a Pula (Botswana), and Portsmouth Abbey School. Since 1976 and until the time of his death he was priest associate at the Parish of All Saints, Ashmont, an inner city parish in the Dorchester neighborhood of the City of Boston where he lived. Tony was the author of eight books and numerous articles in the fields of history, education, and religion. His book, With Love and Prayers, a collection of forty addresses to students, won the Christopher Award for adult non-fiction. He was a Member of the Most Venerable Order of the Hospital of St. John of Jerusalem, the Society of Mary, and the Society of King Charles the Martyr. Tony was predeceased by his sister, Faith Crandall Jarvis Smith, and is survived by his brother-in-law, Craig E. Smith of Hingham; his nephews Ned Smith and his wife, Kristin, of Houston, TX and Benjamin G. J. Smith and his wife, Stacey, of Acton; his niece Cricket Smith Segaloff and her husband, Brett, of Harvard; and his five great nieces and nephews: Catie, Annie, Timmy, Sarah, and Teddy. and I chose to raise our sons here because we believed that this neighborhood, where she and I grew up, was the best place to buy a home and raise two boys. Readville, however, is no longer a secret. We have tracks of land unlike anywhere in the City of Boston, land that is becoming harder and harder to come by. Industrial development is being pushed to the far corners of the City as residential building continues to flourish. This land is prime property. Thus, I will continue to work to do what is best for my neighborhood; I will continue to focus on our needs and concerns; and I will always be a steward of a fair and transparent process.

I have fulfilled my duty as steward of the City of Boston's long and arduous process regarding the Sprague Street Development. I've met with the development team on several occasions in an effort to mediate constituent concerns, opinions and suggestions; I've listened and responded to hundreds of voices – both for and against. During this process, I have been under great pressure to make a statement regarding where I stand on this project. I always felt grandstanding or making a premature decision during the process for headlines is not professional and doesn't serve my neighborhood. My role is to provide an opportunity for voices to be heard, on both sides of an issue. I refused to weigh in because I believe that we all should have our opportunity to make our case. As a Readville resident, this project would affect my family as much as anyone reading this today. But after meeting on October 1, it is clear to me that the development tram has failed to make a case to Readville and our Dedham neighbors that this plan would benefit our community. Therefore I will not be supporting this project as it was presented.
