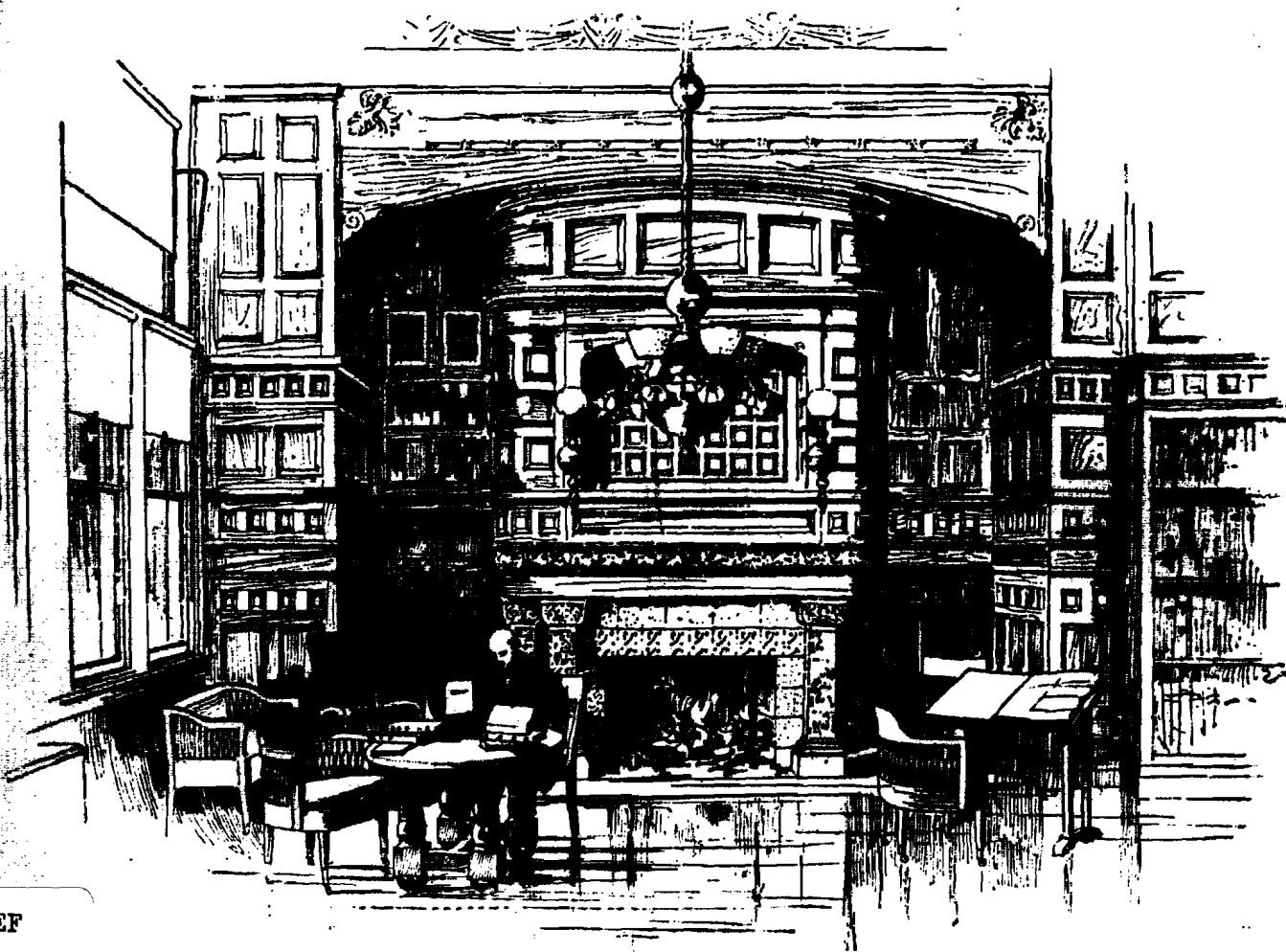


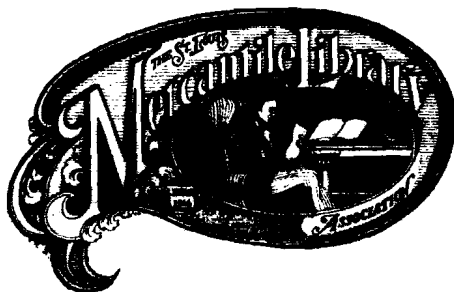

PREFACE

This register of documents, as it now hereby exists for the researcher, intends to be a basic list as well as an announcement made by the St. Louis Mercantile Library of the primary materials in its care relating to early St. Louisan Robert Campbell and his immediate family. The lives of this almost legendary fur trader, banker and St. Louis entrepreneur, and of his family tell a fascinating story of life in the unsettled West, and subsequently, of the burgeoning, booming midwestern city of St. Louis in the nineteenth century.

We at the St. Louis Mercantile Library have thus been immensely pleased that this important collection has come to our Research Department. We are indebted to our young archivist, Mr. Bryan Stephen Thomas, who has created this finding aid for these papers under the auspices of the St. Louis University Department of Historical Studies Archival Intern Program in cooperation with and under the supervision of the research staff of the Mercantile Library. In this collaborative effort it is hoped much has been learned between staff and intern, and we applaud Dr. Martin Towey of St. Louis University Department of History for his time and energy in administering such a splendid program. Mr. Thomas and the Mercantile Library have also benefitted from the unflinching support and advice in this project of The Campbell House Museum and Foundation-- especially from Mrs. Ann Morris, curator of the archives of that Museum and archivist of the John W. Barriger III Railroad Collection of historic materials at the St. Louis Mercantile Library.

Robert Campbell's contributions to the settling of the West and to St. Louis enterprise have always been profoundly felt. Yet, quite ironically, he has remained a shadowy figure to the modern reader. This is, in large part, due to the fact that significant documents relating to his life have remained hidden or hopelessly scattered in St. Louis and elsewhere since the death of the last Campbell heir in 1938. Even before the 1930's, this process had been well underway as Campbell's achievements slowly faded into historical footnote. Despite this trend, much effort in the 1940's by some far-sighted St. Louisans to salvage as much as possible for the city's various institutions had counteracted this.

It is sincerely hoped that this calendar of materials available at the Mercantile Library will help to renew interest in the history of an important individual and his era, which he influenced to such a large extent, and of a distinguished St. Louis family, now belonging to that city's collective, cultural heritage.

INTRODUCTION

The Campbell Family Collection of Historical Materials in the St. Louis Mercantile Library comprises a large and significant group of Robert Campbell's personal papers and business correspondence, the bulk of which was thought to be lost for a number of years after the death of the last Campbell heir and the subsequent dissolution of the Campbell Estate in downtown St. Louis, Missouri in 1938.

This material was discovered and, through donation, acquired by the Mercantile Library on July 19, 1985. It was accessioned into the institution's Special Collections Department through the efforts of John Hoover and, most importantly, through negotiations undertaken by Nicholas V.V. Franchot III with Mrs. Harry W. Kroeger of Clayton, Missouri in whose late husband's possession these papers had remained for the better part of fifty years.

Robert Campbell was one of the most widely known and influential businessmen of the American West. Born in March, 1804 in Aughlane, County Tyrone, Ireland, references to Mr. Campbell can be found in the journals and letters of the early American fur-trapping period. During his early years, he was associated with almost legendary figures of the fur trade, such as John O'Fallon, William H. Ashley, Thomas Fitzpatrick, Jedediah Smith, Jim Bridger and William Sublette. Mr. Campbell spent ten years trapping and trading in the West. Three years later, Mr. Campbell returned to St. Louis to form the firm of Sublette and Campbell which, for the next seven years, represented the only serious competition to the American Fur Company. This firm was formally dissolved on January 12, 1842 as Mr. Campbell turned his interests to establishing a large dry-goods store and investing in real estate. Over the years, he became the proprietor of the Southern Hotel, invested in steamboats and was President of both The Bank of The State of Missouri and The Merchant's National Bank. Mr. Campbell also engaged in public service. In 1846 during the Mexican War, he was appointed to the staff of John C. Edwards, Governor of Missouri, holding the rank of Colonel. His duties included the drilling and equipping of the mounted volunteers. Due to his familiarity with the Indian tribes in the West, Campbell was twice appointed Indian Commissioner, in 1851 by President Millard Fillmore and in 1869 by President Ulysses S. Grant.

Aside from biographical sketches and periodic references made in the writings of other traders and mountainmen, little has been published concerning the life of Robert Campbell. However, many personal journals, letters and records of Campbell are scattered throughout St. Louis and Missouri. The Campbell House Foundation, under the editorship of Ann Morris, recently published a finding aid to the various collections of Robert Campbell's papers possessed by that institution (*). At the time of that publication by Ms. Morris, however, the St. Louis Mercantile Library collection had yet to be acquired.

For the purpose of furthering scholarship on the life of Robert Campbell, and in order to provide an update on the Campbell sources that are available to researchers elsewhere, the publication of this finding aid and intended companion to the Campbell House - Morris document was determined of the highest priority by the St. Louis Mercantile Library Association.

SCOPE AND CONTENTS OF THE COLLECTION

As an overview of the Robert Campbell papers held by the St. Louis Mercantile Library, the collection consists of ledger books, copy books of business correspondence, check books with copious expenditure notations, monthly business reports for various firms and enterprises, as well as account books and a myriad of items ranging from legal papers, various personal books and government documents, maps and printed ephemera.

Personal correspondence, diaries and other family papers have been separated in a logical pattern from business papers by date. Alphabetical arrangement is employed where appropriate to facilitate usage.

The earliest material -- business records and early correspondence -- falls sharply between 1832 and the 1920's, with the most massive part of the collection concentrated between 1835 and 1882, covering Campbell's most active periods of work.

The collection comprises ca.35 linear feet of papers, divided into six subject series, housed in archival storage boxes in the Mercantile Library Rare Book Room, and is available for serious research by appointment at the Library.

Correspondence - By Date 1836 - 1883

Robert Campbell's correspondence of various business ventures as well as personal letters. By date, 1836-1883, and undated material.

- 1-1 -- Letter book - Business letters of Sublette and Campbell. Dates from September 15, 1836 through March 28, 1839. All letters are signed Sublette and Campbell. 12 1/4" x 8 1/4". Very good condition. Spine deterioration.
- 1-2 -- Letter book - "Sublette & Campbell Letter Book". Business letters of Sublette and Campbell. Dates from April 1, 1839 through February 17, 1841. All letters signed Sublette and Campbell. Indexed. 13" x 8 1/2". Very good condition.
- 1-3 -- Letter book - "Letter Book No. 3". Covers business correspondence of Sublette & Campbell. Dates from April 5, 1841 through October 18, 1847. This collection is not a copy book. Instead, the letters have been copied onto paper. 12 1/2" x 8 1/4". Index in back. Very good condition.
- 1-4 -- Letter book - "Letter Book No. 2". Robert Campbell and R. & W. Campbell business letters. Dates from April 29, 1845 through April 18, 1848. R. & W. Campbell letters toward rear of book. Indexed. 12 3/4" x 8 5/8". Very good condition.
- 1-5 -- Letter written by Robert Campbell to Col. J. J. Albert dated April 17, 1848. Handwritten and signed by Robert Campbell.
- 1-6 -- Letter book - Copies of letters, most of which pertain to business, written by Robert Campbell between 1850 and 1855. There are over 1,000 holographs. The collection is bound and each page is numbered. Cover missing, spine deteriorated.
- 1-7 -- Letter book - Copies of letters written by Robert Campbell. Dates from December 20, 1851 through December 11, 1852. 11 1/2" x 9 3/4". Cover missing. Letters fragile but usable.

- 1-8 -- Letters - Two copy sheets of letters found in bottom of transfer box. Dates from December, 1852 and October, 1862. Fair condition.
- 1-9 -- Letter book - "R. & W. C". Letters signed R.W. Campbell. Dates December 13, 1852 through February 14, 1853. 190 letters. Indexed. 12" x 9 3/4". Various stages of disintegration.
- 1-10 -- Letter book - A collection of Robert Campbell's business letters between February 23, 1853 and April 18, 1854. 632 pages of letters and short notes to clients. Contains an index. 11 5/8" x 9 3/4". Spine in poor condition. Covers are loose.
- 1-11 -- Letter - Dated April 21, 1854. Deals with Fort Kearny.
- 1-12 -- Letter book - "From 13 February 1855 R. Campbell No. 3 to ". Letters pertaining to business dating from February 13, 1855 through March 24, 1856. 609 pages of letters and notes to clients. Includes an index. 12" x 9 1/2". Binding loose.
- 1-13 -- Letter book - Copies of letters and business notes dating from May 28, 1857 through May 18, 1858. 12" x 9 7/8". Spine deteriorating; letters in good condition.
- 1-14 -- Letter book - Copies of letters written by Robert Campbell. Dates from July 25, 1859 through September 25, 1862. 11 3/4" x 9 3/4". Cover of binding is missing. Spine has disintegrated. Letters in fair condition.
- 1-15 -- Letter book - Dates from March 6, 1861 through June 25, 1862. Indexed. 953 pages. 12" x 9 3/4". Good condition. Spine deteriorated.
- 1-16 -- Letter book - Set of business letters which date from June 26, 1862 through May 5, 1864. Indexed. 12" x 10 3/4". Spine deteriorated.

- 1-17 -- Letter book - "Letters R.C. & Co." Nearly 1,000 pages of letters to clients and private individuals. Dates from May 6, 1864 through March 24, 1866. Indexed. 11 3/4" x 10".
- 1-18 -- Letter book - Copy book collection of letters relating to business. Dates from March 21, 1866 through December 31, 1867. Nearly 1,000 pages. Indexed. 11 3/4" x 9 1/2". Good condition. Spine deteriorated.
- 1-19 -- Letter book - A collection of Robert Campbell's business letters dating from January 2, 1868 through August 31, 1869. 1,000 pages of letters and notes to clients. Indexed. 11 7/8" x 9 3/4". Good condition.
- 1-20 -- Letter book - Copies of business and personal letters written between September 1, 1869 through May 9, 1874 by Robert Campbell. 11 3/4" x 9 5/8". Good condition, Binding is cracked.
- 1-21 -- Promissory note - Dated January 10, 1872. To Robert Campbell from Wm. M. Clanahan for \$348.50. 3 1/2" x 7 5/8". Very good condition.
- 1-22 -- Letter written by Robert Campbell to his sister, Ann, dated March 4, 1872. Holograph signed.
- 1-23 -- Letters - From John Campbell of Kansas City to Robert Campbell. Three letters, dated November 22, 18, and 2, 1872, respectively. There are some notes and figuring of Robert Campbell attached. 8 1/4" x 3 1/4", folded. Excellent condition.
- 1-24 -- Letter book - "Letters R.C. & Co." 201 pages of letters and notes to clients. Dates from May 15, 1874 through July 30, 1879. Indexed. 12" x 10 1/8".
- 1-25 -- Letter book - "Letters R.C. and Co." Final business letters of Robert Campbell. Dates from February 11, 1878 through May 22, 1883. 11 3/4" x 10 1/4".

- 1-26 -- Letter book - "Blotter Book". More letters from Robert Campbell. The early entries mention the Sublette-Campbell Company, whereas later letters are signed Robert Campbell. Index in front. 13" x 8 1/2". Very good condition.
- 1-27 -- Letter book - 1,001 pages of business notes and letters of Robert Campbell. The last letter in the book is signed Hugh Campbell, asking for a "political favor". 12" x 10 1/8". Good condition.

SERIES TWO

Business Records

Robert Campbell businesses and firms; with company ledgers, business day books, account books, various receipts, bank books relating to fur trade activities, St. Louis property ownership and management, rental agreements, loans and indebtedness. By date 1832 - 1885 and undated material. Always, the first noted year and month of each entry takes precedence over any subsequent date in this listing.

- 2-1 -- Sale log - Robert Campbell's written record of goods sold to trappers at rendezvous in the West. The book details items sold and the cost per item. It also, selectively, records the place of sale as well as the name(s) of the trapper(s) purchasing goods. Most entries are dated 1832. 6 1/4" x 7 1/4". Book in good condition; spine deteriorated.
- 2-2 -- Ledger book - Ledger sheets depicting the constitution of the Jedediah S. Smith Estate as administered by W.H. Ashley. Entries range from 1831 through 1833. 13 1/4" x 8 1/4". In paper wrappers.
- 2-3 -- Account book - Record of sales and debts made between March 24, 1834 and April 16, 1834. Most sales are of horses. There is also a note concerning Captain W. Stewart. 5 7/8" x 3 3/4". Very good condition.
- 2-4 -- Journal account book - "Sublette & Campbell of St. Louis, April 6, 1835". Listing of purchases made upon return from fur-trading rendezvous. Also list of items needed prior to leaving. 7" x 4". Cover in leather, rapidly deteriorating. Documents in good condition.
- 2-5 -- Receipt book - Deals with payments of notes. Begins as Sublette & Campbell. Dates from October 8, 1836 through 1848. Very few entries. 7 1/4" x 8 3/4". Very good condition.
- 2-6 -- Ledger book - List of receipts dated July 22, 1845 through February 9, 1857. Leather binding is deteriorating and in poor condition.

- 2-7 -- Ledger book - "H. P. & Co." Accounts with Harvey Primeau, et al. Records indicate fur trading and also list purchases. Dates from May 14, 1849 through October 2, 1865. Also mentions R. Campbell's investments with river boats. 14" x 10".
- 2-8 -- Receipt book - Record of loans and payment of notes. Dates from August 2, 1849 through December 14, 1852. 5 1/8" x 7 7/8".
- 2-9 -- Ledger book - Contains accounts of R.H. Campbell, R. Campbell and Sublette & Campbell. Cover of book dates the commencement of records September 30, 1849, yet some records date back to the early 1840's. Indexed in back. 13 5/8" x 9 3/4". Binding and spine are deteriorating.
- 2-10 -- Ledger - A list of clients in alphabetical order with page number notations which correspond to ledger page. Dates from 1850 through 1855. 14 3/4" x 9 1/2". Fair condition. Spine has deteriorated.
- 2-11 -- Ledger - "Ledger". The ledger consists of names at the top of each page, followed by balances. A notation concerning a debt due to Campbell and Kelly is found on page 4. Dates 1850 - 1862. 14 3/4" x 8 5/8". Very good condition.
- 2-12 -- Ledger - Includes client index at beginning of ledger. Dates 1850 through 1857. Note - 3 letters appear in center of journal pertaining to the Indian Trade in 1855. Also, two envelopes and a piece of notepaper with names written on it. 13 1/2" x 8 5/8". Good condition. Spine has deteriorated.
- 2-13 -- Invoice book - Empty except for loose ledger sheet in middle dated July 11, 1851. "Invoices". 16 1/2" x 10 1/2". Book is in fair condition. Contains a few loose ledger sheets.
- 2-14 -- Ledger book - Lists of accounts receivable. Dates from June 22, 1852 through November 23, 1858. 17" x 10 1/4".

- 2-15 -- Note book - A brief list of persons trading with R. Campbell. Also notations of trip which mentions wagons and military materiel. Circa 1853. 6 1/4" x 4 1/2".
- 2-16 -- Ledger book - "Cash Book A". An account of debits and credits for March 1, 1853 through September 30, 1856. 17 3/4" x 11 1/4". Good condition.
- 2-17 -- Ledger - "Day Book A". Business transactions and payments made between March 4, 1853 through December 31, 1858. 14" x 9". Very good condition.
- 2-18 -- Receipt book - Collection of charges amounted during Robert Campbell's shopping tours of New York City and Philadelphia. Dates from April 1, 1853 through May 28, 1857. 8 1/4" x 5 1/4". Binding has begun to deteriorate. Interesting design on cover. Book in good condition.
- 2-19 -- Ledger - An alphabetical listing of persons and companies followed by page reference numbers. The first section of the ledger is an index. The middle section is a statement of accounts. Dates range from 1854 through 1859. At the back of the ledger is a loose booklet entitled Robert Campbell & Co. - Memoranda - December 31, 1869. This booklet is a memo of merchandise sold in 1866-1869. "Accounts Current R.C." 15" x 10 1/4". Contents in good condition; binding in fair condition.
- 2-20 -- Note book - First entries date from 1855. Later listings are a diary of street lamps that are not working. 7 1/8" x 4 5/8". Good condition.
- 2-21 -- Ledger book - "#2". First part of ledger is an index with names of people and businesses. The second half contains the accounts. Circa 1855 through 1860. 15 1/2" x 10 1/2". Contents sound; deteriorating binding.
- 2-22 -- Bank book - J.S. Shaw. Entries beginning April 6, 1855 through July, 1858. 5 3/4" x 3 3/4". Binding has separated; contents sound.

- 2-23 -- Ledger - "R.C." Business transactions made between September 1, 1855 through December 21, 1857. Most transactions include per item description of goods sold. 13 3/4" x 9 1/2". Contents in good condition; binding deteriorating.
- 2-24 -- Ledger book - "Day Book". Accounts for the Aricara Post from Saturday, July 19, 1856 through Monday, May 25, 1857. Account for St. Louis from August 11, 1857 through August 14, 1857. 35 pages. 15 3/4" x 8 3/4".
- 2-25 -- Ledger book - List of receipts dated February 13, 1857 through March 24, 1859. Also note entries at beginning and end of ledger that do not correspond to dates listed above. Three entries for January 8, 1859 in front of ledger and January 15, 1858 through March 18, 1859 in the back. 6 3/4" x 8 7/16". Book is in good condition.
- 2-26 -- Receipt book - Receipts from Philadelphia dating April 25, 1857 through June 12, 1863. 6 3/4" x 9", Weak bonding; contents in good condition.
- 2-27 -- Ledger - "Day Book B, R.C." Includes stocks and interest. Robert Campbell's personal financial interests. Dates from January 1858 through September 1862. 13 1/2" x 8 3/4". In sound condition.
- 2-28 -- Ledger - "Blotter B., R.C." List of sales from January 5, 1858 through June, 1858. Only the first 30 pages are used. 14" x 9 1/4". Leather binding covered with cloth.
- 2-29 -- Payment book - Robert Campbell's payment book containing names and dates. Dates from May 20, 1858 through April 23, 1860. 9 1/2" x 3 1/4". Book is in fair shape. Cover and spine have disintegrated.
- 2-30 -- Account book/diary - Some entries listed May 27 through July 6, 1858. Diary portion speaks of a steamboat ride which begins in St. Louis on Sunday, May 23 at 10:30 a.m. and stops in June on Cedar Island, 17 days after departing St. Louis. 6 5/8" x 4 1/8". Book in good condition.

- 2-31 -- Cash book - "Robert Campbell and Co." Cash entries begin June 4, 1858 through September 1, 1862. 6 1/2" x 4". Binding and contents are sound.
- 2-32 -- Ledger book - A list of sales and purchases made in St. Louis between June 6, 1858 through December 9, 1858. 15 3/8" x 10 1/2".
- 2-33 -- Account book - "The Merchants' Bank of St. Louis, in Account with Robert Campbell". Entries from October 2, 1858 through March 2, 1859. In addition, the latter portion of the book lists types, quantities and colors of beads, presumably to be used in trade with the Indians. 7 3/8" x 4 7/8. Good condition.
- 2-34 -- Ledger book - "Blotter 1859 R.C. & Co." Sales and purchases made in St. Louis between January, 1859 and June, 1861. 17 3/4" x 11 1/4". Good condition.
- 2-35 -- Ledger book - "Cash Book 'C' R.C." Detail of transactions between January 2, 1859 and February 25, 1878. 17 3/4" x 11". Good condition.
- 2-36 -- Receipt book - A few pages of entries noting the payment of interest and installments on loans. Dated February 21 and 22, 1859. 6 1/2" x 8 3/8".
- 2-37 -- Ledger - Names of persons and companies in account with Robert Campbell & Co. Dates from March, 1859 through May, 1865. Index of names at front of ledger. 14" x 9 3/8".
- 2-38 -- Receipt book - "Receipts R.C. & Co." Dates from March 25, 1859 through May 18, 1863. Various signatures. 8" x 10 3/4". Contents sound.

THE ST. LOUIS MERCANTILE LIBRARY

The St. Louis Mercantile Library Association occupies the sixth floor of its own building on the southwest corner of Broadway and Locust Streets. The entrance is located at 510 Locust. Hours are Monday through Friday from 8:30 a.m. to 4:30 p.m. The telephone number is 621-0670. We are closed on legal bank holidays.

Membership

Application for membership may be made at any time. Benefits of membership include invitations to social and educational events, such as the Lunch and Lecture Series held in the Reading Room and the Christmas Eggnog Collation. Sustaining Members will be given personalized coffee mugs. Pillars of the Library will receive two complimentary invitations to the Annual Gala, in addition to the above.

The annual rate, payable in advance, is \$25. The rate for six months is \$15. Sustaining memberships are available for \$100 per year and Pillars of the Library, \$500 per year. A corporate membership is \$500 per year.

Rules of Circulation

Books are issued for two weeks or one month. Two-week books may be renewed for an additional week. Month books may be renewed twice. All books may be placed on reserve for a period of two days. Periodicals are issued for one week and cannot be renewed. Members are expected to assume the responsibility of paying for a book that has been lost or damaged, if the book has been charged to their card. Once the book has been paid for, the money cannot be refunded. However, members may keep the book, if it found at a later date.

Mail Service

Mail service of one package of up to four books twice a month, or as requested, is available for an extra five dollars per year. In ordering books by mail, we prefer checked bulletins from the Library. However, we do accept handwritten lists. Oversized books cannot be mailed. Please include Call Numbers of books on handwritten lists.

NOTE: It is against the law to enclose any material except the books when using the Library Postage Rate for book mailing. Therefore, do not send checked bulletins, lists or any other correspondence when returning books by mail. The Library Postage Rate for books is 50 cents for the first pound and 14 cents for each additional pound through 7 pounds. The rate for each pound in excess of 7 pounds is 8 cents per pound.

Reference and Research Service

The Library's Special Collections Reference and Research Service, as well as its General Reference Room, is open to all inquiries by personal visit, as well as by telephone. The Library has sizable and significant resources in the history of travel and exploration, nineteenth century literature and illustrated books, and particularly in Americana and Western Americana, local history and transportation history, i.e., the John W. Barriger III Railroad and Herman T. Pott National Inland Waterways collections. Staff members of the Special Collections and Reference Departments are available to assist you with your research projects and reference questions. For extended work, it is suggested that one call in advance for an interview and appointment, particularly for out-of-town patrons anticipating research at the Library.
