#### Deficit Is Not a Dirty Word

The pandemic has presented unprecedented challenges for us all, particularly as leaders we attempt to balance the drive for earned revenue, with the needed underwriting to fulfill our mission to provide opportunities to experience great art. Each organization has its own balance of earned to contributed revenue, and its unique balance sheet of operating funds (working capital) and long-term savings. In trying times, everything should be tried--even the seemingly sacrosanct application of deficit spending. Deficit is not a concept that is fully understood, which can result in tension between boards and executive leadership, executive leadership and financial managers, and anyone who owns a stake in the short-, mid-, and long-term financial health of an organization. Explore how leadership may best leverage a strategy of deficit spending, for the longer-term viability and sustainability of their organization.

In spring 2017, following its strategic plan, the American Alliance of Museums (AAM) convened the Working Group on Diversity, Equity, Accessibility, and Inclusion (DEAI). Twenty museum professionals, representing a variety of disciplines, organizational sizes and types, and perspectives, came together, monthly at the Alliance's offices in Arlington, to examine the characteristics of effective museum inclusion practices and considered what steps the field could take to promote DEAI. This led, in part, to the monumental Facing Change Initiative – Advancing Museum Board Diversity and Inclusion, funded by Ford, Walton, and Mellon foundations.
