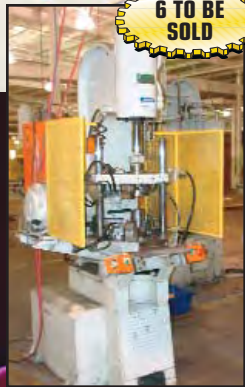

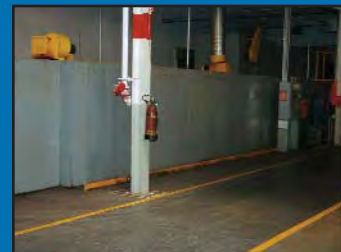

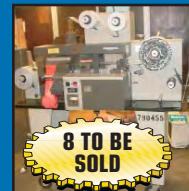

Turn right on Independence Avenue, and go approximately 1 mile to Ely Street. Turn left on Ely Street and go approximately 2 miles to sale site. Look left for signs.

## TERMS & CONDITIONS

**SETTLEMENT:** The United States and State Laws for failure to pay shall apply. The buyer agrees to make agreed settlement on sale day during or immediately after the auction in U.S. currency, bank-certified U.S. funds, or company check with bank letter of authorization.
