STRUCTURE OF THE EXAM

The first four computer based exams consist of fifty multiple choice questions and a student has two hours to complete the exam. The written exams consist of a combination of knowledge and scenario based questions.

ACCA Pass marks are 50 marks out of 100 marks.

COMPUTER BASED EXAMINATION

We are licensed to conduct the computer based exams at our campus. The written exams will be conducted in British Council.

STUDY MATERIALS



PAYMENT TERMS

Cash or Installments

The customer can either pay in cash or in installments. In case of cash payment the customer will get 10% cash payment discount. Alternatively the customer can pay in installments in which case he/she will have to pay at least the first installment before starting the classes. The rest will be payable in two equal monthly installments.

Early registration
