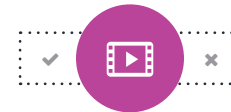

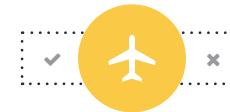

TECHNOLOGY



Meet the new-school side of accounting.

That's where tech-savvy CPAs come into play. They are so in demand there is even a designation called CITP (Certified Information Technology Professional) that makes you more specialized and known for your superior financial and technological prowess.

FINANCIAL ANALYST, GLOBAL SOFTWARE COMPANY

You're responsible for keeping software projects on track and on budget. That analytical brain of yours will help you spot and price the mistakes, too. It's a pretty cool gig.

NON-PROFIT

SPORTS



From soccer to surfing, it's CPAs who are really calling the shots.

While it's important for athletes to keep their eye on the ball, sports industry CPAs are responsible for watching much more than that. Representing the financial needs of pro athletes and franchises takes skills in everything from analyzing the financial implications of drafting a new player to pricing box seats and negotiating the best deal for whichever budding star you happen to be financially representing at the time. It's all about the win.

CEO, SPORTS APPAREL COMPANY

You're like the head coach of an all-star team. You call the financial shots and work closely with your top players to develop marketing plays that will lead everyone to victory.

STAFF ACCOUNTANT, SURF SHOP

Price merchandise, develop tubular promotions and balance those books like you would on the surfboard to keep financials looking as rad as possible. Wear your sunscreen.

ACCOUNTING MANAGER, NATIONAL TENNIS ASSOCIATION

Serve up expertise in overseeing a team of accountants, keeping track of revenue and setting aside some of it for tennis education programs. Like tennis? Then you'll love this job.

\$74,500 – \$97,500

FRAUD EXAMINER, POLICE DEPARTMENT

Bust bank robbers, catch criminals and scare the living daylight out of fiscal wrong-doers. Enjoy all the benefits of being a cop, without having to wear the uniform.

\$68,000 – \$91,750

SPECIAL AGENT, FBI

Help keep our country safe from people committing bank fraud and even international terrorists. Plus, you'll have a pretty sweet badge to go along with this high-prestige gig.

FORENSIC ACCOUNTANT, BIG 4 ACCOUNTING FIRM

Work for one of the big guys helping put the bad guys away for good. Solve financial mysteries, uncover shady business and take home a handsome paycheck for doing it.

The food and fashion industries lean on CPAs to ensure they're making the best decisions when it comes to the business side of things. These CPAs answer the big questions to keep businesses in the black. Will outsourcing overseas save us money? Should our next location be in Austin or Atlanta? CPAs are involved with tons of business decisions—everything from what's on the menu to what walks down the runway.

ACCOUNTING MANAGER, NATIONAL JEWELRY CHAIN

Keep count of everything from inventory to advertising spending. Whether it's coming in or going out, you're the one who's responsible for the business of baubles and bling.

GLOBAL CONTROLLER, SPORTS DRINK COMPANY

On top of keeping athletes hydrated so they can perform their best, you'll be in charge of making sure your profits do the same. Manage a team of global experts.

\$159,000 – \$224,750

PROFESSOR, LOCAL COLLEGE OR UNIVERSITY

Share your invaluable wisdom on things like general accounting principals, audit and international tax law with the accountants of tomorrow. Plus... summers off. Score!

\$112,000 – \$182,000

STAFF ACCOUNTANT, LOCAL SCHOOL DISTRICT

Help future generations get the best public education possible by keeping track of school finances, staying within budget and making sure all the teachers get paid.

\$57,750 – \$70,000

FUND ACCOUNTANT, UNIVERSITY ENDOWMENT FOUNDATION

Monetary gifts from friends, families, companies and alumni are always flowing in. You keep track of it all and make sure it's always used according to donors' wishes.

Schooling school systems on their accounting acumen.

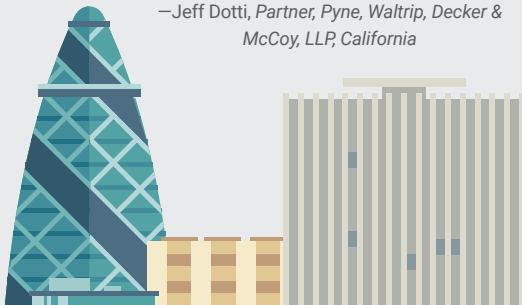

CPAs who work for public firms do all kinds of things for all kinds of companies. They work as an unbiased third party financial advisor to their clients and can either work at their firm or onsite at a client's office, depending on what they're doing. The 46,000 accounting firms in the U.S. range from small one-person shops to large international operations. And the accountants who work for them learn every angle of business.

PRESIDENT, YOUR OWN ACCOUNTING FIRM

The good thing is you don't have to work for "The Man". On the flip side, you are "The (Wo)Man." And as such, it's all you—big decisions and an even bigger office.
