






Challenges



- Difficult to enforce *consistent accounting policies* across disparate systems
- Inefficient use of IT and accounting resources to *rebuild rules for each application*
- Substantial *reconciliation issues* between product systems and accounting
- Lack of flexible mechanisms for *tracking analytics* with accounting
