All occupational licensing Boards are required by N.C.G.S. to undergo periodic Rules Reviews. The process requires the Board to post notification of a public comment period as well as the classification of Rules. The NCBOCE began this process with an August 23, 2018 filing you can review on our website here: https://ncchiroboard.com/10-year-rules-review-notification-and-classification/

The comment period for the NCBOCE's Rules classification began on August 27, 2018 and expires October 31, 2018. The Rules Review Commission ("RRC") will review the Board's final classification at the February 2019 RRC Meeting. In April 2019, Rules deemed "unnecessary" will expire, while Rules deemed "necessary but without substantive public interest" will remain in the Administrative Code.



Final Approval of Amended Rule 10 .0305

At the July meeting, the Board approved the final language of amended Rule 10 .0305 that will change the NC required minimum passing score for Part IV of the National Board's from 475 to 375. There were no changes from the original Amended Rule language.

The filing has been made to the Rules Review Committee (RRC) and we expect to be on the September or October Meeting agenda. If approved, the Amended Rule would be effective on the first day of the month following RRC approval.
