### A Message from the Delegate How to Use These Summaries

This document contains the **Agenda Topic Summaries** of the background information for all the items to be considered by the thirteen conference committees of the 71<sup>st</sup> General Service Conference (GSC). The topics will be discussed by each committee, and the committees *may* or *may not* send recommendations to the whole Conference for consideration and vote.

The **purpose** of these summaries is so that they may be used as a tool by General Service Representatives (GSRs) to provide their group with pertinent information to facilitate an informed group conscience and then to convey that group conscience to the Delegate. In many cases, the summaries serve as an appetizer and those GSRs and groups with an interest in more information should request the complete background from their District Committee Member (DCM). Please remember to **treat the background as AA Confidential**, and do not share it in any public forum or with non AA members.

Please pay special attention in these summaries to the section at the end of each topic: "What does the Delegate need to know?" Not all topics make for fruitful discussion at group level, and this is intended to help you narrow that down. Many of the agenda topics are only for that particular committee (such as reviewing a draft or progress report on the development of a piece of literature) and do not require a group conscience. Other topics appear every year, such as reviewing workbooks and kits used by Public Information, Corrections, etc. Local committees may wish to share their experience. These summaries may also be used by other members of our Fellowship to communicate good information about the agenda topics and, where appropriate, to convey opinions to the Delegate.

Your Delegate this year serves on the **Conference Committee to Grapevine & La Vina** as well as on the secondary committee to **Archives**. Please bear in mind that I will have the opportunity to discuss the agenda topics in those sections in depth during my committee meetings at the Conference.

What is unique to 2021 is that several topics were forwarded from the 70th GSC (those are noted with a + sign in the topic header). This is because the first virtual Conference had a limited schedule and chose to not address everything on the agenda last year. The schedule for this year's virtual Conference is intended to allow enough time to address those items, and these summaries include any new information provided by the trustees' committees on work done over the course of the year. Historical Context; Why is it on the Agenda?	In 2019, this committee reviewed the 2018 General Service Conference evaluations and noted that improvements were implemented from previous years' suggestions. The background includes a copy of this year's evaluation form. A summary of results from the 2019 evaluation form is also in the background and is generally positive about the 2019 Conference – though there were concerns about the translations (particularly the Spanish translation) being late.

A conference call in January 2019 – which included sharing from Conference committee members, the chair of a corresponding Trustee's committee, and a staff secretary – gave Conference members an opportunity to review items on the agenda and discuss items still being considered by trustees. This conference call was then evaluated by the call participants. The evaluation form, results of the survey, and comments from the survey, are all included in the background. Since 2016, efforts have been made to enhance the General Service Conference agenda review and selection process, giving delegates a role in the vetting and selection of proposed agenda items. By 2019, a conference call (including members of a Conference committee, the corresponding trustee's committee chair, and a staff secretary) was implemented. That phone call occurred again in 2020 (with improvements from suggestions from the previous year), and another questionnaire was sent out; answers from that questionnaire are summarized in the background and are positive about the process – one comment is that the process, "for right now, it's perfect as is," though another comment suggests creating a workbook for Conference committee chairs to help them understand their roles as chairs.

Historical Context; Why is it on the Agenda?	Kits and Workbooks are reviewed by the appropriate Conference Committees during each General Service Conference (GSC). Between Conferences, ideas for changes to a Workbook or to the contents of a Kit may be reviewed by the appropriate trustees' Committee and implemented. Alternatively, the trustees' Committee may choose to forward an idea to the Conference Committee for review. Members of the Conference Committee then have an opportunity to review proposed changes to a Workbook or Kit during the next GSC. The CPC Committee Workbook is contained in the Kit and can also be ordered separately. The

#### Conference Committee: Cooperation with the Professional Community — Item D

Historical Context; Why is it on the Agenda?	In January 2019, the committee discussed the procedure to process GSO Publishing updates per the "AAWS Policy on Publication: Keeping Literature Current." The committee noted that additional logistical details to the process warrant consideration for additional definition and agreed to continue discussions in March 2021. Background material includes a draft updated pamphlet, "Members of the Clergy Ask about AA." The content of a piece of literature presented for final approval to the Conference will be fully edited, with no expectation of further change being made prior to publication other than as may be specified by the Conference in granting its approval.
What does the Delegate need to know?	We will not hear group consciences on this item at the Assembly, but you can share them with the Delegate via email, through a web form on the Area website, or by phone.

#### Conference Committee: Corrections — Item A

Agenda Topic	Consider request for a review of all correction related literature to replace terms such as "inmate" and "offender" with less stigmatizing language.
Historical Context; Why is it on the Agenda?	Beginning as a motion from Area 79 (British Columbia/Yukon), background materials note that terms such as "inmate" and "offender" are used by corrections facility administration, not by incarcerated AA members. These words may be taken as derogatory and do not create a sense of belonging. Literature containing these words may not feel inclusive and can go unused. In order to lower the barriers, offer respect, and to aid in recovery, this proposal suggests alternate words should be chosen for the literature, such as "member on the inside" or "incarcerated member."
What does the Delegate need to know?	Does your group feel that terms like "inmate" and "offender" should be replaced in corrections literature? Why, or why not?

Agenda Topic	Discuss innovative ways of carrying the message to alcoholics in correctional facilities/programs.
Historical Context; Why is it on the Agenda?	This past year has brought changes in the way we communicate. This agenda topic encourages sharing within the Fellowship to assist AA groups to find innovative ways of carrying the message to alcoholics in correctional facilities/programs. Suggestions for new solutions to connecting to incarcerated members can offer hope and may save lives. Some examples in the background include teleconferencing, increased literature in facilities during the pandemic, and visiting sponsorship services.
What does the Delegate need to know?	Does your group have any ideas on how to communicate with incarcerated members and increase opportunities to share the message of AA? Does your group know about the North County H&I Virtual Panel effort?

#### Conference Committee: Finance — Items +A1 and A2

Agenda Topic	Review the pamphlet "Self-Support: Where Money and Spirituality Mix:" Consider a request regarding contribution percentages to service entities. Discuss mechanization of group contributions.	
Historical Context; Why is it on the Agenda?	Two pie charts are currently provided on pages 12 and 13 that list suggested percentage breakdown for group contributions between the various service entities. A third chart is provided with no percentages; this is intended for the group to use to create their own breakdown. Area 61 (Rhode Island) has asked that the sample charts be eliminated leaving only the top pie chart with no suggested percentages. They understand that the pie charts are meant to be examples only, but they believe that they are taken literally by many groups. Furthermore, another group submitted that set percentages lead to a mechanization of the process, not allowing for flexibility and thought. The pandemic has shown that certain entities need more money during changed circumstances, while other entities spend less.

Agenda Topic	Reconsider the 1972 G.S.C. Advisory Action stating "G.S.O. should not accept contributions from clubs, listed or known as such, whether or not composed solely of A.A. members. Contributions are welcome from groups meeting in clubs as long as they are sent in the name of the group."
Historical Context; Why is it on the Agenda?	A District in Northern Illinois is asking GSO to consider accepting contributions from clubs, as anyone attending AA meetings at the club is an AA member, and there is a difference between a club being an outside entity and a hospital or institution being an outside entity. GSO currently feels that they are unable to determine whether all clubs are composed solely of AA members.
What does the Delegate need to know?	Does your group feel that GSO should accept contributions from clubs? Why, or why not?

#### Conference Committee: Finance — Item D

Agenda Topic	Discuss Concept XII, Warranty Two and the practice of "selling of our books at cost or less."
Historical Context; Why is it on the Agenda?	This item originated from a past delegate in Area 40 (Montana) and the 38 pages of background include correspondence and archival documents. The proposal notes that in the Concept XII essay, Bill advises that AA should not function in the same manner as a charity with regard to freely giving away our literature, yet those who administer the Pink Can Fund and the Carry the Message Project are assigned responsibilities that require them to do exactly that. Currently these funds are being used to purchase literature for incarcerated individuals who cannot afford or do not have access to the literature on their own. The author of the proposal says he does not intend to suggest, or advise against, either program being discontinued, and notes that they serve an expressed and vital need. In Warranty Two, Bill W. wrote that "Up to now we AA's have strongly believed that money charity to the individual should not be a function of the AA groups or of AA as a whole." And the submitter feels current policy and procedure documents of various committees in the AA service structure are in conflict with the language in Concept XII, and that this discrepancy warrants discussion.

Historical Context; Why is it on the Agenda?	Individual bequest contribution limits are reviewed every few years. The last adjustment was in 2019, when the bequest limit was increased from \$5,000 to \$10,000.

Agenda Topic	Review the Conference-approved maximum annual contribution of \$5,000 to the General Service Board from an individual A.A. member.
Historical Context; Why is it on the Agenda?	The annual contribution limit from an individual AA member to the General Service Board is reviewed every few years. The last adjustment was in 2018 when the limit increased from \$3,000 to \$5,000.

#### Conference Committee: Finance - Item H

Agenda Topic	Review the "Google Grants and the Seventh Tradition Report."
Historical Context; Why is it on the Agenda?	Google offers all non-profits the opportunity to receive up to \$10,000 a month in "in-kind" media value (free advertising). This might or might not be compared to PSA distribution on radio or TV airtime. AA World Services, Inc. utilizes this grant, clarifying that it has not accepted any money from Google, only services. AAWS cites that it already currently receives services with non-profit sales discounts from a list of major companies and that the Google grant does not set a precedent. The full report is included in the background, including the Conference history and actions on topics relating to Google.
What does the Delegate need to know?	Does your group feel that accepting Google Grants for AAWS is in line with the 7 <sup>th</sup> tradition? Why, or why not?

This survey was distributed online and was completed by 4,568 members of the fellowship – both subscribers and non-subscribers. The opportunities identified included: 1. An opportunity to improve perceptions and relevance of Grapevine/La Viña as important personal recovery tools; 2. Confusion surrounding funding of Grapevine and La Viña; 3. Current content being geared toward younger members of the fellowship, as well as members with long-term sobriety; 4. A desire for a simpler subscription model; 5. A better digital experience; and, 6 Improve La Viña engagement.

The current text on page 117 of the <i>Twelve and Twelve</i> states: "Nearly every sound human being experiences, at some time in life, a compelling desire to find a mate of the opposite sex with whom the fullest possible union can be made—spiritual, mental, emotional, and physical. This mighty urge is the root of great human accomplishments, a creative energy that deeply influences out lives. God fashioned us that way."

	The proposer states that the removal of the words would be more inclusive, the words are religious in nature and in conflict with Tradition 10, and that some members were personally offended by the text as written as it implied a condition of membership. He also states that those against the change were concerned that if we start changing anything, where would we stop and that, as written, the <i>Twelve and Twelve</i> was good enough to get them sober, so it's good enough for everyone.

Step Six, paragraph 13, the current version of the <i>Twelve Steps and Twelve Traditions</i> reads as follows: "No one wants to be angry enough to murder, lustful enough to rape, gluttonous enough to ruin his health."
	The reasons given for suggesting this change are: lust is not the cause of rape and this inaccuracy at best misinforms AA members and at worst triggers AA members—many of whom are sexual assault survivors; the causes of sexual assault were not studied, well-known, or understood when Bill W. wrote that sentence; and, use of the are unnecessary—words that have such potential to provoke trauma belong in literature that's more narrowly focused, like pamphlets. Aware of the declaration the General Service Conference made in 2002: That no changes be made to the text of the <i>Twelve Steps and Twelve Traditions</i> because "the book has helped so many alcoholics find recovery," and because "Bill's writing [should] be retained as originally published," the proposers argue that it would be more likely to keep survivors and perpetrators in the fellowship from getting upset enough to consider a drink, or become agitated enough to leave a needed meeting. Since the current language in the <i>Twelve Steps and Twelve Traditions</i> regarding sexual assault is "incorrect and outdated," the proposers request "that you please reconsider your 2002 recommendation."

The suggested change is designed to be sensitive to and accommodate transgender and non-binary members because a segregation of men and women leaves these members at risk of misunderstanding, ostracism, rejection, and even violence.

The trustees continued exploring the need and approaches to update the pamphlet, and the memo highlights input from the Fellowship, noting a desire for new stories reflective of the broad diversity of experiences within the black community, stories that speak to today's Fellowship in language accessible to "modern day" readers, and stories that don't shy away from the difficulties faced by black AA members in attending meetings, service events,
	and other aspects of the Fellowship.

The Board also decided to not publish any study guides because "there are no authorities in AA, and even a self-appointed 'teacher' has feet of clay. Hence, it is preferable that the individual member or prospect interpret the literature according to his own point of view."
	In the past few years, however, a number of proposals to simplify the language of the book, modernize the language into contemporary English, or create workbooks supplementing the AA program have been made. Included in the background are multiple proposals: one (from the San Diego/Interior Area) requests a translation of the book into a fifth-grade level; a second (originating in the North Florida Area) requests an individualized workbook to accompany the Big Book; and a third (from a group in New Jersey) requests that the chapters 'To Wives,' The Family Afterwards,' and 'To Employers' be removed from the Big Book. Other requests include removing the words 'He' and 'Him' from Steps 3, 7, and 10, and replacing them with 'Higher Power' or 'God,' asking Jewish Rabbis. Muslim leaders, Indian Ancient Vedas scholars to edit the book to encourage diverse spiritual language, creating a Big Book dictionary, and creating a workbook to study the Twelve Steps, the Twelve Traditions, and the Twelve Concepts.
	Because so many of these proposals have been sent to the Board, an exploration into what underlying need was driving these requests was launched. The subcommittee tasked with that project reported that most of the need was driven by concerns about accessibility (because of literacy levels) and relatability (because of changes in culture and language). The detailed subcommittee report is included in the background. A video of the PowerPoint presentation from the 70 <sup>th</sup> General Service Conference was made available in 2021, and the slides from that video are included in the background.
What does the Delegate need to know?	Note: If your group has feedback on the video, we will hear it here during the Assembly.Should we continue exploring possible solutions that could help make our message more available? The members suggest that the inclusion of the Long Form of Tradition Five on page 12 could help emphasize that the group is a spiritual entity.

The committee will not be asked to act on it, but rather to determine if they agree with the decision to take no action or if an item needs more work for consideration. They will send their decision back to the trustees' committee to either agree, for more work or information, or for reconsideration, along with rationale, so that a final decision could be made.
	The January call would include a clear invitation that the trustees' committee is interested in the thoughts of the Conference committee members as to whether these Agenda Items not forwarded or still under consideration should be forwarded to the Conference committee, with the Board keeping its final responsibility for selection in keeping with Concept 3. The focus of the call is to obtain sharing on the proposed agenda.

It speaks briefly to the process of simultaneous interpretation during Conference week and divides the translation of written materials into two categories: Conference Translation and Background Translation.
	2018 was the first year the background material was translated into French and Spanish. The bulk of this report is an overview of the process of translating the background material into French and Spanish by the first week in March, the participants involved, the timeline, and the expense of the project. The report explores the lessons learned and takeaways of hiring an agency to do the work compared to in-house AA translators. It also addresses challenges such as irregular style consistencies, even when provided a style sheet, inaccurate translations that did not conform to AA style, and sometimes poor performance or timeliness. Following the conclusion of the report is a list of questions directed to the Fellowship seeking shared experience on the need, presentation, and usability of the background material.

Google Ads performance is resulting in reaching a wide demographic, with the most active demographic being men between ages 25 and 34.

	The report found the following: The current directories available are the 2017-2018 editions, as it was decided in 2018 not to print a new edition during the implementation of the new database system. The purpose of directories is to provide AA members with contact information for groups, especially members who are travelling or who live in rural or remote areas. A 2015 survey of Intergroup/Central Offices showed that while some like to have them on hand, most use the internet now to find area meetings and contacts. There is an AA Near You section on aa.org that has contact information for local hotlines and websites, and the Meeting Guide app is now widely used.
	Looking at potentially printing again, it would have to wait until at least spring of 2021, as there have been challenges with the launch of the new database that will take some time to work through. Being mindful of the fact that not everyone uses technology, a suggested alternative is to use the leaflet <i>Central Offices, Intergroups and Answering Services for the US and Canada</i> (F-25) more widely for those without computer or smart phone access. Historical cost of directories is in the background.

A memo in the background from the General Manager explains that current practices and procedures would not allow for the creation of an alternate trustee, and points to how the current draft plan offers a viable solution for prompt reorganization of the Board. So, no changes were made in the draft from February 2020 and the Conference Committee on Trustees will be reviewing the same revision of the suggested procedures from last year, available in the background. Other documents in the background include the General Service Board Conflict of Interest Policy and a document from the NY State Attorney General on the Responsibilities of Directors of Not-for-Profit Corporations.

Work will continue on this following the 71 <sup>st</sup> GSC this year, and a report will be brought back to the 72 <sup>nd</sup> GSC.

In January, the trustees' Archives Committee adopted a report setting out the considerations of the Conference Committee, the ideas of the GSO Working Group with a request for guidance, and the perspective of the trustees' Archives Committee. The full report is in the background.

#### Conference Committee: Int'l Conventions/Regional Forums - Item A

At the 2020 Conference, the Conference Committee on International Conventions/ Regional

At the International Convention, there are three "big meetings." On Friday night, the meeting has traditionally (for the last four conventions) ended with the Lord's

The scripts for meetings during the day on Friday and Saturday have allowed meeting coordinators to close with any of these choices (or the option of a moment of silence). The background includes the meeting script and a 2019 letter from the 70 <sup>th</sup> Conference Committee Chair detailing how this item came from the committee.

#### Conference Committee: Int'l Conventions/Regional Forums - Item B

Agenda Topic	Discuss ways to encourage interest in Regional Forums and attract first-time attendees.
Historical Context; Why is it on the Agenda?	Regional Forums are held several times a year and are a service provided by GSO staff and the General Service Board with the intent of allowing the general AA membership (not just people involved in General Service) meet and interact with GSO staff and General Service Board members. This helps members put a face to their trusted servants. In order to encourage interest and attract first-time attendees, this committee discusses several ideas each year. In 2020 some ideas discussed were continuing to provide options for remote attendance, providing digital access to Forum materials and presentations (including use of the Meeting Guide App or mobile app) and having a "video invitation" from the GSB Chair. Recent discussion has focused on compiling notes from first-time sharing at a Forum, developing a Regional Forum app, developing a micro-site (in addition to postal mailing of Forum flyers), increasing outreach to different populations (like young people and Spanish-speaking communities), encouraging local welcome committees to create Save the Date flyers, inviting AAWS/AA Grapevine directors to "non-service" AA events to increase awareness of the Forum, and placing information about Regional Forums in the <i>A.A. Grapevine</i> and <i>La Viña</i> .
