Once the checkbox for "Upgrade Existing Scanner to 2nd Life Program" is selected, the Upgrade Kit, and 2nd Life License auto select as required. It then prompts the selection of the Calibration sheet, choose depending on existing Scanner at site.

In addition to the above items, when an Existing legacy PlotWave/ColorWave device on site is Remaining on Site (Active or Inactive) and not being Traded-in or Scrapped, the associated Top Cover is required for the older device. These New Top Covers will not match in color scheme to the older printers, however once the Scanner is de-installed the Top cover is required to be installed to prevent a large exposed area on the top of the machine. Leaving the existing printer without top cover is not suitable for safety and functionality reasons.

There is a selection in Deal Configuration to confirm if the Customer is keeping the existing printer on Site. If "NO" the Top Cover selection will not be required.
