How are we proposing to address the problem?






How will things be different/will the problem be solved or improved, when you are done?





Ten Common Elements found in Winning Proposals

1. Have clearly defined needs & describe how those needs were identified





2. Describe what kids & teachers will do





3. Present the material in a logical manner





4. Are written in positive terms





5. Do not overuse educational jargon



6. Present detailed budgets that match the proposed program





7. Give something back





8. Follow all the guidelines specified in the Request for Proposal

1. Cover Letter Requesting Funding that includes: (Developed by Applicant)
 Name of applying entity (must be a school district)
 Name of Contact Person which includes address, phone and fax number and email address
 Name of Fiscal Contact which includes address, phone and fax number and email address
 Name and address of fiscal agent who will be receiving check
 Amount of funding requested (maximum - \$1500.00)
 Name and signature(s) of accountable officer of funds.
2. Chart that identifies areas of strength and examples (page 2 of application packet)
3. Chart indicating products to be developed and/or disseminated (page 5 of application packet)
4. Action Plan that includes: (pages 6 and 7 of application packet)
Priority 1: Dissemination of Information to be a broad audience
Priority 2: Actions to support continuous improvement
 Priority 3: Identification of Priority Activity that correlates to one or more of the State Performance Plan transition related indicators (1- Graduation Rate; 2-Dropout Rate; 3-IEP Compliance; 14-Student Outcomes)



9. Are professional looking

10. Are not too short or too long







Do not get discouraged if you get a rejection from a possible funding source.

READ the grantor's guidelines & instruction carefully

- Keep your goals realistic
- Have a reasonable, detailed budget
- If possible, cite research that supports the program for which you are requesting funding



Clarity in communicating your ideas is very important

Proofread!





Ideas should be innovative, creative, & educational





Is your project replicable? Sustainable?


