



Fourth District Members Support "Companion Pet Program"

4th District S.A.L. members rallied together to support the Companion Pet Program at the Cincinnati VAMC. The new program gives robotic pets to veterans of the CLC unit as well as residents suffering with PTSD and those in the Hospice units.

The robotic companion pets help the residents deal through the tough times that each of them is facing. They help them deal with their daily stress from any illness but also help them cope with not being able to have family members visit because of the COVID-19 virus.

Currently the Veterans Administration does not support this new program through funding. It is only supported by donations from other groups. The 4th District and several of its Squadrons are one of the organizations that have stepped forward with donations.

Costs for each companion pet is \$150.00. A total of 18 pets were donated to the program. Along with the 4th District, Squadrons 69, 72, 138, 199, 513, 554, and 615 supported this program.

Award Given to S.A.L. Junior Member

S.A.L. Junior Member Aiden Duncan was presented the American Legion Auxiliary "Good Deed Award". Aiden is currently the 4th District Asst. Sgt at Arms and a member of Squadron 484. At the recent S.A.L. 4th District Fall Conference, Donna Ray Past Auxiliary Sate President and Cincinnati VAMC VAVS representative spoke about the new robotic Companion Pet Program. The program is supported by donations from organizations and Aiden asked his Grandmother how he could help the veterans. They came up with the idea for Aiden to sell candy bars at meetings and 4th district events. Aiden was able to raise \$300.00 for the purchase of two companion pets. This brought the total of 20 companion pets that were donated by the S.A.L. 4th District members. It goes to show where the heart of a 10-year-old S.A.L. Junior Member is.



On Saturday, November 7, 2020, Sons of The American Legion Don Gentile Squadron 532 rededicated Clime Cemetery in Columbus, Ohio.



Located along busy Clime Road in southwest Columbus, this cemetery was hard to spot unless you knew where to look. The cemetery dated back to at least 1840 with some of the area's earliest pioneers buried there. Adam Alkire and Conrad Clime are two examples. Alkire and Clime helped establish the area and both have roads named for them. Civil War Veteran William Huddleston of the 176th Ohio Volunteer Infantry is also buried here.

The cemetery's fence, erected in 1989 as part of a Boy Scout project, was partially knocked over, and had completely vanished by 2006. There are some tombstones knocked over, either due to weathering or vandalism. A road improvement project took place in that widened Clime Road and added sidewalks, making the cemetery much more visible. A small pull-off was also installed, allowing easier access to the cemetery. As of 2015, Clime Cemetery seemed to be regularly mowed and well taken care of.

In more recent times, the cemetery fell into disrepair again, and the grass was cut less frequently, trees had died but still stood, and work was needed to bring this historic cemetery back.

In June 2020, Past Squadron 532 Commander Jeff Waugh wanted to renovate this cemetery. He asked his Squadron for help, which led to this rededication today. Under the leadership of Commander Rocky Searles, Squadron 532 got the project started by adopting the cemetery and making a five-hundred-dollar donation.

Sowers Lawn Care was hired to do the initial clean-up, removing limbs and branches, weeds, trimming, and mowed the lawn. At the time, the plan was to continue to cut back overgrowth around the perimeter, and to install a new picket fence, flagpole, and benches, and to keep the cemetery properly maintained in the respectful manner that this historic cemetery deserves.

Mr. Waugh worked with Brian Sowers and Boy Scout Troop #275 on the project, and today we can see the fruits of their labor.

Eagle Scout Candidates Jordan Alt and Riley Duncan worked on the project, providing a paver patio with a bench and flagpole and a new fence to line the cemetery.

The Don Gentile Post 532 Honor Guard participated in the ceremony, with the Franklin County Sheriff's Office providing traffic control and security. The Franklin County Engineer's Office was also involved with research into the cemetery.

Child Welfare Foundation

The CWF has announced 17 grants for 2021 totaling \$740,889.

Many of the causes are the same as previous years, with different recipients. For 2021 the CWF will support the areas of Autism education, Braille books for the blind, medical transportation to treatments, Sudden Infant Death Syndrome, adoption assistance, Spina Bifida education, counseling of dependents of military personnel, Boy's Town national hotline, and a glossary of terms related to Schwachman-Diamond Syndrome.

We will also be supporting the usual American Legion endeavors in the areas of Youth Scholarships and Temporary Financial Assistance.

Ohio is off the zero in donations, so far, with \$220 being reported.

That's good enough for a tie for 22nd with Minnesota. Our goal, once again this year, is for \$1.00 per capita or about \$30,000. Last year we were pretty thoroughly messed up by Covid-19, and it looks like it's going to get bad, again, this winter. Hopefully, the lessons we learned last year will translate into better results this year. I love announcing donations received at our meetings, but if the meeting is cancelled, I still want the donation to go in. Consider direct mailing your donations to Delaware or Indianapolis. I have direct mail envelopes if needed.

I still have CWF piggy banks. The banner order form for 2021 is available at the CWF web site. Apparently new this year, you must send in the form AND your donation equal or greater to \$1.00 per capita in the same envelope in order to get the banner. The "Sons for Kids" aprons are still available through the American Legion. Suggested donation for each is \$20 plus maybe a little something extra to cover shipping.

We have also received, from National, three CWF awards that we were to have gotten at the cancelled National Convention.

Legislative Update

Congressman Davidson introduced H. R. 8484 Ensuring Survivors Benefits During COVID-19 Act of 2020. It requires the Department of Veterans Affairs (VA) to obtain a medical opinion when a veteran with a service-connected disability dies from COVID-19, and to determine whether their service-connected disability was the principal or contributory cause of death. The intention is to ensure the veteran's families receive survivor benefits.

Senate Amendment 1972 in the FY 2021 National Defense Authorization Act (NDAA) would add bladder cancer, hypothyroidism, and parkinsonism to the list of agent orange presumptive diseases. Each of these diseases has been linked to agent-to-agent orange by the National Academies of Sciences, Engineering, and Medicine.

For those Squadrons not using MySAL, why not? This is one of the best tools we have. It provides nearly instant updates to membership, reduces mailing costs, has multiple reports that are useful to Adjutants and Membership Chairmen, and discontinues the need to write a check to

Detachment every time you have membership to process. Transmittals are not only a few clicks away.

As of November 25, 2020, only 88 Squadrons have taken advantage of MySAL. We need more Squadrons to this tool, as it is not the wave of the future, it is the wave of the present. Don't be afraid of the technology. It is safe, secure, and timely.

When using MySAL, make sure to do your transmittals once you receive the member's dues. A good rule of thumb is to make your submission on at least a weekly basis. Who's next?

For those Squadrons not using MySAL, please remember that we do not hold cards. Once a member pays his dues, it must be processed and forwarded to Detachment head-quarters right away. These mailings should also be done on at least a weekly basis.



No matter which way a Squadron handles its membership transmissions, it is important that we conduct our Buddy Checks. Reach out to the members that haven't paid for 2021 and find out why. If he needs help, offer to do what you can. Especially during this global pandemic, our membership needs to know we care about them, how important they are to the organization, and remind them why they joined, and that they are **proud possessors.**



Memorandum

SUBJECT: NEC / ANEC Election – May 2021

Article VI, Section 2 of the Constitution of the Sons of The American Legion, Detachment of Ohio specifies in part the following (emphasis added):

"The Detachment shall hold an annual Detachment Convention to elect a Detachment Commander, First and Second Vice Commanders, a Detachment Chaplain, and in even-numbered years a National Executive Committeeman and an Alternate National Executive Committeeman. Such officers shall take office and be installed immediately before the adjournment of that session of the Convention at which they are elected and shall serve until the next Convention or until their successors are elected and qualified."

Given the impact of the COVID-19 pandemic and its effects on our elected officers (extending their terms in office through the 2021 Detachment Convention), I have received inquiries as to the next election of Ohio's National Executive Committeeman and Alternate National Executive Committeeman. These offices would normally have been elected to two-year terms in May 2020 but will now not be elected until May 2021.

Specifically, the question is: will the election of our NEC and ANEC in May 2021 be for a period of two years or one?

After consulting with Detachment Judge Advocate Bill Towns, Jr., we are offering the following answer to the question.

Since our constitution specifies these two offices are for two-year terms elected in even-numbered years and they shall serve until their successors are elected and qualified, it is our opinion that we should elect the next National Executive Committeeman and Alternate National Executive Committeeman in May 2021 to one-year terms and resume the elections to two-year terms in May 2022. Otherwise, we would need to amend the constitution to switch to odd-numbered year elections.


