# **Capacity Euthanasia List**


The pets on this list are at immediate risk of euthanasia and this serves as the final notice for them. It is updated daily before 5 pm for the next capacity euthanasia day. Humane euthanasia begins at 12:30 pm Monday thru Friday and 11am on Saturday. Although general euthanasia may take place on any of these days, pets with grave medical concerns may be euthanized at any time.

To allow the staff adequate processing and reply time, ALL placement intention emails from ACS-approved fosters and rescues MUST be received via: ACSRescue-foster@Sanantonio.gov at least 30 mins before euthanasia begins.

Placement requests submitted after these times, to different emails or by rescues, and fosters not currently approved to work with ACS provide no guarantee a pet will not be euthanized.

For pets located in kennels labeled "SAPA Tran": These are the transition kennels located in building #1 on our ACS 151 campus and are the primary responsibility of our rescue partner San Antonio Pets Alive!.

For placement interest and general questions about SAPA Tran pets, please email: placement@sanantoniopetsalive.org. Animals listed in SAPA TRAN are still at risk of euthanasia and may not have confirmed placement. They may return these pets to ACS at any time for euthanasia.
