Board Vice Chair Kip Harmon called the meeting to order at 6:30 p.m. in the Wembley Ave. Boardroom. The event had been scheduled to take place at Wedgewood Resort but was canceled due to coronavirus. However, in order to take care of necessary business and with everyone practicing social distancing, Board members met together as well as arranged for credit union members to call in to participate by phone. Kip said the virtual meeting was necessary due to coronavirus concerns. He said we're doing the best we can and spoke about the worldwide pandemic, noting not many places in the world have been untouched. He noted the phone number was advertised via signage at the branches and on our website, and gave instructions to those calling in as to where they could locate the annual meeting program online.

Kip announced board member and supervisory committee names and noted who was participating via phone or teleconference. He also asked those members participating by phone to give their names so they could be counted as in attendance for the meeting. They were also requested to email their names to mail@macfcu.org.

Tim Erickson announced 15 members constitute a quorum and noted we had achieved a quorum so the meeting could continue.

OLD BUSINESS

Kip noted the minutes from last year's annual meeting had been provided and asked for a motion of approval.

DAWN HARMON MOVED, ANGIE HEAD SECONDED TO APPROVE THE ANNUAL MEETING MINUTES FROM FEBRUARY 21, 2019, AS PRESENTED.

NEW BUSINESS

Kip noted required reports were included in the annual meeting program.

Election of Board Members

Tim reviewed the slate of nominees and explained the nomination process. Members whose seats are up for election include Kip, Jeremy, and Linda (who has retired). The Board had also recently changed the number of Board members from seven (7) to nine (9). The nomination committee had consisted of Linda Hilliard, Tim Erickson, and Dave Dershin. Committee members met with two candidates: Jim Williams and Traci Schachle. Both candidates are members in good standing.

Traci was present and introduced herself as a local realtor with Somers Sotheby's International. She was married and had been a Fairbanks resident for over 20 years. She loves Alaska and wants to be part of MAC and what they're doing for this community. She noted she's had previous experience on the Board of a credit union.

Kip noted he was a 32-year resident of Fairbanks, involved in lots of organizations in town and on MAC's Board for 10 years. He has learned a lot, despite having no previous credit union experience. He said the Board members we have now really care about members and said there was no such thing as a rubber stamp when making decisions. He said board members all had differing opinions coming from different backgrounds and said he wanted to continue serving on the Board.

Jeremy Fillipi has been in Fairbanks for 24 years. He said it started as a vacation, but he found work in the auto industry and was currently the business manager at Gene's Chrysler. He wanted to be more involved with finances and the community, noting MAC is very involved and he looks forward to continuing on the Board.

Jim Williams is Chief of Staff for the Fairbanks North Star Borough and was not able to attend due to an emergency borough assembly meeting. Kip spoke about Jim and his credentials, saying he would be a welcome addition to the Board.

Tim said the nominations committee had approved nomination of both Traci Schachle and Jim Williams. He asked if there were nominations from the floor and hearing none, he asked for a motion to accept the slate.

RUTH KNAPMAN MOVED, STACY MARKHAM SECONDED TO ACCEPT THE NOMINATIONS, AS PRESENTED.






