"Change" is the best way to describe what has been going on in the School of Social Policy

& Practice for the past three years. Even this annual publication marks an important change. We have transitioned from the hard-copy *Sociolog*, which appeared two times each year, to an electronic monthly newsletter titled, *Penn Matters* (named by John (Jack) Hansan, MSW'56) and a hard-copy annual publication.

Last September we welcomed our first cohort of seven students into our Masters of Science in Non-Profit/Non Governmental (NGO) Leadership. That program, which is offered in collaboration with Wharton and the School of Arts and Sciences, welcomed more than 20 students, including international students, in September, 2006.

This September we also welcomed 8 students into our new Masters of Science in Social Policy degree program. Two of the 8 students are pursuing joint degrees in Social Work and Social Policy.

Our core program is our Masters of Social Work degree. Enrollments in our MSW program remain strong and the quality of our students is truly remarkable. As most of our MSW students focus on direct or clinical practice, we also examined their career goals and trajectories. One conclusion we reached is that many of our graduates seek advanced education in clinical practice—more than what can be met through continuing education courses. Our Ph.D. program, which emphasizes research, is not suitable for our graduates who have a clinical focus and we have been frustrated in providing career guidance to MSW graduates who seek advanced education. Thus, our faculty has approved a new clinically-oriented DSW degree. We are recruiting our first class of students for matriculation in September, 2007.

Our research and service centers continue to grow and thrive. In January 2006 we received a gift that enabled us to create the Center for High Impact Philanthropy (CHIP). CHIP, which is led by Katherina Rosqueta, is designed to improve the impact of philanthropy by guiding philanthropists through decision-making and evaluation of the impact of their philanthropy.

The actual look of the school has changed as well. Thanks to the generosity of the MSW classes in 2005

and 2006, as well as reunion classes ending in '0,' '1,' '5,' and '6' we renovated two of our classrooms. While we could not bring direct light into the rooms, we did eliminate the 1960s style cinder-block wall treatments.

None of the changes I have listed would have been possible without the energy and wisdom of our

alumni, students, faculty, staff, and our Board of Overseers. All have been generous with their time, talents, and sometimes treasure.

While the major changes have been put into place, our work is not nearly over. In two years we will begin to celebrate the Centennial of the school—One Hundred Years of Social Work Education. In October 2008 we will be one of the hosts of the annual meetings of the Council for Social Work Education. We are planning two years of events to showcase the school and our contributions to social justice and societal well-being. We invite our alumni and friends to join with us in planning and celebrating the contributions of one of the nation's oldest and most unique social work education




#### **Masters of Social Work**


ith field placement opportunities from Washington, DC to New York City and electives ranging from *Race and the Law* to *Substance Abuse and Mental Health* and *Poverty, Welfare and Work*, the MSW program offers students a wide array of options in the field of social work. The well-rounded expertise of the faculty prepares students to practice social work in a variety of settings, and graduates become leaders in fields such as child welfare, mental health, school social work, domestic violence, community development, and urban social policy.


The focus on social justice – bolstered by the racism sequence at the center of the program – remains a cornerstone of a Penn social work education. In recognition of the importance of balancing field practicum with classroom study, the course schedule has shifted so that classes are now two and a half hours each. This will allow for more in-depth discussion, while expanding the opportunity to integrate field experience with theory. The MSW degree remains the School's core program, with a current enrollment of about 300 students. 

The MSW Student Organizations add a valuable dimension to the social work learning experience. The following organizations highlight some of the extracurricular opportunities available to students.

**Student Council** represents and communicates the academic, administrative, professional, and social concerns of the students, and serves as the umbrella organization for the social work student groups.

Association of Black Social Workers provides support and networking for African American social work students, and promotes the welfare of the African American community through services and programs that provide an understanding of the African American experience.

**Latino Social Workers Alliance** offers programs for students interested in Latino issues who want to contribute to social change, while gaining education and perspective on the unique concerns of the Latino community.

Queer Social Workers and Allies at Penn represents gay, lesbian, bisexual, transgender and questioning (LGBTQ) social work students and their allies, and offers social activities and advocacy, while serving as a liaison to the University-wide network of LGBTQ organizations.

Social Welfare Action Alliance is a national organization of progressive social workers dedicated to promoting social activism through teach-ins, education, and community service.

**Students for International Social Work** recognizes the need to be reactive and proactive to the world beyond the U.S. borders, and brings together students committed to social work in a global context.

**United Community Clinic (UCC)** is a free treatment and assessment clinic that provides services, events, and outreach to the East Parkside Community of West Philadelphia. The UCC is a collaborative effort of University of Pennsylvania Medical, Nursing, Dental and Social Policy & Practice students and their Schools.

#### **Masters of Science in Social Policy**

his September, the School welcomed its first class into the new Master of Science in Social Policy degree program. Graduates of this one year program will finish with an in-depth understanding of policy, policy research and advanced analysis, while having had the opportunity to explore a policy issue of special interest. The program prepares graduates to do policy in a variety of settings, including government, think tanks and advocacy organizations. Outside of the core class requirements, students work with their advisor to choose electives specific to their focus of study, and design and implement a policy research project. This eight week project, completed in conjunction with the Capstone Seminar, provides students the opportunity to do original research in an agency or organization. Director Dr. Carol Spigner emphasizes that the program offers numerous possibilities and points out that the governing board is already looking at opportunities for international experiences within the program.

#### Masters of Science in Nonprofit/NGO Leadership

f you had fifteen minutes to address the nation, what would you talk about?" This was one of the questions students asked seven executive directors and CEOs of local nonprofit organizations this past spring, through a series of conversations designed to strengthen their understanding of the leadership challenges facing the nonprofit sector. These conversations were part of the culmination of their year-long Masters in Nonprofit/Non-governmental Leadership in which students gained both the theoretical understanding and practical experience essential for effective leadership.

In conjunction with the Wharton School and the School of Arts and Sciences, Social Policy & Practice developed this visionary Masters degree to prepare leaders for the nonprofit/non-governmental (NGO) world. In the United States more people work in the not-profit sector than in the whole financial services industry or the transportation sector and Penn decided that leaders in the nonprofit sector need specialized education as much as those running financial services or the transportation industry. Through a combination of core classes on subjects such as "The Profits of Non-Profits," "Value Creation and Stewardship," "Transformational Reasoning," "Action and Efficacy," along with specialized tracks, electives, and individual mentorships with senior executives and community leaders, the NPL program fills this critical void.

Now in its second year, this fall the program welcomed twenty-one new students, a third of whom are members of the international community. This increasingly global focus positions SP<sup>2</sup>, in combination with its other graduate programs, to be a significant partner with those dedicated to human welfare around the world.

#### **International Programs**

hat happens if you travel 4,002 miles northeast from Penn as part of an international summer program? You find yourself in Rovaniemi, Finland, studying comparative social work with a group of international students and scholars. For the five MSW candidates who traveled with Professor Roberta Iversen, Ph.D., to the University of Lapland this summer, the program offered an unparalleled experience. Through this three-week program, participants gained a deep understanding of social and economic systems in other parts of the world.

In addition to the School's formal international exchanges to Finland, Germany, and Austria, students often arrange independent research studies in other countries. In recent years, students have studied resiliency among Burmese refugee women in Thailand and intimate violence among men and women in Guatemala City. During the 2006 summer session, independent research projects were undertaken by MSW students in Mexico, Taiwan, Tanzania and Thailand.

International and comparative research projects by members of the faculty add another dimension to the School's international activities. The following short list highlights some of the faculty's current international research projects:

- A study of NGOs in India, which focuses on issues of women's empowerment and entrepreneurship in the NGO sector (Femida Handy, Ph.D.)
- A cross-national research project on intergenerational relationships in families in Israel, South Africa, Holland, and the U.S. that are divided along lines of religiosity and country of residence (Roberta Sands, Ph.D.)
- A study on the prevalence of domestic violence and HIV in Tanzania (Laura Mc-Closkey, Ph.D.)

#### Ph.D. in Social Welfare

he Ph.D. in Social Welfare is an interdisciplinary program that prepares students to be scholars, researchers, and leaders in the field of social welfare. The program is highly selective and admits high caliber candidates who can flourish in an academically rigorous environment: Four new students entered the program this fall. The Ph.D. in Social Welfare provides candidates with the structured foundation courses necessary to engage with their colleagues on a competitive level, but also emphasizes the development of an individualized educational plan that builds on areas of faculty expertise and student interest. Throughout the program, candidates receive superior mentorship and advising from leaders in their field.

#### **Doctorate in Social Work**

ext September (2007), the School will welcome its first cohort of students into the new Clinical Doctorate in Social Work (DSW) program. Intended for clinicians with at least two years of post-MSW experience, this program focuses on clinical practice. Unlike the Ph.D. in Social Welfare, which is designed for those pursuing careers in research or academia, the DSW caters to those who want to remain clinicians or teach social work clinical practice.

The program is structured so that course work and dissertation are completed in three years, but the class times and class formats complement the schedule of working professionals. The School expects to admit a class of ten students during the first year of the program. More information about the DSW degree will be available on the SP<sup>2</sup> website in early fall 2006.


#### **Cartographic Modeling Lab**

hat do tax abatements, gun violence, and obesity have in common? They have all been the focus of different research studies conducted by the Cartographic Modeling Lab (CML). At the CML, GIS mapping is used to analyze impacts, trends, associations, and outcomes on an almost endless list of subject matter. Advancements in GIS software have enabled the CML to expand its research capabilities and offer more advanced, user-friendly data applications. These expanded capabilities have caught the interest of other universities, community organizations, foundations and government agencies on both the national and international levels.

As the CML continues to solidify its role as a leader in spatial analysis, the number of partnerships with outside agencies and organizations continues to expand. For example, in the KIDS Integrated Data System project, the CML partnered with more than seven municipal agencies in Philadelphia. This integrated administrative database grew out of a desire to conduct research projects that can be used to identify how programs and interventions can improve the quality of life for children and their families. As with all the CML's projects, the partnerships are essential to the collection of data as well as the application of the results to policy- and decision-making.

The variety of projects undertaken by the CML emphasizes the fact that their work is more than just map-making. In the past year, the CML has analyzed: the impact of weatherization projects on home ownership (initial results show these renovations increase ownership stability); the consequences of tax abatements in Philadelphia (it appears abatements attract investment and development to the city, but policy changes are recommended to ensure a continued positive impact); the routes of young gunshot victims (by using hand-held computer tablets, the victims are able to trace on a map the route they took leading up to the shooting). 
# Center for High Impact Philanthropy

Established in the Spring of 2006, The Center for High Impact Philanthropy (CHIP) is the newest center at the School. Under the guidance of Executive Director Katherina Rosqueta, CHIP addresses an aspect of the non-profit sector that is often untouched by other research centers: efficient philanthropy. In accordance with its mission, CHIP is not grantmaking, not grant-seeking, and does not plan to offer the kind of highly customized philanthropic advice that other philanthropic groups provide. Rather, CHIP will synthesize and translate existing information, develop practical metrics and benchmarks, and identify new models to help philanthropists achieve greater **impact**.

In the upcoming year, CHIP will begin pilots in two areas: K-12 urban education and global public health. The pilot programs seek to answer three questions: What interventions and programs are effective?; Which organizations are well-positioned to deliver what's effective?; and How does the policy landscape impact the effectiveness of a philanthropist's gift? In answering these questions, CHIP hopes to leverage the tremendous intellectual and scholarly resources of the University. After these initial pilots, CHIP intends to expand its work to include the areas of global development assistance and improving the lives of disadvantaged populations in the United States.

# Center for Research on Youth & Social Policy

s it promotes "social justice and social change through applied research, planning, and technical assistance," CRYSP has established a number of ongoing community relationships with agencies ranging from the Philadelphia Housing Authority to the Asociacion Puertorriquenos en Marcha.

In a recently completed nine month project, CRYSP collaborated with the Field Center for Children's Policy, Practice and Research and the Cartographic Modeling Lab to evaluate Family Support Services at Belmont Charter School. Findings revealed that these services are well received by students, teachers, staff and parents, creating a higher level of satisfaction than experienced by other charter schools in the state. In another project, with funding from the Department of Health and Human Services through Asociacion de Puertorriquenos en Marcha, and in collaboration with Programa Conexiones, CRYSP is conducting a five-year evaluation of an outreach program for Latino prisoners in Philadelphia with HIV and substance abuse problems who are returning to their communities. CRYSP is also working with the Philadelphia Housing Authoring on their Mentoring Demonstration Project for Low-Income Families and the establishment of another HOPE VI housing project, both funded by the Department of Housing and Urban Development.

As requests for CRYSP's research and evaluation services increase, the Center has made it a high priority to find a way to offer less-resourced nonprofits access to these services. To this end, CRYSP is embarking on a pilot study with Philadelphia Society for Services for Children to develop a service and funding model that will make the Center more accessible through corporate sponsorship.

While CRYSP's research projects address a variety of social problems and systemic issues, they simultaneously provide high-quality training opportunities. In the 2006-2007 academic year, CRYSP will host five second-year, macro MSW students from the School.

# Field Center for Children's Policy, Practice & Research

#### Founding Benefactors: Marie Field and Joseph Field, C'52

f EBay can do it, why can't we? In a recent editorial Dean Richard Gelles, Co-Faculty Director of the Field Center, likened the on-line auction giant's ability to track 1,000,000 detailed transactions a day to the real-time software that is needed in the child welfare system. Introducing a state of the art tracking program into the daily case management of abuse and neglect cases could remedy a number of shortfalls in the child welfare system. The first step in implementing a new management information system is the completion of a comprehensive evaluation of existing child welfare information systems. Toward this end, the Hite Foundation awarded the Field Center a grant to research current systems and convene a two-part summit of child welfare leaders and practitioners, software developers, federal legislators, and potential funders to develop a prototype MIS system.

This year the Field Center completed a number of projects, including an evaluation of social service programming at the Belmont Charter School (in conjunction with CRYSP), a contract from the Philadelphia Department of Human Services (DHS) to analyze the current policy manual and develop components of a new policy and procedure manual, and a study of the impact of pre-hearing conferences on dependency cases in Philadelphia Family Court. Additionally, the Field Center finished two separate research projects for the American Bar Association Center on Children and the Law related to victims of Hurricane Katrina who were known to the child welfare system.

In keeping with its multidisciplinary focus and its commitment to education, the Field Center has strengthened its Morning Symposia series. These symposia offer community leaders, social service practitioners, medical professionals, lawyers, and other child welfare workers the opportunity to hear from experts about groundbreaking research and current practices.

# Ortner-Unity Program for the Prevention of Family Violence

amily violence accounts for about 11% of violent crime. This percentage, reported by the Bureau of Justice Statistics in 2005, underscores the importance of the Evelyn Ortner-Unity Program on Family Violence. Since its inception two years ago, the program has developed an interdisciplinary approach to addressing domestic violence. Its activities and accomplishments include a new graduate course offered at the School, the development of an undergraduate course within the University, a national Intimate Partner Violence conference, a lecture, and a fellowship for a social work Masters student. Additionally, the program collaborates with numerous schools on Penn's campus as it advances the rights, safety, and well-being of victims of family violence.

# The Out-of-School Time Resource Center

oused within the Center for Research on Youth and Social Policy, the Out-of-School Time Resource Center (OSTRC) has positioned itself to impact both practice and policy. The OSTRC serves as a clearinghouse for professionals, offering access to resources such as training, field trips, and funding for OST programs. The Center is also involved in researching the effects of professional development, and strives to answer the question, "How can agencies and organizations invest in their staff in order to achieve the best student outcomes?"

This year, the OSTRC instituted a peer-networking group, maintains a listserv of over 500 subscribers, and hosted a professional development symposium sponsored by a National Science Foundation. The OSTRC also created an evaluation toolkit that measures conference training effectiveness. As a follow-up to this first toolkit, the OSTRC commenced a national pilot study to evaluate the impact of non-conference workshops. Data from these research projects is building a bank of evidence that can be used to shape OST practice and policy.

At this time, the OSTRC is funded primarily by a three-year grant from the William Penn Foundation. Support has also come from the Philadelphia Foundation, the Greater Philadelphia Urban Affairs Coalition, the National Science Foundation, and contracts with several outside organizations.

# The Program for Religion & Social Policy Research

edicated to understanding the nexus between organized religion and the provision of social services, The Program for Religion and Social Policy Research advances our knowledge on religious-based social services. Through a variety of projects, the program investigates the nature and practices of congregations and faith-based service agencies. One recently completed project led to the publication of The Other Philadelphia Story, a book by Program Director Ram Cnaan and his colleagues at PRSPR. Based on the Philadelphia Census of Congregations, the book is the culmination of four years of data collection and analyses, and explains the role of congregations and religious-based organizations in the provision of social services and charitable support.

In another project, PRSPR is conducting a community capacity study on reentry resources for ex-of-fenders. This project, commissioned by the Philadelphia Mayor's Office for the Reentry of Ex-offenders, includes an assessment of over 800 social service agencies in the area and aims to provide the City with valuable planning and policy information on these resources.

#### **Social Impact of the Arts Project**

stablished in 1994, the Social Impact of the Arts Project seeks to understand the ways that cultural engagement stimulates civic engagement and community revitalization. Since its inception, SIAP has undertaken a variety of policy research projects on the role that cultural institutions play in the metropolitan Philadelphia region and its neighborhoods. SIAP recently completed the Philadelphia and Camden Cultural Participation Benchmark Project to document the current state of cultural participation in North Philadelphia and Camden. Currently, SIAP is conducting an evaluation of the John S. and James L. Knight Foundation's Community Partners in Arts Access (CPAA) initiative and collaborating with The Reinvestment Fund (TRF) on a study of culture-based neighborhood revitalization funded by the Rockefeller Foundation.



## SPECIAL REPORT: SP<sup>2</sup> RESPONSE TO HURRICANE KATRINA

fter Katrina raged ashore on August 29, 2005, the first reports out of New Orleans and the Gulf Coast broadcast the devastating aftermath: flooding, looting, loss of life, lack of food, and utter chaos. A thousand miles away, the SP<sup>2</sup> community immediately mobilized its response effort in Philadelphia. Students, faculty, and staff formed a relief committee and worked in a number of ways to aid Hurricane victims:

- A "Loose Change" drive raised money for the American Red Cross.
- Faculty and students wrote editorials about Katrina-related social work practice and policy issues.
- SP<sup>2</sup> community members staffed the Red Cross Disaster Hotline.
- Students created a "Jazz up New Orleans" t-shirt, which was given to all donors who contributed \$10 or more to the School's relief efforts.
- Friends and local businesses contributed a range of prizes to a fundraising raffle.
- An invitation-only reception at Douglas Cosmetics raised more than \$500 when Douglas contributed 10% from all guest purchases to Katrina relief. Speakers and a photo display offered an intimate look at the regional devastation and the need for continued support.

Liddy Congdon-Martin '06, Karen Singer '06 and Amanda Barczyk '06 were instrumental in spearheading these efforts. The majority of the Committee's fundraising efforts have supported the United Negro College Fund, Inc., to aid in the renovations of Dillard and Xavier, the two Historically Black Universities severely damaged by Katrina. To date, SP<sup>2</sup> has forwarded contributions totaling \$2,500 to the UNCF.

Unfortunately, more than a year after the Hurricane hit, New Orleans and the surrounding communities still need our support, so the School continues its fundraising and relief efforts.
