Modern play-way method is used to create interest in the young learners and help in accelerating the process of learning. A glass of milk and mid-day meal is provided to take care of their nutritional needs and regular medical check-ups ensure they remain in good health. Music, dance, art and other extracurricular activities are an integral part of their curriculum. The students get opportunities to perform on public platforms to boost their creativity and confidence. Celebrations and outings, sports and games are other avenues to nurture talent and make them ready to forge ahead in life in pursuit of their dreams.



Sshrishti strongly believes that reading of books should go beyond the prescribed texts and writing should be an expression of the innermost thoughts and feelings. The children at Sshrishti's centres are encouraged to read extensively. Each centre is equipped with a library and the children this year also participated in a creative writing workshop organised by the NBT.

At the village resource centres of project Sshrishti CRN in Uttarakhand, the local children and youth have an easy access to a wide variety of library books to add to their entertainment and knowledge base. The computers at the centres offer them an opportunity to become digitally literate.

Nutrition – Impact

Better health is indicated by improved school attendance and expected gain in height and weight of the students. These are documented in each of Sshrishti's educational centres.

Mid-day meal served on all school days to: 550 children

A glass of milk served daily to: 500 children

Average attendance at learning centres: 80%

Healthcare—Impact

The following medical check-ups were carried out at Sshrishti's educational centres:

1. **Eye check up** by Rotary South West Delhi at SLC, Kishangarh, with distribution of 48 glasses after cataract operation. Total Beneficiaries: 200

2. **Dental check up** By Rotary mobile dental camp at Jai Hind Camp. Beneficiaries: 79

3. Immunization: Hepatitis B at Sshrishti Vidya for 93 students. Hepatitis A: 90 students & Typhoid: 96 students

4. Immunization of Polio at Sshrishti Bal Siksha for 111 students.

5. Health and Hygiene workshop at Jai Hind Camp for 96 members of the community

Women Empowerment

Project: Sshrishti Jagriti

Adult Literacy: This project tries to address the low literacy rate among the women of the community. The women are keen to learn to read and write and Sshrishti's program is helping them to fulfil that aspiration.

The programme also runs **special classes** for girls who have dropped out of school. These girls are enrolled and coached to continue their education through the National Institute of Open Schooling and get due certification from the board after appearing for the examinations.



Skill Development & Livelihood: Sshrishti's Tailoring units in Bhatti Mines and Rangpuri Pahari are providing vocational training and regular income to women. The women stitch uniforms for Sshrishti's learning centres and make fashion accessories which are sold through exhibitions and on online marketing portals.

Advocacy: Mahila Panchayat:

This project has been running in association with the **Delhi Commission for women.** It provides a platform for grievance redressal to women living in Bhatti Mines which is a neglected colony on the fringes of Delhi.

The women members of the Panchayat along with a coordinator from Sshrishti offer help to women suffering from domestic abuse, financial exclusion and other forms of social and sexual violence . They are helped with counselling and legal aid.

Prevention of sexual harassment at place of work


The Vishakha guidelines mandate that any organisation employing more than 10 people must have an internal complaint committee for redressal of complaints regarding sexual harassament at place of work and take measures to create a safe environment for the women workers.

To counter the growing incidences of violence against women at home, public places and place of work, Sshrishti offers training sessions on gender sensitisation to organisations for creating a safe working environment for their female staff members. The training sessions are customised to address the profile of the employees of each organisation.

Rural Development

Location: Uttarakhand, District Nainital, Villages— Gahana, Sonera, Sasbeni, Saliakot Talla, Saliakot Malla. These villages suffer from lack of water, very low income and male migration resulting in ceaseless drudgery for its women.



Population: 8050 families.

SHG Formation: Two SHGs have been formed and they have been engaged in maintaining the nursery of fruit and other plants and in tailoring. They are also helping with water management.

Horticulture: Plants in our nursery

Walnut: 330 grafted, 92 non-grafted at Saliakot Walnut: 190 Grafted, 349 non-grafted at Sargakhet Lime: seeds in 400 polybags & 27 saplings Prunis Avium (Padam): 146 Fir: (Deodar): 230 Quercus Glauca (Phaliyat): 46 Padam: 146





Water management:

This programme was launched in February 2015 with the construction of 15 check walls on a stream in Village Saliakot Talla. These check walls will prevent runoff of extra water during rainy season and make more water available for irrigation in the village.

Water samples from drinking water sources have been checked for contamination, and plans are being finalised to construct an infiltration well to supply clean drinking water to the villagers.


Digital Literacy

Sshrishti's digital literacy programme was started in 2004 with 8 obsolete computers donated by IIT Delhi. By 2008, Sshrishti had started its rural computer centres to bridge the gap between the rural children and their more privileged urban peers.

Sshrishti's Engagement with Sarva Shiksha Abhiyan -

This engagement started in 2009 with Sshrishti joining the Vidyalay Kalyan Samiti to supervise the utilisation of funds received by the local government school in Sect. B1 in Vasant Kunj for improving the infrastructure of the school.

SMDC (School Management & Development Committee):

After the transformation of VKS into an internal body, SDMC was formed in the year 2014 and Sshrishti has been a member of SDMC of B1, Government School, Vasant Kunj since then. The SDMC also comprises of the current MLA of the area. Sshrishti is a part of the bimonthly meeting of SDMC which is conducted in the school and has a major say in the committee.

Major responsibilities of Sshrishti in the SDMC

Monitoring the quality of mid-day meals provided to the students of middle school.

- Monitoring the utilization of funds by the school in the capacity of a signatory authority
- Monitoring and ensuring cleanliness in the school.
- Monitoring the general maintenance work in the school including but not limited to infrastructure maintenance.

Bali - the girl who journeyed from persecution to hope

Bali's family fled to India from Sindh in Pakistan fifteen years ago. As a refugee fleeing persecution, her childhood memories include images of a harrowing flight under the cover of night. She was only ten years old at that time, but vividly recalls hiding behind trees and shrubs, holding her breath in fear.

The family drifted to Sanjay Colony, Bhatti Mines. A remote part of Delhi, almost unknown to the outside world, the dry terrain and the ramshackle huts here provided a familiar landscape. The mining activity in the region provided employment to the people from their village who had fled earlier. Bali's family put up a mud and thatch home in the growing colony of hutments and started their life in the new country.



Her father opened a roadside vend and made a living selling daily home



necessities. But a monthly income of 5000 rupees was never enough to provide for a family of seven. The first casualty was very predictably, Education. Growing up in a community displaced by external politics, they were faced with deep seated mistrust of any changes to the traditional social norms. Hence, neither Bali nor her three sisters reached school. The appalling situation was compounded by the absence of suitable schools and the apathy of the civic administration. Unschooled and unskilled, Bali and her sisters lived a marginalized life grappling with poverty and hopelessness till they were contacted by Sshrishti's community worker and offered life changing opportunities. They joined the literacy and skill development classes conducted by Sshrishti. Bali and her sister Rajkumari soon became proficient in tailoring and joined the livelihood generation centre 'Sshrishti Jagriti'. Bali is a confident 25 years old woman today and her sister Rajkumari is 20. They work regularly at Sshrishti's centre crafting fashion accessories and tailoring school uniforms. The fashion accessories are marketed by Sshrishti on various E-Commerce portals like ebay, snapdeal and paytm and the school uniforms are used by all the students

in Sshrishti's various learning centres.


Bali's family income has increased substantially since they started working at Jagriti. The new found economic independence has made Bali determined to help her peers, the young women who are victims of rights abuse. Now she is an active member of Sshrishti's grievance redressal forum-the 'Mahila Panchayat' and helps other women cope with issues of domestic violence, financial exclusion, child custody and various other practices that rob women of their confidence and dignity. Bali is today an active member of a Self Help Group started by Sshrishti. She represents the new generation of women in Bhati Mines, who remain steeped in family traditions yet continue to journey towards self-fulfillment.


