This was truly an exceptional year for Assistance League. With your support, we expanded our philanthropic programs to include weekend food for children in a neighborhood school through Pack for Kids, and books for older children through Books from Friends. We consolidated our Outreach and agency Operation School Bell®efforts to serve deserving children whose uniform criteria were different than our standard uniforms. Assistance League Scholarship is now a permanent chapter program.

Perhaps the highlight of the programming year was Discovery Day at the St. Louis Zoo. We took our Steps to Success shoe program and 100 elementary school students to the zoo. Working with school administrators, the students received new shoes and socks and an educational experience in a fun and iconic location. It was truly a joy to behold!

For our donors and partners, the highlight of the year will certainly be the chapter's achievement of a Platinum Rating from *GuideStar*, the world's largest source of information about nonprofits. Fewer than 1% of nonprofit members earn Platinum status. Our 80% return to community and the thoroughness of our program assessment practices are major factors contributing to our rating.

As we close our 29th year of service, Assistance League of St. Louis celebrates the lives we have touched through our philanthropic programs and the generosity of our members and donors who made it possible. Our philanthropic programs are conceived and delivered to empower, not enable; to provide opportunity, not foster dependence. ## PHILANTHROPIC PROGRAMS



#### **Operation School Bell®**

Provided over **9,908** elementary school children from **29** area schools with two sets of new uniforms, socks, underwear, dental hygiene kits and an age appropriate book. An additional **3,232** children received shorts and shirts for the summer months.

#### **Steps to Success**

In 2001, Assistance League began providing athletic style shoes and socks to school children. Last year, our members visited **32** elementary schools to properly fit and provide athletic shoes to **3,319** children.





#### **Operation Hug**

In 1987, we were one of the first nonprofit organizations to distribute **teddy bears** to emergency personnel and social agencies. We now serve **26** agencies in the St. Louis community.

#### **Project ROSE**



Since 2001, Assistance League members have delivered **gift bags** containing clothing, personal care and household items for women and their children in 4 area shelters. We also provided clothing, undergarments and hygiene kits to sexual assault survivors. Through last year, we have contributed to the well being of **18,800** women and children in crisis.

#### My Own Fun Stuff

Assistance League delivers kits for quiet activities for both children and adults to **21** hospitals, schools and agencies. Begun in 1986, last year we provided **21,702** activity kits.





#### **Pack for Kids**

Through the Pack for Kids Project, Assistance League provided weekend food to **440** students and their families in the last year.
