These are the type of comments we receive from families all the time. This is what helps make each year so special for us at CF Dream Holidays.

#### 2018

2018 was another great year for Dream Holidays. Our income, although not quite as much as in 2017, was over our budget level and with our hard work and the good discounts we receive from many of the holiday companies such as Haven and Butlins, we were able to help 223 CF children and their families with a much

needed respite holiday. We were also very lucky once again to be given some free holidays in Duchally Country Estate in Scotland by the wonderful people at CLC World Resorts and Hotels. In addition to this we continue to use holiday accommodation on the Isle of Wight which is much loved by the families who are lucky enough to go there with us, that and the numerous free tickets to the many attractions on the Island make this a great choice for the families. We have received lots of lovely postcards and photos from families, many of which you will see throughout this report.



#### **INCOME**

Our main income is from various Grant Giving Trusts and Foundations, some of whom have supported us since the mid 90's – such as The Baron Davenport Charity, Earmark Trust, Harry Payne Trust, Langtree Trust, Rank Foundation, Rind Foundation, Sir Jules Thorn Charitable Trust, Sobell Foundation, Stella Symons Charitable Trust, to name but a few! We also raise funds from Rotary and Lions Clubs, etc., a small Direct Mailshot 3 times a year which is done "in house" this way we know exactly how often our donors are contacted and it ensures the peace of mind that we don't sell their details on to other marketing firms. In addition to this, various friends and families of the CF children we have helped arrange different events to raise funds for Dream Holidays.

# Once again this has been invaluable in helping us with the urgent referrals we have received from the Hospitals. Last year we received 50 urgent referrals slightly less than the previous year and we raised £46,000 for this fund. It's an amazing feeling being able to help these truly needy families at such short notice. The urgent referrals are cases such as a child is waiting on a heart/ lung transplant so can't travel too far from the hospital and the holiday would need to be taken

straight away. Other cases are where the

We have six Trustees who meet to agree the board strategy and activities of the Charity, consideration of investments, Bank accounts and risk management.

Most of all our thanks go out to all of our supporters personally for your help with funds. Without you we would not have been able to help as many families as we did. Thank you for taking an interest in our Charity and helping us achieve a wonderful 25 years!

The trustees consider the available reserves are sufficient for the committed expenditure requirements of the charity at the year end.

#### Statement of the Management Committee's responsibility for the Accounts

#### Notes forming part of the Accounts For the Year to 31st October 2018

#### 1 Accounting Policies

The accounts have been prepared under the historical cost convention adopting the following principal accounting policies.

#### a) Basis of Preparation

- (i) The accounts have been prepared on a receipts and payments basis and include income and expenditure as they are received or paid rather than earned or incurred.
- (ii) The recommendations for SORP 2006 have been followed in the preparation of these Accounts.

#### b) Cash flow

The Accounts do not include a Cash Flow statement because the Charity, as a small reporting entity, is exempt from the requirement to prepare such a statement under the Financial Reporting Standard 1 "Cash Flow Statement"

#### 2 Tangible Fixed Assets

Tangible fixed assets are measured initially on the balance sheet at their historical cost.

The asset less its residual value must be depreciated on a systematic basis over its useful economic life.

Office Extension 0% per annum of cost Computer Equipment 25% per annum of cost

The charity has chosen not to depreciate the office extension as its residual valuation is likely to be at least equal to its initial cost.

#### 3 Revaluation of Tangible Fixed Assets

The charity has chosen to adopt an accounting policy of revaluation on tangible fixed assets on a rolling basis over a five year period. Any gain will be shown within the revaluation reserve on the balance sheet

#### 4 Total Recognised gains and Losses

The Charity has no recognised gains or losses other than the net movement of resources for the above year.

#### 5 Direct Charitable Expenditure

Included in the Fundraising Expenses are the Direct Mailing Costs incurred by the Charity for the above year.

#### 6 Trustee Remuneration

No remuneration was paid to a charity trustee or to any one connected to a charity trustee during the year

#### 7 Trustee Expenses

No expenses were paid to a charity trustee or to any one connected to a charity trustee during the year

#### 8 Office Extension

The charity has contributed to half of the cost of building a dedicated office to work out of. The amount forwarded of £12,500 is to be re-paid to the charity if the house to which it is attached is sold.
