Contract Review, Agreement, & Execution	 Disclose in writing the source of supply Issue revised quote when source of supply changes.
Supplier Approval and Source Selection	 Weighted criteria or supplier ranking system; ARP6178 or equivalent. Require suppliers to issue a revised written quotation and risk assessment, if source of supply changes.



Control Plan Topic	AS6081
Supply Chain Traceability	 Identify the name and location of all of the supply chain intermediaries for all procurement lots If traceability is incomplete or unavailable, customer approval required.
Verification of Purchased Product	• AS6081 calls out specific testing and sampling plans.



Control Plan Topic	AS6081
Control of Nonconforming Product	 In any case, suspect/fraudulent /counterfeit parts shall not be returned to the Supplier
Reporting	• Suspect, fraudulent and confirmed counterfeit parts be reported, within 60 days of identification, to internal organizations, and to customers, applicable Government authorities, Government reporting organizations



Control Plan Topic	AS6081
Personnel Training	 Personnel with responsibility for the detection of suspect/fraudulent/ counterfeit indicators through use of Radiographic Inspection (e.g., X-ray and XRF) shall be trained and certified to NAS-410 National Aerospace Standard, NAS Certification Qualification of Nondestructive Test Personnel or equivalent



ANAB Accreditation Rule 47

Factors related to Scope determination

"Because a certified distributor may supply parts in accordance with AS6081 and also supply parts not in accordance with AS6081, the Certification Body shall develop processes to ensure an understanding of the distributor's practices.

These Certification Body processes will ensure that the audit teams understand the distributor practices and verify that the distributor employs appropriate controls and makes appropriate representations of parts delivered to customers."



ANAB Accreditation Rule 47

Factors related to Scope determination

- How does the distributor differentiate between an AS6081 and an non-AS6081 order?
- How are the following processes affected by AS6081?
 - Requests for Quotes from the Customer
 - Purchasing
 - Testing
 - Test Report
 - Reporting



AS6081 – Role of Consultant

Tasks where you may utilize a consultant:

- Review of current documentation to identify gaps
- Revision of policies to meet AS6081 requirements
- Internal Audit of AS6081 requirements

Recommend that you don't have the consultant present during the certification audit. It's important that the certification body believes that your internal staff have a good understanding of the requirements of AS6081.
