"Video Lottery Siteholder (VL) registration requirements"

- Confirmation from Atlantic Lottery Corporation (ALC) confirming the number of video lottery devices that they intend to supply to the site.
- Valid liquor licence under the Liquor Control Act.
- ➤ Registration fee of \$3,200 for the initial application if you have between 15 and 25 devices (\$3,000 for renewal).

OR

Registration fee of \$2,200 for the initial application if you have between 11 and 14 devices (\$2,000 for renewal).

OR

- Registration fee of \$1,200 for the initial application if you have between 1 and 10 devices (\$1,000 for renewal).
- Completed Application for Video Lottery Siteholder and Personal Disclosure Form (retailer and the manager).

Information on the applicant, and on individuals and corporations identified in connection with the applicant, may be shared with Government officials who are assisting the Gaming, Liquor and Security Licensing Branch in the evaluation of applicants for registration and with the Atlantic Lottery Corporation;
- 3. The Branch may share information on the applicant, and on individuals and corporations identified in connection with the applicant, with law enforcement agencies for gaming-related investigations or clearances, with other branches in the Department, and with the Atlantic Lottery Corporation; and
- 4. To conduct ongoing personal history investigations, including checks for criminal charges outstanding and past criminal convictions or criminal records, during the entire course of the applicant's registration with the Gaming, Liquor and Security Licensing Branch.
