K.D. stated she wanted her back pain worked on.

Mr. Anthony stated he wanted to look at her posture, so he had K.D. turn around so that he could look at her pelvis area, and said her pelvis was not in the right alignment, and that he needed to work on that area.

AG Ms. Campbell asked K. D. if the 1st massage on June 9th proceeded as she expected. K.D. said it was as expected.

AG Ms. Campbell asked K. D. if she had massages before from other therapists. K.D. said yes.

AG Ms. Campbell asked K. D. if this was one time before or several times

K.D. said it is not frequent but she does go on occasion.

K.D. said Mr. Anthony offered her the special price to return again.

AG Ms. Campbell asked K. D. if the 2nd massage on June 9th proceeded as she expected.

K. D. said Mr. Anthony had her stand and he looked at her posture again.

K.D. said it was as expected.

AG Ms. Campbell asked K. D. if the 3rd massage on June 17th proceeded as she expected.

K. D. said Mr. Anthony had her stand and he looked at her posture again. Mr. Anthony was working on other things and he had not worked on her back at all since she had asked for it.

AG Ms. Campbell asked what she was dressed like for the massage

K.D. said she undressed down to her underwear same as she had done before. While she was being massaged the drape was moved off completely and it was not a massage anymore. She was being groped and Mr. Anthony was caressing her breasts. It was rubbing from top to bottom going over the breast touching the nipples. Her breasts were not draped. Mr. Anthony started working down to pelvis area. Mr. Anthony tucked the drape inside the underwear, working on the outer thigh and working on the inner thigh, his fingers touched the outer part of the vagina, rubbing against it and gradually getting closer and closer to penetrate. It was not pressure, it was being caressed and touched.

AG Ms. Campbell asked whether Mr. Anthony touched K.D.'s Vagina but before penetration whether K. D. stopped him saying "This is way too much". K.D. said ves.

K. D. said Mr. Anthony stopped then moved to massage her legs.

After the massage K. D. immediately went to the police station and filed a complaint. The investigator had asked K.D. to call Mr. Anthony to try to get in contact. K.D. left a voicemail requesting callback.

Mr. Anthony called back about 2 hours later. K.D. returned to the police station to record the conversation.

AG Ms. Campbell asked what was said when she called him back from the police station. K.D. said to Mr. Anthony that she was freaked out about what happened, she asked why Mr. Anthony touched her breasts and what made it all right to put his hand on her vagina and why he would do that. Mr. Anthony had said that had never happened before and he would take back what happened if he could. Mr. Anthony promised he would not touch her vagina or breasts if she came back for a 4th visit.

K.D. made a complaint to the massage board of what happened on the 3rd visit because she received a notice in the mail from the police that they would not be proceeding with

Mr. Anthony said very near, on it.

Mr. Duskey asked what else is right there

Mr. Anthony said Vagina

Mr. Duskey did you say that during the police report that you wouldn't do that again Mr. Anthony said I don't recall saying that. I agreed to portions of the statement by

agreeing to the entire statement. Clients have emotional responses to a massage. Mr. Anthony said he got mixed signals since she didn't say anything during the massage.

Mr. Ortega asked that the police phone conversation when Mr Anthony apologized for touching vagina and breasts if it was not correct?

Mr. Anthony said they were taken out of context.

Mr. Duskey asked if the sheet was ever fixed

Mr. Anthony said he adjusted the draping

Ms. Pruetz asked if Mr. Anthony touched her breasts

Mr. Anthony said he never touched with any sexual intent.

Mr. Duskey asked did you touch areola

Mr. Anthony said no

Mr. Duskey quoted "If there was any contact made it was unintentional"

Mr. Anthony said at the time she moved she bucked her hips and moved.

Mr. Duskey asked did you ask permission before you touched there

Mr. Anthony said no

Mr. Anthony said that he can't say for certain what was touched at the time.

K.D. said on this progressed for one or two minutes from inner thigh to labia to vagina AG Ms. Campbell asked Mr. Anthony if he had anything he would like to say. Mr. Anthony said no, other than he takes his job seriously with the highest level of professionalism. Ms. Bowman asked K.D. when he was touching your breast where was he standing or sitting.
