# Is this proof humans have TELEPATHIC powers? Two men, 4,600 miles apart, send messages to each other using just their minds

With a blindfold covering his eyes, and earplugs cancelling out almost all sound, Dr Michel Berg sat in a state-of-the-art laboratory at the University of Strasbourg in north-eastern France, and began to think.

Nearly 5,000 miles away, at a research facility in the Indian city of Kerala, a young Spanish man called Dr Alejandro Riera pulled on a tightly fitting hat, placed a laptop computer on a white table, and also began to think.

Over the course of the next hour, on March 28 this year, the 51-year-old Dr Berg and his faraway counterpart would attempt something that had only previously occurred in the exotic realms of science fiction.

The two men aimed to send a simple message between each other, across the continents, without using any of the five senses that human beings - and indeed animals - have for millennia used to communicate.

They instead hoped to achieve what scientists call 'mind-to-mind direct technological communication' - and the rest of us would recognise by a single, tantalising word: telepathy.

The experiment in speaking via 'thought' happened in conditions of absolute secrecy. Until recently, only a small team numbering a dozen researchers (including Dr Berg and Dr Riera) were even aware of its existence.

That all changed a few days ago, however, when PLOS ONE, a website little known outside academia, published a peer-reviewed scientific paper detailing its outcome.

The report is lengthy and jargon-ridden. But to a layman, its findings seem little short of sensational. For on that afternoon in March, Dr Berg and Dr Riera were indeed able to achieve 'conscious brain-to-brain communication'.



Brave New World: Dr Berg believes that in the coming decades their research could be used to help stroke victims, extreme paraplegics, and sufferers of 'locked-in syndrome' to speak and move again.

This, in layman's terms, means they carried out the first scientifically documented telepathic conversation in human history.

The exchange was nothing if not brief. The duo shared just two words: the Spanish greeting 'hola', and the Italian 'ciao'.

Yet what it might have lacked in colour and complexity, it surely made up for in potential historic importance.

'We have shown that it is possible to send a mental message between two people, without using sight, touch, sound, taste or smell,' Dr Berg told me yesterday.

'This is of course early days, but the discovery could eventually have a profound impact on civilisation.'

The possibilities of telepathy are, indeed, endless.ble: keeping your thoughts to yourself is about to get a whole lot harder.

## Homeland Security Chairman: 'U.S. now on high alert as anniversary of 9/11 nears'

#### "Al-Qaeda likes to pick anniversaries"

Michael McCaul, Homeland Security Chairman, said recently that the U.S. is on "a higher state of alert" as the anniversary of 9/11 approaches in the coming days dovetailing with other reports claiming that ISIS is determined to attack within the U.S..

An excerpt from the Daily Caller reveals McCaul's fears and may even give insight on what is to come:

On Tuesday of this week (Aug. 26), Israel officially stopped adding fluoride to its water supplies. The decision has "been lauded by various rights groups, but criticized by many in the medical and dental communities as a serious mistake," as the Times of Israel put it.

The tasteless, colorless chemical is put into water for the purpose of reducing cavities, but critics say that it amounts to mass medication, and forces people to consume the substance whether they want to or not.

By law, fluoride had been added to public drinking water supplies of large Israeli towns since the 1970s, and until this week about 70 percent of the country was fluoridated. (For comparison, 67 percent of Americans receive fluoridated tap

Health Minister Yael German announced last year that she planned to end the practice, but faced a wave of backlash. Undeterred, she said earlier this month that she had nevertheless decided to end the process effective Aug. 26, and to not even allow optional fluoridation in communities that support it.

While water fluoridation is not practiced in most of Europe or most countries worldwide, it has become widespread in the United States, Canada, Ireland, New Zealand and Australia, and a few others. It remains contentious where it is practiced, especially outside of the United States; however, fluoridation was recently voted against in Portland, Ore. and Wichita, Kan., and controversy has flared up in major cities like Milwaukee and Cincinnati.

One major open question is what constitutes a safe dose of fluoride. Supporters say the small amount put into water is safe, but opponents of the process point out that once the chemical is put into water, its dose cannot be easily controlled or monitored since people drink widely varying amounts of water and have different body weights and ability to process the mineral.

At high levels, fluoride can cause pitted teeth, bone defects and thyroid problems; a study in the medical journal The Lancet earlier this year labeled fluoride a developmental neurotoxin

Patriot Act's absurd new spawn: Just when you thought it couldn't get any worse

Creative legal interpretations may now enable the government to sign off on things that will blow your mind

Congress may be preparing to reinforce two horrible FISA Court decisions and an abusive government search with no debate in the coming weeks: a decision to give national security orders unlimited breadth, one making it legal for the government to investigate Americans for activities protected under the First Amendment, and the FBI's "back door" searches of Americans'

#### communication content collected under the FISA Amendment Act Section 702 authority.

On Tuesday, the ACLU and the Department of Justice argued about the legality of the NSA's phone dragnet program before the 2nd Circuit Court of Appeals in New York. Much of the discussion focused on the implications of the government's theories that it can collect all phone records in the United States based on a claim they are "relevant" to standing terrorism investigations. "You can collect everything there is to know about everybody and have it all in one big government cloud," said Judge Gerard Lynch, describing the implications of the government's theories to Assistant Attorney General Stuart Delery.

But the ACLU and the government also engaged in an equally important debate — on whether the FISA Court's interpretation of the word "relevant" overstepped Congress' intent – focused on whether Congress had backed FISC's definition of "relevant" by reauthorizing the Patriot Act twice.

The executive branch and the FISA Court have spent the last 15 months arguing that Congress "ratified" the expansive interpretations on which the phone dragnet program relies when it reauthorized the Patriot Act in 2010 and 2011 because, having been informed of the program, Congress extended the Patriot Act without changing that language. "When Congress reenacts a statute without change," the administration said in a white paper on the phone dragnet in August 2013, "it is presumed to have adopted the administrative or judicial interpretation of the statute if it is aware of the interpretation." Three federal judges have bought that claim, relying on it to rule the program is legal.

The government's claim with regards to past authorizations is terribly weak. There were at least six known instances where Congress did not get notice it should have; in several cases, those obligations were imposed by law. Perhaps the most important – in which House Intelligence Committee chairman Mike Rogers did not invite most congressmen to read notice of the dragnet provided to Congress in 2011 – means that 65 of the people who voted to reauthorize the Patriot Act in 2011 probably had had no way of learning about the phone dragnet. And, as the ACLU's Alexander Abdo pointed out in Tuesday's hearing, Congress *couldn't have* been briefed on the legal analysis underlying the phone dragnet because the FISA Court never got around to writing an opinion on it until 2013, in response to the Snowden leaks.

The executive's claim that Congress "ratified" the phone dragnet before the Snowden leaks — and therefore that the program currently complies with the intent of Congress — is farcical. And the judges on the panel — in addition to Lynch, fellow Democratic appointees Robert Sack and Vernon Broderick — seem skeptical of the government's claim that secret briefings offered about an unannounced program can support a claim that Congress knowingly ratified the program.

So the government's argument that the program is legal because Congress reauthorized the Patriot Act after the government started secretly using it to collect most phone records in the U.S. may fail to persuade the 2nd Circuit.

But that won't be true going forward.

The government's public release of numerous court opinions and other intelligence information over the last 15 months means no one in Congress can make a credible claim to be uninformed of the decisions underlying these parts of the government's spying. In 2011, most members of Congress probably didn't know the FISC had redefined the word "relevant" in a key Patriot Act definition to mean "everything," but they should know that now. Yet none of the current proposals to reform the dragnet do anything about the definition of "relevant." They limit collection of phone records in other ways, but would permit bulky collection under that "relevance" standard in a number of ways and by association using a number of statutes.

Thus, while the 2nd Circuit might rule the current dragnet illegal in part because the legal logic of it would permit the government to "collect everything there is to know about everybody," if Congress passes the USA Freedom Act without changing that definition of "relevant," it will be easier for the government to win this argument in the future.

Congressional passage of the USA Freedom Act with the existing language intact would also probably "ratify" two other intelligence community programs: first, a more recently released decision, a February 2013 opinion in which Judge John Bates ruled that prohibitions on using the Patriot Act to investigate Americans based solely on First Amendment-protected activities – such as political speech or religion — do not apply if associates of the targeted person are engaged in unprotected activities. Bates took language from Congress prohibiting the government from using Patriot authorities against Americans for nothing more than their speech and created a loophole allowing the government to do just that.

As Stanford law professor Jennifer Granick said in a post on this opinion, "Most people, when they cite [the] statutory language [from the Patriot Act], believe it means that Americans won't be subjects of terrorism investigations for the First Amendment protected things they say or do." But based on what we can see of Bates' opinion, Granick continued, "They would be wrong."

And while the language of the opinion pertains to a terrorism investigation, the novel interpretation of the phrase might now apply in other uses of Patriot authorities, such as counterintelligence investigations, which sometimes includes hacking or leak investigations. Behind a veil of secrecy, Bates and the government appear to have made it OK to investigate Americans for their free speech again.

In addition, the government has revealed the FBI conducts "back door" searches — warrantless searches on U.S. persons' data collected under FISA Section 702 — even for "assessments" of counterterrorism investigations. The FBI keeps no records of such searches, presumably because it dictated for itself in 2011 it need not keep any records of assessments. As a result, it refuses to tell Congress how many Americans have been subjected to such warrantless searches.

In a letter released Wednesday, Director of National Intelligence James Clapper seemed to point to back door searches. He hailed Sen. Leahy's version of the USA Freedom Act because it "recognize[s] the technical limitations on our ability to report certain types of information." The big topic the bill limited was FBI searches of 702 information. That suggests Clapper is pointing to Leahy's exemption for FBI's back door searches.

That would be particularly troubling given that back door searches are one area of particularly acute constitutional concern.

And if Congress doesn't do anything about these issues, in the future the government will argue - more credibly, this time - that Congress signed off on these expansions of Executive authority.

Whether by passing USA Freedom Act this fall or by reauthorizing the Patriot Act next June, Congress is likely to extend the life of the Patriot Act. Given the absurd implications of some of the recently released FISC opinions, Congress would do well to redefine this language to reclaim the plain English meaning, contrary to FISC's reinterpretations of it. Thus far, however, they show no sign of doing so.

On Feb 9, 2012 David Wilcock published his interview with Neil Keenan.

MY INTERVIEW WITH NEIL KEENAN AND KEITH SCOTTAfter I interviewed Fulford and gave a detailed but flawed critique of the lawsuit, Neil Keenan and Keith Scott contacted me. I wanted to get to the bottom of the story. I had many questions. I have not censored any of their answers.

I found their answers fascinating, and it dramatically increased my understanding of the underlying issues. Some of the highlighted key points are given in the right-hand panel for comparison with the facts contained in the Cease & Desist Order issued by Dr Seno to Keenan & co. on 7th Oct. 2012. (left hand panel).

The centre panel is Keenan & Scott's own Cease & Desist order to UBS and BIS dated May 14, 2012. Keenan's lies are very obvious if you refer back to what he said in the Feb 9, 2012 interview with David Wilcock.

Briefly, Keenan confirmed Dr. Edy Seno Soekanto was the legal heir to the referred Soekarno Trust ( aka Soekarno Family Heritage aka Soekarno papers aka Amanah Assets). In that interview, Keenan lied that Dr Seno had turned over the Trust to Keith Scott, Keenan & a 3rd person (now known as Drs Stanley P.D. Hoop). Keenan confirms it in his dodgy C&D dated May14, 2012. The difference (from the Feb interview) is person who signed over the Full Power of Attorney for the Amanah Papers.

Instead of Dr Edy Seno Soekanto, it was Mr. Bayu Soekarno Putra. Also note that Mr. Bayu claimed to be the Chairman, the appointed head and Authorised Officer of the Amanah Papers. Mr. Bayu signed over the power of attorney to Keenan & co allegedly on 30th day of Jan, 2012. That was well before the David Wilcock interview published on Feb 9, 2012.

Doesn't that sound confusing? Not if Keenan lied. In that interview, Keenan was confident he would get Dr Edy Seno to hand over the Amanah Papers or did he lie? Obviously, Dr. Edy Seno was the "first choice". But when Keenan was rejected by Dr Edy Seno, he fell back to an "easier meat". Otherwise he would have named Mr. Bayu as the legitimate heir. See the twist?

Of course the date of handover (Power of Attorney) could easily be changed (back dated to Jan 30, 2012). Keenan had so many lies, he obviously forgot to cover all the ground. Further, if he had already secure the Power of Attorney on Jan 30, 2012, why did he wait 3.5 months to issue the C&D order to the banks? Isn't time of the essence? 


