1. Call Board Meeting to Order

Chairman Reed called the meeting order at 7:00 a.m. This meeting is being held virtually and it is being streamed live through EIPH's YouTube channel. EIPH staff is present at the Idaho Falls office where there is also a space for the public to view in person.

2. Approval of the January 14, 2021 and January 25, 2021 Board of Health Minutes

MOTION: Commissioner Mendenhall made a motion to approve the January 14, 2021 and January 25, 2021 meeting minutes.

SECOND: Commissioner Young

ACTION: MOTION CARRIED UNANIMOUSLY

3. Reports from Regional Healthcare Partners

a. Eastern Idaho Regional Medical Center (EIRMC)

David Hoffenberg, Chief Operating Officer, reports that while things are getting better, most cases are going to the larger facilities. EIRMC currently has 14 COVID inpatients, 3 are in the ICU. They are still facing staffing challenges in the ICU and PCU. He also reported that 95% of EIRMC staff has taken the vaccine, with second doses being completed this week. EIRMC is making plans on how to incorporate a permanent COVID unit at their facility.

b. Idaho Falls Community Hospital

Casey Jackman, Chief Operating Officer, was not available this morning but provided Ms. Rackow with an update. They currently have 7 COVID inpatients, 1 in the ICU on a ventilator. They are finishing up with providing vaccine to staff and also assisted in administering vaccines to Bonneville Joint School District 93's teachers and staff.

c. Madison Memorial Hospital

Dr. Rachel Gonzales, Chief Executive Officer, reports that while things are slowing down, we should stay diligent in efforts to keep the numbers down. Going forward they are planning on how to care for COVID patients on an ongoing basis. They have an 80% vaccine uptake rate at their facility and are finishing up the administration of the last of their second doses.

4. COVID-19 Situational Report

a. COVID-19 Data Review

- Mr. Corbett reviewed the Data Dashboard. We currently have 368 active cases and 26 hospitalizations in our District. Cases have been slightly higher this week than in the previous two-week period.
- Ms. Rackow reported that Governor Little move the state to Stage 3 on Tuesday. Gatherings went from 10 people to 50 people. Healthcare clinics are exempt from the mass gathering limitations. The exemption was extended for other gatherings over 50 but will require the completion of a Large

Gathering Plan Attestation and submitted to the appropriate Health District. The plan does not need approval of the Health District.

b. Vaccination Rollout Update

- On February 1, people 65 and older became eligible to receive the vaccine. On Saturday, January 30, EIPH had a plan in place to allow this group to either call in or go online at 9:00 a.m. to schedule one of 2,000 appointments. The response was overwhelming and within 20 minutes all the appointments were filled. While many were glad to get appointments, many more were anxious, frustrated, and confused with the process. EIPH quickly revamped its appointment scheduling plan to make the process easier going forward, especially for the senior population. An overview of the new process was shared. There are approximately 40 providers in our Health District providing the vaccine; the list of providers is available on EIPH's website.
- Through the Federal Pharmacy Partnership, Idaho received additional vaccine due to the inability of pharmacies to full fill their contractual obligations. The additional doses will be allocated across the state. This additional vaccine allocation allowed EIPH to provide additional doses for Teton and Lemhi Counties at their regularly scheduled clinics as well as schedule two new mass vaccination clinics—one in Bonneville County for Bonneville and Jefferson County residents and the second in Madison County for Madison and Fremont County residents.
- Ms. Gamett provided updated information on two additional vaccine trials and provided an update on how the clinics have been going. EIPH has given over 7,000 first and second doses. They have hired additional staff and are using many volunteers at the clinics.
- Mr. Corbett provided information regarding the logistical challenges faced by the Preparedness Team in managing the allocation of vaccine to providers. They work with partners daily to distribute vaccine equitably through our district. The team also works to coordinate volunteers and secure venues for clinics.

c. Budget Request for Additional Vaccine Rollout Support

Ms. Rackow reports that EIPH will be utilizing grant funds, insurance reimbursement for the administration of the vaccine, and subgrant funds received through the Department of Health and Welfare to help with the increased costs of staffing and operating costs. She estimates the total amount needed for additional staffing is estimated to be \$350,000. These changes will likely require a budget adjustment at a future meeting.

5. Discussion and Vote Regarding Rescinding Orders of Restriction in Bonneville, Custer, Jefferson, and Madison Counties

- Custer and Jefferson Counties have been under the threshold of 15/10,000 cases for 14 consecutive days and could be moved to the Minimal Risk level.
- Bonneville County, if they continue on their downward trend under the threshold of 15/10,000 will be eligible to move to the Minimal Risk level on February 8, 2021.
- Discussion followed.
- Ms. Rackow reviewed the Draft Order of Restrictions and stated that even though we are moving in a positive direction and may begin lifting orders, it is still the recommendation from Public Health that face coverings be worn when physical distancing from people outside of one's immediate household members cannot be maintained.

MOTION: Commissioner Young made a motion to lift the Orders of Restriction for Custer and Jefferson Counties and move them to the Minimal Risk level and move Bonneville County to the Minimal Risk level, on February 8, 2021, if they meet the 14-day criteria.

SECOND: Commissioner Shenton

ACTION: MOTION CARRIED.

6. Legislative Update

Bill Leake, Ms. Rackow, and Chairman Reed traveled to Boise last week for presentations to the Legislature on the role of Public Health in Idaho. They were also able to meet with the Governor, Lieutenant Governor, senior leadership at the Health and Welfare Committees for the Senate and the House, and many other representatives to provide information and answer questions.

Mr. Leake reviewed the following legislation:

- A bill will be introduced this afternoon at 3:00 p.m. to address overall powers and authority of the Boards of Health.
- House Bill 33 - Review of any Health Board actions by the appropriate Board of County Commissioners.
- House Bill 67 and 68 - These bills are going to show that the only authority to close schools is the School Boards or Governor. The Board of Health, cities, and Department of Health and Welfare would not be able to close schools and universities.
- House Bill 63 – Prohibits the mandate of vaccinations.

7. Announcements

- EIPH has received the affirmative votes from the majority of the County Commissioners for the appointments of Commissioner Leah Madsen and Commissioner Blair Dance.
- Public Health Districts will be presenting their FY2022 Budget to the Legislature's Joint Finance and Appropriations Committee on Monday, February 15, 2021. This will be a virtual meeting and Ms. Rackow will be the spokesperson for the Public Health Districts presentation.
- Ms. Rackow sadly announced the passing of Southeastern Idaho Public Health Chairman and Trustee and former Power County Commissioner, Ken Estep. He committed a lot of years to the support of Public Health.

Chairman Reed adjourned the meeting at 8:28 a.m. The next meeting will be held on March 4, 2021 at 7:00 a.m.

IN JULY 2020, IDAHO'S RESPONSE to the COVID-19 pandemic transitioned from a statewide response to a regional response, and the following plan was developed by the Board of Eastern Idaho Public Health (EIPH). The plan is applicable to the following counties within EIPH's region: Bonneville, Clark, Custer, Fremont, Jefferson, Lemhi, Madison, and Teton.

As outlined in Idaho Code §39-414(2), Idaho's public health districts shall "do all things required for the preservation and protection of the public health and preventive health..." The ultimate goal of this plan is to slow the spread of COVID-19 (a new highly infectious communicable disease), to protect public health, and to ensure during the COVID-19 pandemic that healthcare capacity is maintained for ALL patients needing care—not just COVID-19 patients. Furthermore, we want to minimize the impact to our economy, our children's education, and individuals' physical and mental health as much as possible while still protecting public health. EIPH's Board of Health and Director will be responsible for the implementation of this plan.

This plan will not be in effect indefinitely; however, it is not possible to determine the exact length of time it will be needed. The risk assessment and mitigation strategies included in the plan will be in effect until a COVID-19 vaccine is readily available to the public, treatment options for COVID-19 are readily available, other mitigating factors currently not known are identified—OR until the plan is modified or rescinded by the Board of Health.

THIS PLAN IS A FLUID DOCUMENT AND SUBJECT TO CHANGE AS MORE INFORMATION BECOMES AVAILABLE.

WHAT TO KNOW ABOUT EIPH'S COVID-19 RISK LEVELS:

- The risk levels may be applied at county, geographic, or regional level.
Different parts of EIPH's region may be at different risk levels.
- In **ALL** risk levels, practice everyday preventive measures (see page 3)
- **MOVEMENT BETWEEN LEVELS**
 - Advancement to a higher risk level can occur any time the identified rates of active cases exceeds a designated threshold for three consecutive days (see page 2)
 - Reversal to lower risk level can occur when a county has been below a metric's threshold for the most recent consecutive 14-day period.
 - ~~A county's Board of Health member may request on behalf of the respective Commissioners that a public health order issued by EIPH's Board of Health remain in effect until a time certain.~~
 - EIPH officials will be in close communication and collaboration with elected officials of local jurisdictions within the region. It is important to note that local elected officials have the authority to implement their own more restrictive measures to do what they feel is necessary to protect the public health of the residents within their jurisdictions.
- ~~In addition to metrics determining exposure risk, public health officials will also be closely monitoring and take into consideration the following for movement to a different risk level:~~
 - ~~Input from our healthcare partners prior to data being available for decision-making~~
 - ~~Effectiveness of contact tracing~~
 - ~~Trends in COVID-19 testing, including positivity rate and turnaround time of test results~~
 - ~~Supplies of Personal Protective Equipment (PPE) for healthcare providers/first responders~~

HOSPITALIZATIONS ARE THE FOUNDATION OF THIS PLAN. The goal of the plan’s public health mitigation measures and recommendations is to slow the spread of COVID-19 in order to *protect individuals* and to *maintain healthcare capacity* in our region. The Risk Levels are based on the number of hospitalizations that we would expect to result from the positive cases of COVID-19. EIPH continually monitors the COVID-19 hospitalization rate for our eight-county district, which is reported on the Data Dashboard on our website (www.EIPH.Idaho.gov). Obviously, the higher number of cases, the more hospitalizations that will occur, putting stress on our hospitals’ ability to maintain capacity—not just physical bed capacity, but more importantly, healthcare personnel to care for the patients.

ACTIVE CASE RATES of COVID-19 are used to establish the Risk Levels in this plan. An active case is:

A confirmed or probable case of COVID-19 that is currently being monitored by EIPH. A case is considered infectious during the monitoring period, which is generally 10 days from onset of COVID-19 symptoms.

- **Confirmed Case:** A person with a positive laboratory test result for SARS-CoV-2, the virus that causes COVID-19, using a molecular amplification (PCR, NAA) technique.
- **Probable Case:**
 - ⇒ A person with a positive laboratory test result for SARS-CoV-2 (COVID-19) using a non-molecular amplification (antigen) technique OR
 - ⇒ A person who develops symptoms after being in close contact with a confirmed or probable case without being tested using a molecular amplification (PCR, NAA) technique.

For situational awareness, EIPH reports daily case counts of COVID-19, the number of active cases and rate by county, and much more on our website.

While EIPH's mitigation measures do not change between these three risk levels, it is important for us to provide situational awareness to the public regarding the level of community spread of the virus so individuals can make informed decisions for themselves and their families.

Everyone is asked to follow these everyday preventive measures to keep themselves safe and minimize the spread of COVID-19:

- Stay home if you are sick
- Wash hands frequently for at least 20 seconds or use hand sanitizer
- Maintain physical distance of at least 6 feet from others outside of your immediate family/household members whenever possible
- Wear face coverings that fully cover the nose and mouth in public when physical distancing is not possible or is hard to maintain. **This is important because one can be infected with the virus and spread it to others for up to two days before symptoms begin.**
- Carefully monitor your health (refer to [EIPH's COVID-19 Decision Tree](#) for more info)
- Seek a COVID-19 vaccine when it becomes available to you.
- If you are diagnosed with COVID-19, please follow recommendations from EIPH and the [Centers for Disease Control and Prevention](#) (CDC) for isolating during your infectious period (10 days from symptom onset). If you have close contact (within 6 feet for more than 15 minutes) with someone who has tested positive for COVID-19, you should quarantine for **10-14** days from your last close contact with them **OR 7 days with a negative COVID-19 test conducted after day 5 of exposure** unless you are fully vaccinated against COVID-19 in accordance with [current CDC guidance](#).



In addition, as risk levels increase, EIPH recommends the following:

- ~~○ Stay home if you are sick.~~
- ~~○ Wash hands frequently for at least 20 seconds or use hand sanitizer.~~
- ~~○ Maintain physical distance of at least 6 feet from others (outside of immediate family/household) whenever possible.~~
- ~~○ If you are diagnosed with COVID-19, follow public health recommendations for isolating during your infectious period (10 days from symptom onset). If you have close contact (within 6 feet for more than 15 minutes) with someone who has tested positive for COVID-19, you should quarantine for 10-14 days from your last close contact with them. This to prevent the spread of the virus.~~
- Follow the Public Health Order* (*which carries the force of law, Idaho Code 39-419*) issued for your County (**please review your respective county's Order in its entirety found at www.EIPH.Idaho.gov**), which includes:
 - ~~○ Face coverings that fully cover the nose and mouth are required to be worn in public places when physical distancing is not possible or is hard to maintain.~~
 - ~~○ Social gatherings and events, both public and private, are restricted to a maximum occupancy in the venue that provides for _____ approximately 28 square feet per person based on the area patrons and gathering/event staff, participants, and/or performers will be situated for the gathering/event. This is to allow for physical distancing of attendees.~~
- Schools should implement their School Board-approved plans for the various levels of community transmission.
- Hospitals should implement their contingency plans for handling an increased volume of hospitalizations.
- High-risk populations (older adults and people with underlying health conditions) and those caring for high-risk populations should take extra measures to protect themselves from the virus (see page 4).
- Consider other public health recommendations to minimize your exposure to COVID-19 (see page 4).
- EIPH will continue to work with local community leaders (elected officials, school officials, law enforcement, businesses, and other stakeholders) on enhanced mitigation strategies and education needs for their respective jurisdictions.

If the COVID-19 Pandemic reaches a critical level in EIPH's region:

- The EIPH Board of Health may recommend/implement other measures based on specific situation(s) occurring within a respective county, a region, or the entire health district.

***In the event that multiple Public Health Orders are in effect at one time (for example, a statewide order and a local public health order), the most restrictive guidelines should be followed unless exemptions are allowed.**

PUBLIC HEALTH RECOMMENDATIONS FOR SPECIFIC POPULATIONS/ACTIVITIES

HIGH-RISK POPULATIONS

Individuals at higher risk of severe illness with COVID-19 include older adults and people of any age with:

- Chronic lung, heart, kidney, or liver disease or someone who smokes
- Obesity, diabetes, hypertension, or high blood pressure
- Immunocompromised conditions
- Pregnancy

In addition to always following the key preventive measures of maintaining physical distance from others, wearing a face covering, and increased hand hygiene, take extra precautions to protect yourself, especially as the level of community transmission increases.

- Limit close physical interaction with other people, especially if they are sick.
- Make sure you have an adequate supply of food, medication, and other essential items. Use curbside and delivery services to minimize close contact with others.
- Maintain social connections with your loved ones from a distance or while taking extra precautions.
- If you live alone, seek out a “buddy” who can check on you and help provide support if needed.
- Avoid large gatherings of all types and being in crowds.
- Do not postpone seeking medical care for any of your health conditions. And, if you contract COVID-19, seek appropriate medical care early.

BUSINESSES

- Ensure physical distancing as much as possible between: employees; employees and customers; and customers (rearrange seating) from other groups.
- Where feasible, provide teleworking opportunities for high-risk staff or if physical distancing between staff cannot be maintained.
- Require masks of employees and customers.
- Consider special business hours for high-risk individuals.
- Provide opportunities for increased hand hygiene for employees/customers.
- Increase cleaning/sanitizing of your facility.
- Provide contactless service where possible (curbside and delivery services, payment options, etc.).
- Provide signage, announcements, and physical markings to promote physical distancing and other protective measures.
- Implement policies that encourage employees to stay home when sick.
- Work with EIPH when you have a positive case or an exposure in your business (208-533-3219).

CONGREGATE LIVING FACILITIES

This include nursing homes, assisted living facilities, correctional facilities, homeless shelters, and other shared housing facilities:

- Closely monitor health of all staff and residents. Ensure staff who are sick **DO NOT WORK** until COVID-19 is ruled out.
- Encourage staff to follow all public health recommendations outside of work.
- Consider 14-day quarantine for new residents to the facility per CDC guidelines.
- Cohort staff and residents as much as possible.
- Ensure physical distancing occurs as much as possible.
- Consider requiring staff to wear masks at all times while working inside the building.
- Use outdoor space as much as possible.
- High-risk staff should not have close contact with residents who have suspected or confirmed COVID-19, if possible.
- When residents temporarily leave the facility, follow public health recommendations for masking and physical distancing from others to prevent any possible exposure.
- Increase testing (screening and surveillance) as much as possible, in accordance with respective regulatory authority guidelines.
- Ensure plans are in place to handle an outbreak in the facility.
- Increase communication to residents and staff regarding policies, protective measures being implemented, and contingency plans.
- As risk levels increase, consider limiting visitors to the facility as well as residents leaving the facility to prevent possible exposures to residents.

TRAVEL

- Prior to travel, evaluate the COVID-19 risk level at your planned destination. Two good sources are: <https://globalepidemics.org/key-metrics-for-covid-suppression/> and <https://www.cdc.gov/coronavirus/2019-ncov/travelers/travel-during-covid19.html>. Also, check for any travel restrictions involving your destination.
- Do not travel if you are sick.
- During your trip, follow public health recommendations of maintaining physical distance between you and others, wear a face covering, wash your hands frequently, and avoid contact with anyone who is sick.
- As community transmission of COVID-19 increases, consider minimizing non-essential travel.
- Employers may consider asking employee to quarantine for 14-days following travel to minimize risk of exposure in the workplace.

GATHERINGS/SOCIAL EVENTS

Small gatherings of extended family members/friends are a primary source of spread of COVID-19, likely due to people feeling more comfortable in these more intimate settings and relaxing public health precautions.

- Do not attend any gathering if you are sick.
- Practice physical distancing from all individuals outside your household.
- Wear a face covering when you cannot physical distance.

ORDER OF THE DISTRICT BOARD OF HEALTH EASTERN IDAHO PUBLIC HEALTH, STATE OF IDAHO

ORDER OF RESTRICTION: MARCH 4, 2021

Employers, Businesses, and Individuals in **BONNEVILLE COUNTY**

THE DISTRICT BOARD OF EASTERN IDAHO PUBLIC HEALTH HEREBY FINDS AND DECLARES AS FOLLOWS:

According to the Centers for Disease Control and Prevention (CDC), the virus that causes Coronavirus 2019 Disease (“COVID-19”) is easily transmitted from person-to-person through respiratory droplets produced when an infected person coughs, sneezes, talks, or raises their voice (e.g., while shouting, chanting, or singing). These droplets can land in the mouths or noses of people who are nearby or possibly be inhaled into the lungs.

The CDC reports that recent studies show that a significant portion of individuals with COVID-19 lack symptoms (are “asymptomatic”) and that even those who eventually develop symptoms (are “pre-symptomatic”) can transmit the virus to others before showing symptoms.
