As part of the CARES ACT funding that ASPPB received during 2020, and in hopes of increasing access to mental health care services via telepsychology, ASPPB is extending the E. Passport application fee (\$400) waiver until January 31, 2021. Please note that you only need to have initiated the E.Passport application by January 31, 2021 to take advantage of the \$400.00 fee waiver. REGULATORY ACTIONS CURRENTLY UNDERWAY

Unprofessional conduct/conversion therapy

The Board intends to specify in section 150 that the standard of practice requiring licensed psychologists to "avoid harming patients or clients, research participants, students and others for whom they provide professional services and minimize harm when it is foreseeable and unavoidable" includes the provision of conversion therapy and to define what conversion therapy is and is not. The goal is to align regulations of the Board with the stated policy and ethics for the profession. The provision bans conversion therapy on minors.

The Board will vote on Final Regulations at its February 9, 2021 meeting.

Periodic Review of the Regulations Governing the Practice of Psychology

The Board completed a Periodic Review of its Regulations Governing the Practice of Psychology. The Board recommended aspects of the Regulations to repeal and/or amend to provide consistency and clarity, reduce the regulatory hurdle for licensure by endorsement, increase the opportunities for continuing education credits, specify a timeframe within which an applicant must have passed the national examination, and simplify the requirement for individual supervision within a residency. The Board also recommended accreditation by the American Psychology Association (APA) and the Canadian Psychology Association (CPA), or an accrediting body acceptable to the Board, be a requirement for all psychology doctoral degree programs within seven years of the regulatory changes becoming final. Finally, the Board recommended revamping the standards of practice to emphasize rules for professionalism, confidentiality, client records, and prohibitions on dual relationships.


The Regulations are at the Final Stage and under review by the Office of the Governor.



Periodic Review of the Regulations Governing the Certification of Sex Offender
Treatment Providers
As a result of a periodic review, the Board made amendments by: 1) Clarifying and updating requirements and language consistent with current practice;
2) Eliminating the need for reference letters with an application, and substituting a report from the National Practitioner Data Bank and verification of any licenses issued by other Boards;
 3) Providing for acceptance of supervised experience obtained in another state; 4) Adding an allowance for exceptions or exemptions for continuing education requirements; and,
5) Expanding the standards of practice and grounds for disciplinary action for consistency with other Boards and professions.
The Department of Planning and Budget is currently reviewing these regulations for Fast-Track Authorization.
COVID-19 ACTIONS The Board took a number of actions to help students and licensees during the pandemic. The Board granted a one-year extension to complete any required Continuing Education (CE) to all licensees. The Board requires licensees to complete the 2020 CE requirements as well as the 2021 requirements by the June 30, 2021 renewal.
Please note that regardless of the COVID-19 actions, not all continuing education courses must be face-to-face. At least six of the required hours must be earned in face-to-face or real-time interactive educational experiences. Real-time interactive includes a course in which the learner has the opportunity to interact with the presenter during the time of the presentation. The Board considers Zoom, WebEx, or any video conferencing platforms real-time interactive educational experience.
Pursuant to Governor Northam's Executive Order 57, the Board issued accelerated temporary licenses to clinical psychologists with an active license issued by another state. The Board issued 577 of these licenses with a 1-2 day turn-around. Those temporary licenses expired on September 8, 2020.
Health care practitioners with an active license issued by another state may provide continuity of care through telehealth services to their current patients who are Virginia residents. However, if they want to acquire new patients, or if the Governor rescinds Executive Order 57, they must apply for full licensure in Virginia. If you are a Virginia licensee and want to provide clinical services to clients in another state, please check with the state in which the client resides to determine if that state allows you practice without a license.

As you know, Virginia law requires that all individuals licensed to practice one of the healing arts to immediately report concerns of suspected child abuse and neglect. The Virginia Department of Social Services' (VDSS) Division of Family Services (DFS) has developed a new Mandated Reporter Portal, which provides a streamlined and easily accessible way for Mandated Reporters in Virginia to submit reports of suspected abuse and neglect. Data from the Mandated Reporter Portal securely transmits the information to VDSS hotline staff for review. You can access the Portal at <u>https://vacps.dss.virginia.gov/</u>. Healthcare Workforce Data Center

The Department of Health Professions Healthcare Workforce Data Center (HWDC) works to improve the data collection and measurement of Virginia's healthcare workforce through regular assessment of workforce supply and demand issues among the 80 professions and 350,000 practitioners licensed in Virginia by DHP.

Health Practitioners' Monitoring Program (HPMP)

The Virginia Health Practitioners' Monitoring Program (HPMP) is an alternative to disciplinary action for qualified healthcare practitioners with a substance use diagnosis, a mental health or physical diagnosis that may alter their ability to



practice their profession safely. HPMP refers healthcare professionals for appropriate treatment and provides ongoing monitoring of treatment progress.
The goal for each participant is to assist and support the recovery process, including achieving and maintaining optimal physical, mental, and emotional health. The HPMP team has the expertise to help practitioners skillfully navigate their return to safe and productive clinical practice.
The Department of Health Professions (DHP) contracts with Virginia Commonwealth University Health System, Department of Psychiatry to provide services including: Intake to determine program eligibility; Referrals to providers for clinical assessment and treatment; Monitoring of treatment progress and clinical practice; and, Alcohol and drug toxicology screens when indicated.
Participation in the program is voluntary. A practitioner may avoid disciplinary action and, in the absence of criminal behavioral or Board action, avoid the generation of a public record. For those participants with Board involvement, our team provides support including participant preparation for hearings and providing the Board with documentation or testimony of monitoring compliance.
 HPMP services are available to anyone who: holds a current, active license, certification or registration by a health regulatory board in Virginia, Holds a multi-state licensure privilege, Is an applicant for initial or reinstatement of licensure, certification, or registration for up to one year from the date of receipt of the application.
