**WHEREAS**, the Borough of Glen Rock has entered into an agreement with Enterprise Fleet Management to lease police vehicles under the Sourcewell, formerly NJPA, government purchasing agreement, in order replace the Police Department's aging and high maintenance vehicles in a more cost-effective manner; *and* 

**WHEREAS**, Enterprise's vehicle disposal program represents one their long term competitive advantages with 700+ dedicated remarketing employees that sell over one million vehicles in each fiscal year – their sole job is to maximize the value of a vehicle at the end of its life cycle. In 2017 Enterprise Fleet having sold over 54,000 customer owned (i.e. non-leased) vehicles at an average of 107.8% over the Black Book Commercial Index. Selling vehicles significantly better than what the wholesale market calls for lowering the total cost of ownership and reducing leasing cost for new vehicles; *and*

WHEREAS, the Borough of Glen Rock has municipal pool complex that requires various improvements and repairs; and

The capital budget is hereby amended to conform with the provisions of the capital ordinance to the extent of any inconsistency therewith.

This Ordinance shall take effect immediately upon passage and publication as required by law.
