Samaritan Shares Blueprint for Comprehensive Cancer Care

Fighting cancer takes advanced technology and advanced thinking, but it also takes bricks and mortar. On May 31st, Samaritan Medical Center held a town meeting to share with the community its plans for a new comprehensive cancer center, which will house cancer services and physician specialists in a single convenient location designed with patients in mind. Cancer survivors and area residents were in attendance for a look at architectural renderings of the plans and to find out why Samaritan decided to pursue the project.

More than just a building...

"A building by itself is just a shell," explains Robert Johnson, MD, a thoracic surgeon and Chair of the Samaritan Cancer Committee. "What we're creating is more than that. It's a tremendous undertaking. We're creating a comprehensive cancer care program and building a facility specially designed to contain it."

Samaritan's new cancer care program has been in the making since its Board of Trustees adopted an updated strategic plan in January 2015. Based on a regional assessment of cancer care needs that was conducted in January 2014, the recommendation was made to establish a comprehensive oncology service line that would position Samaritan to meet those needs.

Striving for accreditation...

Part of establishing this new program is to achieve accreditation by the Commission on Cancer, a consortium of professional organizations dedicated to improving survival and quality of life for cancer patients through standard-setting, which promotes cancer prevention, research, education and monitoring of comprehensive quality care.

"Achieving Commission on Cancer accreditation will allow Samaritan to demonstrate to our community that we have invested in systems to ensure that cancer patients receive high quality, coordinated care, as well as making the commitment to

ensure that supportive services and resources addressing the full continuum of care are available in our community," says Jim Steggeman, Director of Oncology at Samaritan.

For patients, it means the assurance that Samaritan is dedicated to a full continuum of cancer care, including:

- Quality cancer care, close to home
- Comprehensive care offering a range of services and technology
- A multidisciplinary team approach to coordinate the best cancer treatment options available
- Access to cancer-related information and education
- Access to patient-centered services, such as psychosocial distress screening and navigation
- Options for genetic assessment and counseling and palliative care services
- Assessment of treatment planning based on evidence-based national treatment guidelines
- Information about clinical trials and new treatment options
- Follow-up care at the completion of treatment, including a survivorship plan

To achieve Commission on Cancer accreditation, each cancer program must undergo a rigorous evaluation and review of its performance and compliance with the standards. To maintain accreditation, Samaritan will undergo an on-site survey review every three years.

The modern design of the new comprehensive cancer care center features abundant natural light, easy and convenient accessibility to staff and supportive services and a calm, healing environment.

In addition to clinical exam and office space, this new 28,000 square foot, two-story facility will also offer space for:

- Covered, dedicated entrance
- Counseling and Supportive Care resource center/library, patient navigation services, social workers, complimentary palliative care
- Chemotherapy/ infusion area eighteen comfortable stations featuring reclining chairs, seating for family members, televisions and a view to the outside rooftop green space
- Appearance Center retail sales for oncology patient-specific clothing, headwear, skin care products, wigs and breast prosthetics
- Medical conference, education and meeting rooms

Samaritan's new comprehensive cancer care center is expected to open in late 2017.

Newly Renovated Acute Rehabilitation Unit to Open Soon

Samaritan's Acute (Inpatient) Rehabilitation Unit (ARU) is currently being transformed as part of "Phase IV" of the Medical Center's on-going renovations. (See full story on page 5.) The new unit will include 12 private rooms with enough space to accommodate family members, an expanded therapy gym and a full apartment where patients will stay in order to gain confidence in their daily living activities before returning home. Watch for news of an Open House event once renovations are complete tentatively late summer/early fall!

After an unexpected injury, debilitating disease or complicated surgery, you can come home again with help from Samaritan Medical Center's Acute (Inpatient) Rehabilitation Unit (ARU). The ARU combines 24-hour nursing care; physical, speech and occupational therapy; and a full-time physician who specializes in rehabilitation – making it easy to stay close to family and friends while also receiving expert care.

"Our Acute Rehabilitation Unit is designed for people who were living and functioning independently and now, for whatever reason, may be experiencing difficulty walking; with balance or coordination; bathing, eating or performing other activities of daily living; or with speech or swallowing," explains Aaron Naklick, Case Coordinator.

Samaritan's ARU, formerly known as Physical Medicine & Rehabilitation (PM&R) cares for patients who have suffered a stroke, head injury, spinal cord injury, joint replacement, complicated fracture, amputation or certain other medical conditions that result in debilitation or weakness. Some patients receive their initial medical treatment at Samaritan Medical Center. Others are transferred to Samaritan from other hospitals once their condition is stable and they are ready for therapy.

"Samaritan Medical Center offers the only acute rehabilitation unit in Northern New York," says Mr. Naklick. "It's a very specialized service not available in all hospitals. The nearest comparable services are as far away as Syracuse, Utica and Burlington, Vermont."

"Patients who receive their initial medical treatment at other hospitals should know that they can ask to be sent to Samaritan for their rehabilitation care," he adds. "An acute rehabilitation stay can range from one to three weeks, depending on the severity of the illness or injury. Being closer to home helps the patient to relax,



while his or her loved ones avoid frequent long drives, busy city traffic and the expense of travel and parking."

From the first day, patients and family work with the rehabilitation team to set goals, create a treatment plan and begin working toward discharge.

"Our team approach offers a variety of rehabilitation options that can be tailored to the patient's needs," says Paula Lidestri, MD, a Board-certified Physical Medicine & Rehabilitation specialist and Medical Director of the ARU. "Since each patient who comes to Samaritan is a unique individual, their rehabilitation program should be, too."

"We're proud to share that 90% of our patients return to their homes after rehabilitation," Dr. Lidestri adds. "That's higher than the national average of 77%."

Samaritan's ARU accepts patients who have a medical reason to be in the hospital for rehabilitation, require 24-hour nursing care and close medical supervision by a physician who specializes in rehabilitation, are able to participate in a minimum of three hours of therapy at least five days a week, and require at least two different kinds of therapy – physical, occupational and/or speech.



Renovations Continue to Transform Samaritan Medical Center

Ten years ago, Samaritan Medical Center (SMC) kicked off a period of growth unprecedented in its long history. Since then, the main campus has been transformed through the addition of the parking garage, the four-story patient pavilion, and the Macsherry Connector that links SMC and Samaritan Keep Home. Renovations have also been on-going within the walls of the Pratt Building of SMC as we modernize that facility to continue meeting the growing healthcare needs of our community.

Recent years have seen the opening of a newly renovated Rehabilitation Services Department and a new Chapel on the first floor of the Pratt building. Changes have also occurred on the 5-Pratt Medical/Surgical Unit, which was converted to private patient rooms.

Work is now underway on what is referred to as "Phase IV" of these on-going renovations. This phase will address SMC's remaining areas most in need of modernization. The areas slated for expansion and/or renovation include:

Maternity (Labor/Delivery, Recovery & Post-Partum) **Pediatrics Inpatient Mental Health** Acute Rehabilitation

Radiology Medical Staff Services **Support Services** (Shipping/Receiving, Storeroom, etc.)

One of the most visible changes from a patient perspective will be the new **Center for Women** & Children. The Maternity and Pediatrics departments, currently located on separate floors, will be situated on one floor in order to provide an environment that appeals to the needs of both women and children. A separate parking lot and new, dedicated entrance will lead patients and visitors to a relaxing, spa-like environment featuring soothing colors, nature themes and abundant natural light. The Center for Women & Children will include:

Labor and Delivery

- Increasing from six to eight labor/delivery rooms, each with its own Jacuzzi tub
- Rooms large enough to accommodate family members who are present for the birth
- Adding a second operating room to accommodate Cesearian-section births

Post-Partum

• In this area where moms and babies go after the delivery until they go home, the room and furniture will be designed with the family in mind. Medical equipment is tucked away behind wood panels, with space is dedicated for personal belongings and flowers.

Pediatrics

- Bright, child-friendly colors and a "virtual" playroom to appeal to young patients
- Rooms will feature chalk/white boards for drawing and gaming capabilities

Other planned changes include:

Inpatient Mental Health:

The outdated institutional environment on this unit will be transformed to one that considers the unique healing needs of our patients in a calmer, warmer environment. In addition to an increase in beds from 32 to 34, the programming and activity space will feature enhancements for the patients and staff.

Acute (Inpatient) Rehabilitation Unit (ARU):

As part of the renovations, this unit will grow from the six shared rooms that exist today to twelve private rooms with enough space to accommodate family members. An expanded gym within the unit will make additional equipment available as part of the patient's therapy, including stairs, walking bars and even a car simulator to ensure that the road to recovery is traveled safely.

Prior to their discharge, patients will stay in a full apartment within the unit in order to gain confidence in their daily living activities once they return home. A living room, kitchen, bedroom and bathroom will enable the patient to test the skills and adaptive techniques learned during their rehabilitative stay. Renovations are expected to be complete within the next 3-5 years.

Over 1,700 babies are born at Samaritan Medical Center each year. That gives us more than 1,700 reasons to proudly announce that Samaritan is one of the first hospitals designated as a Blue Distinction Center for Maternity Care by Excellus BlueCross BlueShield. This national designation recognizes hospitals that consistently demonstrate expertise in delivering quality maternity care safely and effectively, and we¹re honored to be one of them!

The Blue Distinction Centers for Maternity Care program evaluates hospitals on several quality measures, including the percentage of newborns that fall into the category of early elective delivery, an ongoing concern in the medical community. Compared with babies born 39 weeks or later, early term infants face higher risks of infant death and respiratory ailments, such as respiratory distress syndrome, pneumonia, and respiratory failure, among other conditions.

In addition, hospitals that receive a Blue Distinction Center for Maternity Care designation have agreed to meet requirements that align with principles that support evidence-based practices of care, as well as having initiated programs to promote successful breastfeeding. The program also evaluates hospitals on overall patient satisfaction, including a willingness to recommend the hospital to others.



"We understand what matters most to patients at Samaritan Medical Center is the quality and safety of the care they receive. That is why we have made it a top priority to improve positive patient outcomes through evidence-based care processes," explains Mario F. Victoria, MD, Chief Medical Officer for Samaritan. The Top Performer program recognizes hospitals for improving performance on evidence-based interventions that increase the chances of healthy outcomes for patients with certain conditions. 

The renovation and expansion of the Family Health Center at Adams is now complete. The project, which started in 2015, included a 5,200 square foot addition to the existing building as well as renovations to the existing space. The building is now home to the Samaritan Family Health Center, a new Samaritan imaging/lab center that offers mammography, bone density testing, x-ray, ultrasound and lab draw services, and a separate Urgent Care Center operated by Dr. Collins Kellogg.

Making House Calls

Samaritan Home Health brings medical care to you.

From skilled nursing to rehabilitation to IV therapies and more, Samaritan Home Health provides professional care that aids recovery, keeps older individuals independent and helps those newly diagnosed with a chronic condition cope. All with the goal of keeping you right where you want to be: at home.

In January, Samaritan

acquired Genesis Home Health Agency - now known as Samaritan Home Health (SHH). The former Genesis Agency had been operating under a management contract with Samaritan since early 2014.

"By adding a certified home health agency (CHHA) to our continuum of healthcare services, Samaritan is working to help manage the overall health of our community," explains Nicole Davis, RN, Director of Patient Services/Administrator of SHH. "Care from the Samaritan Home Health team can often help prevent hospitalizations or reduce the need for nursing home placement. It enables patients who are homebound or not one hundred percent recovered from an injury or illness to receive medical treatment right in the comfort and familiarity of their own homes."

Samaritan Home Health is certified to care for patients throughout Jefferson County. Patients must be under a physician's care, receive a referral and have a health condition

that requires skilled nursing and/or physical therapy. Those who would benefit from home health services often include individuals who have recently been diagnosed with a chronic condition (diabetes, congestive heart failure, chronic obstructive pulmonary disease (COPD), etc.) and need to learn how to manage their disease at home; individuals who are still recovering from a hospitalization and need additional care; or individuals who have an on-going health need (home IV therapy, wound care, etc).

Once your doctor has established a need, SHH will send an experienced registered nurse (RN) to visit you and develop a plan of care and schedule of visits. The nurse will teach you and your family members the best way to help in your recovery while providing the specialized nursing care that you need. The nurse will also arrange for any additional help you may need, such as a physical therapist, occupational therapist, speech therapist, nutritionist, home health aide or medical social worker. Your care team will meet weekly to discuss your progress and will keep your doctor informed of any changes in your condition.

Once you are under our care, a SHH registered nurse is available 24 hours a day, seven days a week for emergency calls. The nurse will advise you over the telephone or send a member of the SHH team to visit your home if necessary.

"This is a care option that people need to be aware of," shares Mrs. Davis. "Research confirms that there really is no place like home for patients to recover ... where they are most relaxed, following their treatment plan, and supported by family members, loved ones and Samaritan Home Health."

Samaritan Respite Care

Whether you're going away on business, planning a vacation, or simply need a break from your duties as caregiver, Samaritan Summit Village's Respite Care program is the perfect solution for providing your loved one with the individualized care he or she needs.

The Respite Care program provides two levels of care -Assisted Living and Skilled Nursing. Assisted Living guests enjoy a fully furnished one bedroom apartment, three meals a day, and laundry and housekeeping services, plus experienced staff members who are available to offer personal assistance with daily needs. Skilled Nursing guests receive a semi-private room, all meals, and 24hour nursing care. All Respite Care guests experience the same amenities available to permanent residents at Summit Village, and may also participate in any of the social, educational, devotional and recreation activities scheduled daily for residents.

The Samaritan Respite Care program is private pay with a one-week minimum stay. Pre-registration is required. Skilled Nursing guests must have a medical screening before their stay and must have a local primary care provider. For more information, call 315-782-7033.

If you've been a patient at Samaritan Medical Center within the past year, you may choose to self-enroll in the hospital portal using a link on MySamaritanHealth. com. Please remember that your e-mail address must already be on file at the hospital for you to self-enroll. If you did not provide your e-mail address during the patient registration process, please call the Health Information Management (HIM) Department at 315-785-4099, Monday-Friday. 7:00 a.m. - 3:00 p.m. and provide your e-mail address. It will be added to your account information, and you can then self-enroll at your convenience.

If you did provide an email address to our staff, you may already be enrolled. There is no need to self-enroll again. Contact our HIM Department for password resets or for help in logging into the portal.

When you visit MySamaritanHealth.com to self-enroll, you will need to provide your first and last name, date of birth, medical record number or the last four digits of your social security number, and a valid email address that matches the one Samaritan has on file. Your medical record number can be found on your discharge paperwork; it is the seven-digit number following M. Once you have successfully enrolled, a onetime use ID, password and additional instructions will be emailed to you.



Patients at the Samaritan Family Health Centers and the Samaritan specialty clinics also have access to a patient portal through MySamaritanHealth.com. Simply contact the office and speak to a representative about enrolling in that specific portal.

Healing Begins at the Samaritan Wound Care Center

About eight years ago, Boonville resident Steven Denslow developed a blister on his left foot. "No big deal," you might think, "It'll heal quickly." But what if it didn't?

While most wounds do heal on their own, Mr. Denslow soon found himself one of the eight million Americans suffering from a chronic wound. The blister eventually became an open sore, with the circumference of a soda can. After another doctor told him that nothing could be done and that his foot would need to be amputated, Mr. Denslow heard about Dr. James Stillerman.

"Think about a wound. It hurts. It aches. It limits your mobility. A wound that doesn't heal changes your whole life," says Mr. Denslow. "Dr. Stillerman changed my life again. His knowledge and experience saved my foot!"

After first encouraging Mr. Denslow to lose weight to help with the recovery process, Dr. Stillerman performed a skin graft in September 2013. After a week in the hospital and four months at home with no walking, Mr. Denslow began regular wound care appointments. Approximately two years later, his foot ulcer was healed.

"When Dr. Stillerman told me that he was joining the staff at Samaritan Medical Center and helping to open a new wound care center in Watertown, I didn't even think twice about following him to his new location to complete my care," says Mr. Denslow. "I would recommend the Samaritan Wound Care Center and Dr. Stillerman to anyone with a wound that won't heal."
