




Example of Changing Paths in Job Advancement


Certification means that an individual has:

Re-Certification Requirements

- Recertification required every 3 years
 - CBPP[®] 60 hours of continuing professional education activities required
 - CBPA[®] 30 hours of continuing professional education activities required
- Or retake test
 - Some example activities
 - Courses, Training, Seminars
 - Professional association events
 - Writing, Presenting, Teaching


