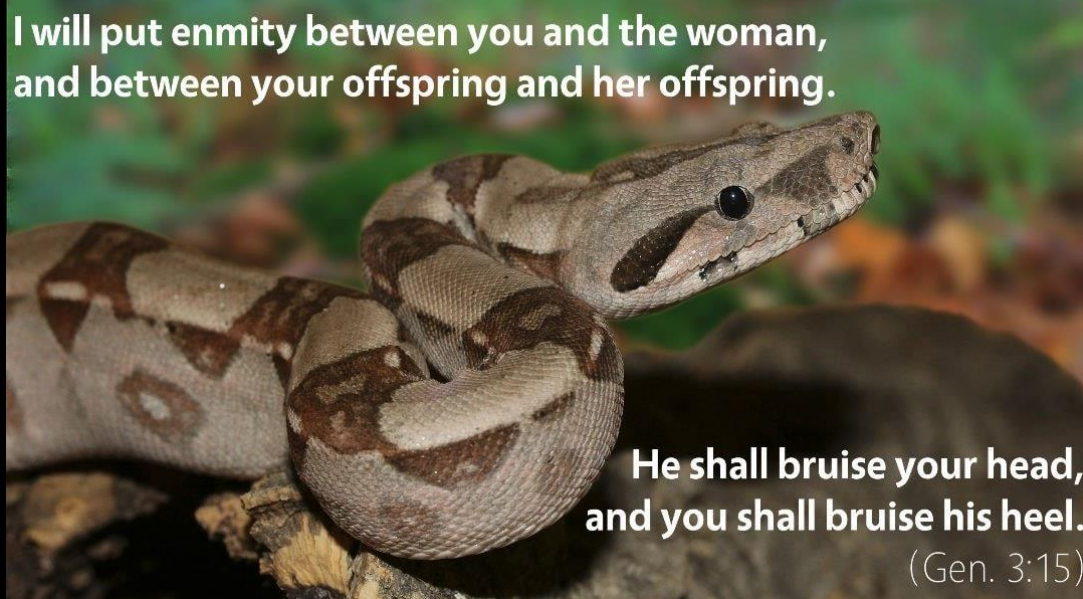

“Genesis, 3:15 I will put enmity between you and the woman, and between your offspring and hers; he will strike your head, and you will strike his heel”

Firstly, we have to do with two different seeds: On the one hand the offspring of Satan and on the other hand the offspring of Eve. And, as the rest of the verse states: Eve exclaims, «I have gotten a man from the LORD» (Gen. 4:1 KJV). But, according to the New Jerusalem Translation, however, the verse translates from the Hebrew just a little differently: ...I have gotten a man from an angel of the LORD.

Jewish Zohar is more specific about that:

“After Adam and his wife sinned, and the serpent had intercourse with Eve and injected filth into her, Eve bore Cain. He had the shape from above and from below (the earth)... Therefore, he was the first to bring death into the world, caused by his side, as he came from the filth of the serpent. The nature of the serpent is to lurk, so as to kill, and his issue, Cain, learned his ways”

– Zohar Pekudei 21 (The Zohar, Volume 13, Pekudei, Section 21. Breastplate and Efod, 203)

“...the members of the mixed multitude are the children of the primordial serpent that seduced Chavah (Eve) by the tree of knowledge, so the mixed multitude is indeed the impurity that the serpent injected into Chavah. From this impurity, which is considered the mixed multitude, Kayin (Cain) came forth and slew Hevel (Abel)...”

– Zohar 2 Beresheet A28 (The Zohar, Volume 1, Beresheet A, Section 28. Hevel-Moshe, 285)

Entering now into the Christian religious texts, the Gospel of Phillip and the New Testament tell us same things:

“First, adultery came into being, afterward murder. And he (Cain) was begotten in adultery, for he was the child of the Serpent. So he became a murderer, just like his father, and he killed his brother. Indeed, every act of sexual intercourse which has occurred between those unlike one another is adultery”

– The Gospel of Philip

1 John 3, 12 Not as Cain, who was of that wicked one, and slew his brother. And wherefore slew he him? Because his own works were evil, and his brother’s righteous.



After the flood of Noah now, we still reading about Giants on Earth:

“And there we saw the giants, the sons of Anak (i.e. the Anakim), which come of the giants (i.e. the Nephilim): and we were in their sight as grasshoppers...”

– Num. 13:33 (KJV)

The union between the Devil and the woman was the sin of mongrelization, race mixing, and the fruit of that sin was a mongrel devil named Cain. It should be further noted that Cain had children (Genesis 4:17-22), and they were later known as the Canaanites, the children of the devil. The Giants rescue now from that flood, cleared from the follow religious texts:

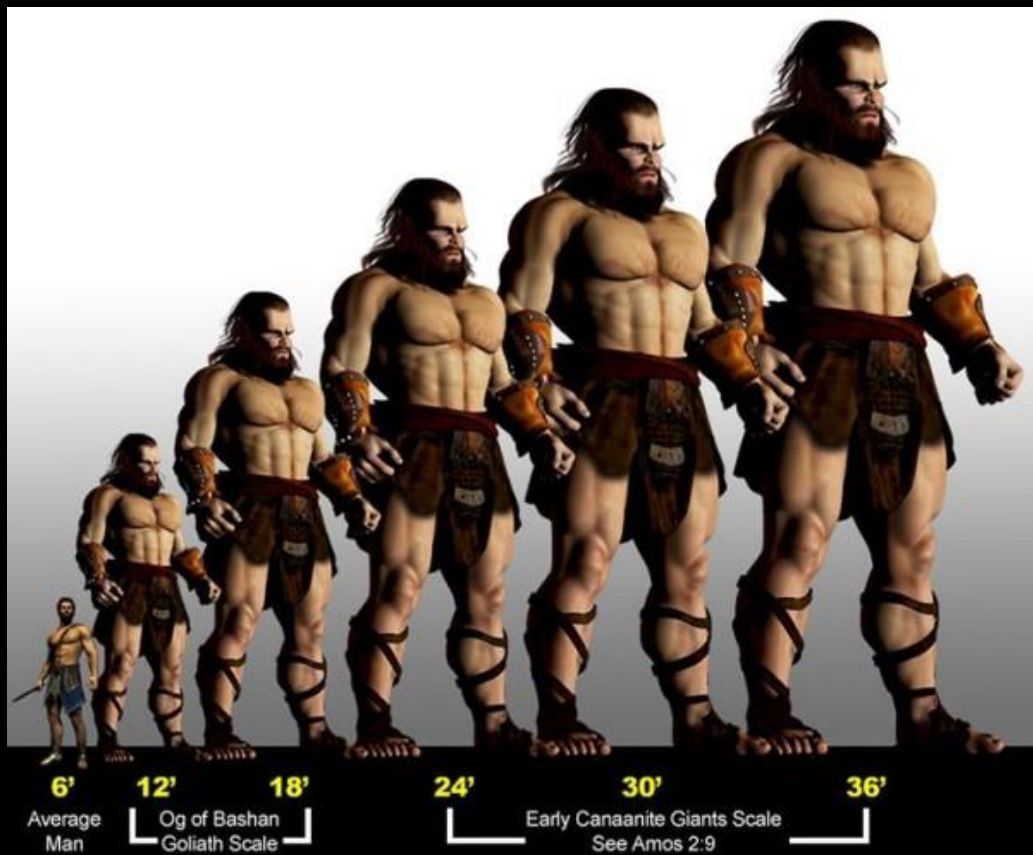
“There are many kinds among Israel that are called cattle and beasts...the side of idolatrous nations, who are like animals and wild beasts”

Gen. 7:13 In the selfsame day entered Noah, and Shem, and Ham, and Japheth, the sons of Noah, and Noah’s wife, and the three wives of his sons with them, into the ark; 14 They, and every beast (i.e. Chay) of the Field after his kind, and all he cattle (i.e. Bahemah) after their kind, and every creeping thing (i.e. Remes) that Creepeth on the earth after his kind, and every fowl (i.e. Owph) of

the Air after his kind, every bird of every sort. 15
And they went in unto Noah into the ark... wherein
is the breath of life.

NOTE: Traditionally, people thought this referred to Noah, and the groupings of animals aboard the ark. We notice, however, that the verses mention the Owph (fowl) of the Air and the birds separately. Why? If the two names both stood for birds only, then why separate the two? Why – unless the Fowl of the Air could have been a specific name for a group of individuals – another group of individuals that were not birds? The verses were already talking about Noah and his family in verse 13. Obviously, there were no other of the Adamite group mentioned; just the other four. Could verse 14 and 15 be just an extension of this list of human beings going aboard the ark. There could have been up to five groups of people on the earth at this time; beyond those of Adam. There could have been the Chay (beasts) of the Field, the Owph (fowl) of the Air, the Bahemah, the Remes (creeping thing) that Creepeth, as well as other Adamites.



“The Nephilim were on the earth in those days and afterward, when the sons of God went to the daughters of men and had children by them. They were heroes of old, men of renown”

– Genesis 6:4

Ancient DNA reveals that Biblical-era Philistines may have originated in Europe

(CNN) —

The Philistines were related to Europeans, according to DNA evidence in a study published Wednesday in the journal *Science Advances*.

Scientists looked at the genomes of 10 Bronze and Iron Age individuals from Ashkelon, which is on the Mediterranean Sea about 40 miles west of Jerusalem and which was known in ancient times as one of five cities of the Philistines.

The ancient group, immortalized in the Hebrew Bible, arrived in the area in the 12th century BC.

They found that the Philistines were genetically distinct from human remains from other ancient groups who lived in the area because they had a set of genes linked to Europeans.

“Of the available contemporaneous populations, we model the southern European gene pool as the best proxy for this incoming gene flow,” the scientists wrote in the study.

The Philistines may have had southern European ancestry

Comparing results from the earliest-available Philistines with DNA from later Iron Age remains in the area, the scientists found that the European genes did not continue. These early European immigrants into what is now Israel would have essentially been absorbed into the existing population and would not have had a longer-term effect on the genetic makeup of people in the area.

The Philistines are perhaps best-known as a group the Israelites were fighting in scenes depicted in the Book of Samuel. The Philistines sent out their great warrior Goliath, challenging the Israelites to put forth a fighter of their own so that the entire conflict would rest on the outcome of the duel.

A young Israelite volunteered and killed the giant using a sling, propelling a small lethal stone at Goliath's head.

So every time you talk about an underdog story as "David vs. Goliath," you're making a Philistine reference.

Results come from decades of archaeological work

In 2016, archaeologists announced that they had unearthed the first Philistine cemetery, calling it the culmination of three decades of work.

"This cemetery is going to teach us a whole lot about the Philistines that we've never known before," Daniel Master, a professor at Wheaton College and co-director of the expedition in Ashkelon, said at the time.

After 108 sets of skeletal remains were excavated, and 10 had enough DNA to be studied in depth.


Master is also a co-author on the latest study.

Over the years, scientists at the Ashkelon site have excavated Philistine houses and delved into what they would have eaten and who they would have traded with. The new study gives us the closest

look yet at the people themselves and sheds light on their unusual origins.

Scientists Claim Cro Magnon DNA Fully Modern, Unchanged for 28,000 Years

A Cro-Magnon DNA sequence 28,000 years old was obtained from fossil bones discovered in the Paglicci cave, in Italy. The results show that the DNA is identical to the DNA sequences of certain modern Europeans. The DNA sequence has remained static and unchanged over 28,000 years. This means that Cro Magnon was a fully modern individual who perhaps had a larger brain capacity. (1)

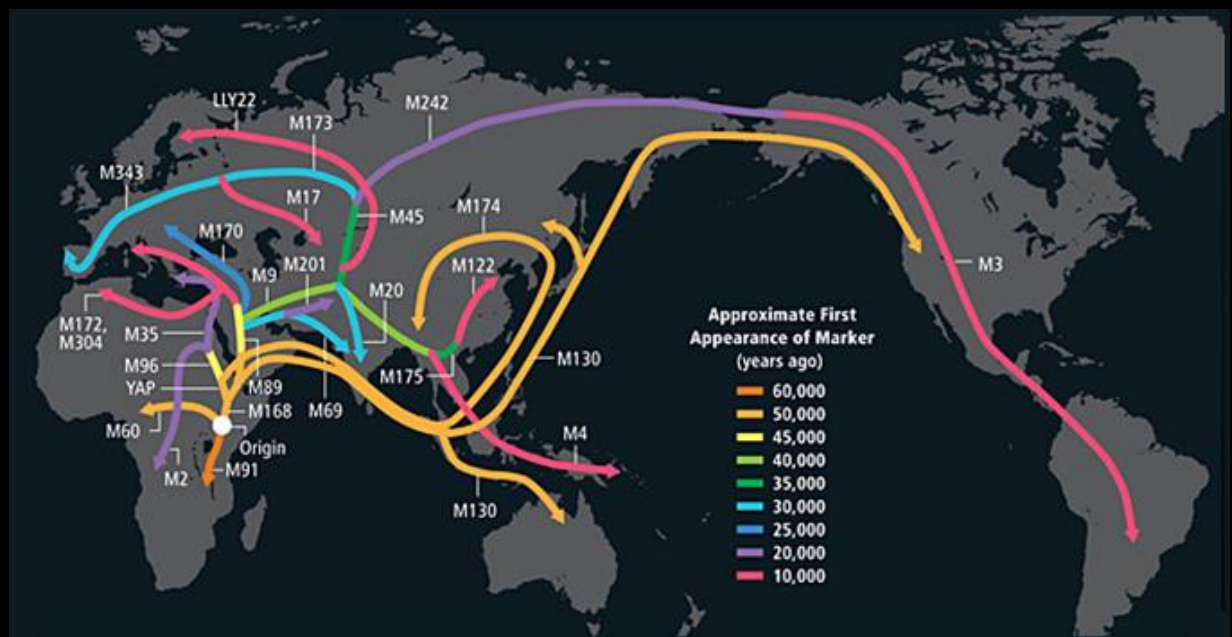
“Out of Africa” Theory Officially Debunked

Scientific evidence refuting the theory of modern humanity’s African genesis is common knowledge among those familiar with the most recent scientific papers on the human Genome, Mitochondrial DNA and Y-chromosomes.

Regrettably, within mainstream press and academia circles, there seems to be a conspicuous – and dare we say it – deliberate vacuum when it comes to

reporting news of these recent studies and their obvious implications.

Australian historian Greg Jefferys explains that, «The whole ‘Out of Africa’ myth has its roots in the mainstream academic campaign in the 1990’s to remove the concept of Race. When I did my degree they all spent a lot of time on the ‘Out of Africa’ thing but it’s been completely disproved by genetics. Mainstream still hold on to it.»



FRAUDULENT STORY

It did begin the early 90’s. And the academics most responsible for cementing both the Out-of Africa theory and the complementary common ancestral African mother – given the name of “Eve” – in the

public arena and nearly every curriculum, were Professors Alan C. Wilson and Rebecca L. Cann.

In their defense, the authors of this paper were fully aware that genealogy is not in any way linked to geography, and that their placement of Eve in Africa was an assumption, never an assertion.

A very recent paper on Y-chromosomes published in 2012, (Re-Examining the “Out of Africa” Theory and the Origin of Europeoids (Caucasians) in the Light of DNA Genealogy written by Anatole A. Klyosov and Igor L. Rozhanski) only confirms the denial of any African ancestry in non-Africans, and strongly supports the existence of a “common ancestor” who “would not necessarily be in Africa. In fact, it was never proven that he lived in Africa.”

Central to results of this extensive examination of haplogroups (7,556) was the absence of any African genes. So lacking was the sampling of African genetic involvement, the researchers stated in their introduction that, “the finding that the Europeoid haplogroups did not descend from “African” haplogroups A or B is supported by the fact that bearers of the Europeoid, as well as all non-African groups do not carry either SNI’s M91, P97, M31, P82, M23, M114, P262”.

With the haplogroups not present in any African genes and an absence of dozens of African genetic markers, it is very difficult nigh on impossible to sustain any link to Africa. The researchers are adamant that their extensive study “offers evidence to re-examine the validity of the Out-of-Africa concept”.

They see no genetic proof substantiating an African precedence in the Homo sapien tree, and maintain that “a more plausible interpretation might have been that both current Africans and non-Africans descended separately from a more ancient common ancestor, thus forming a proverbial fork”.

We regard the claim of “a more plausible explanation” as a gross understatement, since there is absolutely nothing plausibly African turning up in any test tubes. In fact, the researchers made note of their repeated absence stating “not one non-African participant out of more than 400 individuals in the Project tested positive to any of thirteen ‘African’ sub-clades of haplogroup A”. The only remaining uncertainty relates to the identity of this “more ancient common ancestor”. All that can be stated with confidence is that humanity’s ancestor did not reside in Africa.



Unfounded accusations of racism have become common as the prevailing Afrocentric hypothesis is constantly being challenged by the growing mountain of conflicting scientific evidence, especially in the evolving field of genetics.

It is now scientifically irrefutable fact that the «human species» has been found to contain a substantial quantity of DNA (at least 20%) from other hominid populations not classified as Homo sapien; such as Neanderthal, Denisovan, African archaic, Homo erectus, and now possibly even «Hobbit» (Homo floresiensis).

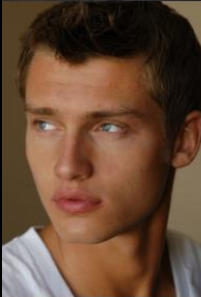

Are you descended from a Fallen Angel?

'The Sons of God saw the daughters of men were
fair,' it says in Chapter 6 of the Book of Genesis.

What happened next was perhaps inevitable.

'The Sons of God came in unto the daughters of
men,' Genesis continues. 'And the daughters of
men did bare children to them.'

God's trust had been betrayed. The offending angels were cast out, became known as the Nephilim, which is Hebrew for 'fallen'.

But what happened to the children born of a human mother and an angel father?

For answers, we have to turn to the Book of Enoch.

The Book of Enoch is an official part of the Bible only in certain Christian traditions, like the Ethiopian Orthodox Church.

But it describes in great detail how the Fallen Angels taught their wives and children, instructed them.

And for the first time, human beings had knowledge.

'Azazel taught them how to make swords,' the Book of Enoch says. 'Kokabiel taught astronomy, Penemuel instructed humans in the art of writing and reading...'

And because God believed all this knowledge was corrupting mankind, he sent the Great Flood.

Soon, humanity was washed away, along with the Nephilim and their children.

It would be up to Noah to start over again.

All of which sounds like a rather far-fetched story taken from books written thousands of years ago.

But what if it were true? And what if the Nephilim and their children survived the Flood somehow?

Chapter 10 of the Book of Genesis tells how the children of Noah's oldest son Japheth left the Holy Land and populated Northern Europe.

But some experts believe those weren't Japheth's children at all. They believe Japheth had been killed by a Nephilim who assumed his form and had children with his wife.

Which might sound even more far-fetched than before. Until you consider the evidence.

The Nephilim and their children were said to have a reddish tinge to the hair on their heads and their pubic hair, pale skin, hazel eyes, a tendency to high blood pressure and a higher than average IQ.

Sound like anyone you know?

It certainly might. And if you tick any of those boxes, you might be descended from a Fallen Angel.

But there's more... Scientists have identified a blood type that may well be the blood type of the Nephilim.

Rhesus Negative.

Blood types are broken into two groups. The first is a letter, A, B, AB and O. The second is the RH, or Rhesus Factor, which is positive or negative.

So, for example, the most common blood type in the world is O Positive.

Most people have a positive blood group. A, B, or AB positive. 85% of the world's population in fact.

So, what of the 15% with a negative blood type?

Scientists argue the Rhesus negative blood group originated in the Holy Land 35,000 years ago.

And it originated suddenly, like it was introduced to the human genetic code from an outside source.

Now, however, it's practically unknown in the native people of Israel, Jordan, Palestine and the Lebanon. It's practically unknown in most parts of the world.

Except Europe.

Most of the people with negative blood types live in Northern Europe.

Where Japheth's children settled.

About 40% of Northern Europeans have an RH-negative blood type.

And that means that approaching half of Northern Europeans could be descended from the Fallen Angels.

But were the Nephilim angels?

But so far-fetched it might just be believable.



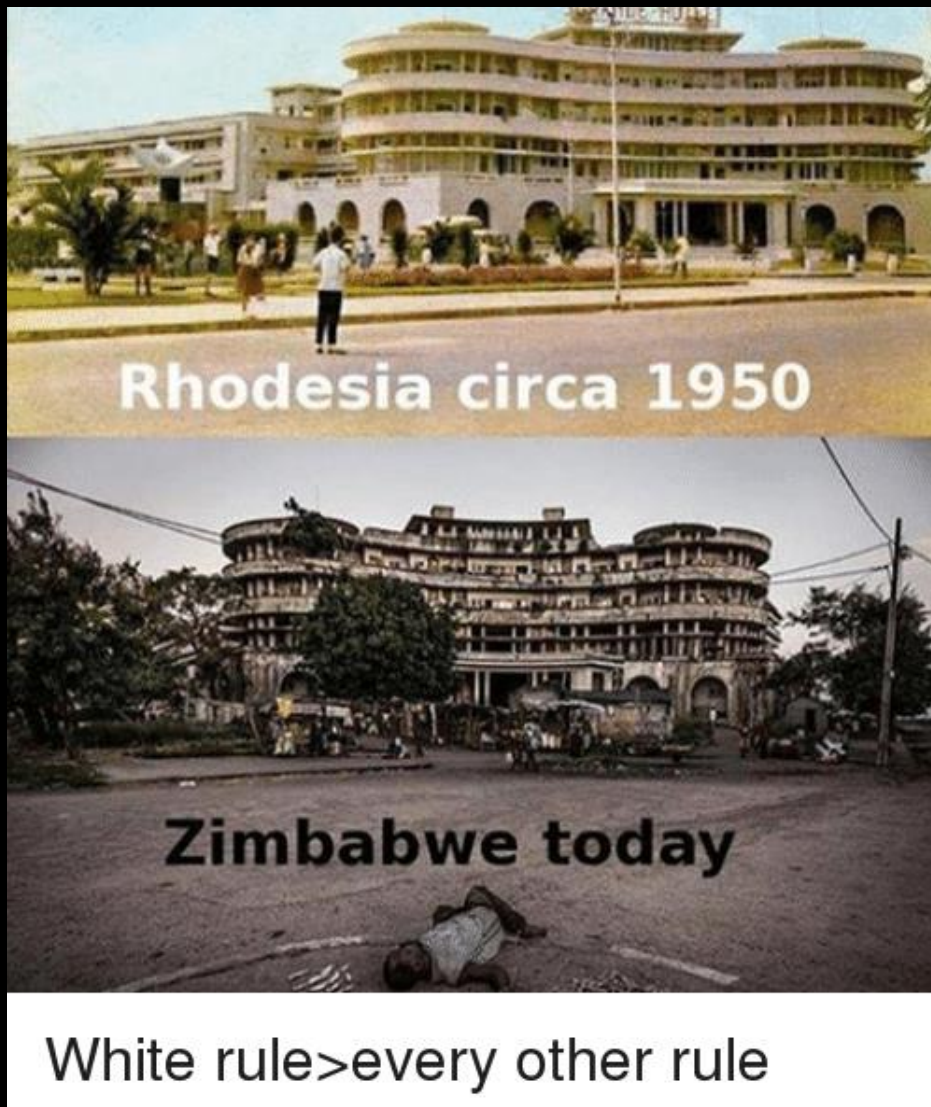

And I mean a real rebel, a real outlaw – someone who cuts a dash, who has charisma, whose very presence makes others uneasy (and who does not have to wear some stupid ‘costume’ to do this). Second – try something to see if you get away with it. If not – tough, you failed. There are plenty of others... If you succeed, try again, until you know your limits. Choose a good cause, or a bad one or no cause at all, and really live, intoxicating yourself with life, danger, achievement. Do not rest and never be afraid to face the possibility of death. But in all that you do be honourable – to yourself. Carry this honour

with you everywhere like a favourite concealed weapon.

Third, learn from your experience – like you would learn from a ‘bad’ woman (or man) in your youth when sex was still something of a mystery. A real Satanist does not often do magick – they are magick by the very nature of their dynamic, zestful existence. It is experience which teaches, from which you learn – you cannot learn Satanism from books (although some may guide you aright to begin with), it cannot be taught by ‘Masters’ and never involves cosy little discussions with ‘friends’ or others. Anyone who accepts a ‘Master’ and grovels before them – however slight that grovelling may be – is not a Satanist, just a sucker who sucks. Accepting some ‘authority’ is a sign you are weak: a sign you need emotional crutches: a sign you are a wimp.

So, get off your arse, you suckers, and make Satan proud. Learn to do evil.

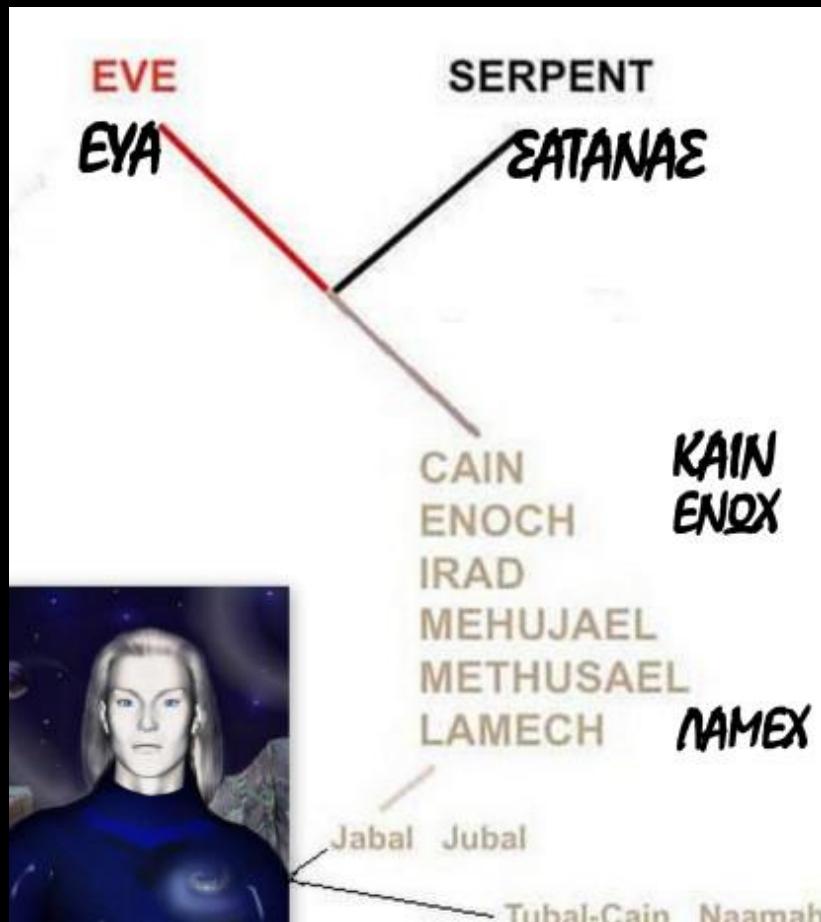
