

#### **AUGUST 2017**

- Authorized the Solana Beach Pump Station Design agreement amendment to add groundwater sampling, National Pollutant Discharge Elimination System (NPDES) Permitting Assistance, and Construction Bid Support with Dudek, for a total contract amount of \$287,810.
- Approved selecting Track 1 for implementation of the Trash Amendments to the Water Quality Control Plan for the Ocean Waters of California (Ocean Plan) and Part 1 Trash Provisions of the Water Quality Control Plan for Inland Surface Waters, Enclosed Bays, and Estuaries of California (ISWEBE Plan).
- Approved the submittal of a grant application to the County of San Diego for a Neighborhood Reinvestment Program grant for the La Colonia Skate Park.
- Authorized the issuance and sale by the Successor Agency of the Solana Beach Redevelopment Agency of tax allocation bonds to refund the outstanding Solana Beach Redevelopment Agency Tax Allocation Bonds, Series 2006, and reissuance of lower interest 2017 bonds.

#### SEPTEMBER 2017

- Awarded the 2017 Street Maintenance & Repair Project, Bid 2017-08, contract to PAL General Engineering, for the amount of \$344,290.
- Authorized an Automated Red-Light Photo Enforcement agreement with Redflex Traffic Systems.
- Awarded a Fire Apparatus Maintenance & Repair agreement to North County Emergency Vehicle Services for an amount not to exceed \$60,000.
- Approved the use of a Model License Agreement for Wireless Facilities on Vertical Infrastructure in the Public Rights-of-Way.
- Authorized submission of a list of projects to the California Transportation Commission for Road Maintenance Rehabilitation Account Funding, as required by Senate Bill 1.
- Authorized the Fiscal Year 2017-18 Community Grant Program application period for \$25,000.
- Authorized Phase 2 of the Lomas Santa Fe Corridor Feasibility Study, allowing for technical analysis of the data collected in Phase 1 of the Feasibility Study, and preparation of 30% preliminary engineering plans and cost estimates with an agreement amendment with STC Traffic, Inc. for the amount of \$65,000.
- Appointed Paul Basore to the Climate Action Commission with a term expiring January 2018.

- Established the Solana Beach-Del Mar Relations Council Standing Committee appointing Mayor Nichols and Councilmember Zito.
- Adopted Ordinance 480 providing an expedited, streamlined permitting process for Electric Vehicle Charging Systems.

#### OCTOBER 2017

- Authorized moving into Phases 2 (Program Launch) and Phase 3 (Operations) of Community Choice Aggregation (CCA) Development and Implementation.
- Discussed pedestrian and bicycle improvements to the Lomas Santa Fe/I-5 Interchange proposed by a design team consisting of Staff and CalTrans traffic engineers.
- Authorized a request for proposals for a preliminary design of the Marine Safety Center at Fletcher Cove Park
- Ratified an emergency contract for relocating a Storm Drain System at 473-521 Glencrest Drive.

#### **NOVEMBER 2017**

- Authorized the Sewer System Inflow Smoke Testing of the Eden Gardens area contract with Infrastructure Engineering (IEC), for the amount of \$24,805.
- Approved to neither accept nor decline Coastal Commission's suggested modifications to the Local Coastal Program (LCP) Land Use Plan (LUP) amendment and instead trigger the one-year extension to work with Coastal Staff to analyze the fee data, continue the collection the \$1,000 per linear foot interim fee, move forward with a geographical segmentation of the City, and proceed with preparing the LIP (Local Implementation Plan).
- Appointed Peter Lambrou to the View Assessment Commission with a term expiring January 2019.
- Adopted Ordinance 481 related to regulations for Wireless Communication Facilities.
- Authorized a communication to congress to pass the DREAM Act without amendment and provide DACA recipients with a pathway to permanent residence and eventually U.S. citizenship.
- Approved the Community Choice Aggregation Implementation Plan and Statement of Intent for submittal to the California Public Utilities Commissions (CPUC).
- Introduced Ordinance 483 to establish a Community Choice Aggregation Program.

## Planning Division Highlights

The State of California and local jurisdictions establish criteria for public review of many types of projects.

The following is an abbreviated list of the programs, projects, and proposals under consideration by the City of Solana Beach.

### Local Coastal Program

#### WHAT IS THE LCP?

The Local Coastal Program (LCP) is a coastal management plan mandated by the California Coastal Act of 1976. An LCP contains land use, development, public access, and resource protection policies and regulations that implement the Coastal Act at the local level. It is comprised of a Land Use Plan (LUP) and a Local Implementation Plan (LIP or IP). The City has its LUP and is now working on its IP. The City's approved LUP can be viewed online on the City's website and in person at the Community Development Department at the City of Solana Beach City Hall. Every local government in the coastal zone (61 cities and 15 counties) is required to prepare an LCP and submit it to the California Coastal Commission (CCC) for review and approval. The City is one of six coastal cities without a certified LCP, and the entire City of Solana Beach is located within the coastal zone.

#### WHY CERTIFY?

Currently, residents and business owners with projects requiring a discretionary permit must apply to and have their permits approved by the City and then apply as well to the Coastal Commission for approval. In most instances, certification of the City's LCP will allow the City to issue these permits.

Certification of the LCP means:

Solana Beach Control

Greater Accessibility to Staff

Faster Processing Time

Lower Permit Costs

After certification, the majority of permit applications would be processed by the City, instead of the CCC. In addition to the convenience of filing at Solana Beach City Hall, permit applications would be processed by your open and responsive Community Development Department staff, which means your application can be processed much faster. All this will translate into less time and lower application costs.

#### HOW WILL LCP CERTIFICATION AFFECT WHAT I CAN DO ON MY PROPERTY?

Most of the LCP content is taken from the City's Zoning Code. Therefore, land use, setbacks, height limits, floor area limits, off-street parking, and other development regulations will remain largely unchanged. For properties located along the bluffs, the development standards would be tied to the policies contained within the Certified LUP. Bluff top properties are within the "appealable" Coastal Development Permit (CDP) area subject to additional CCC review. The City is exploring the geographic segmentation of bluff-top properties from the rest of the City to move forward with the LIP for the remaining 95% of the area within the City.

If you have a project that requires a permit, the LCP will provide a set of procedures for obtaining a CDP from the City. Like the CCC, the City would ensure that the CDP is issued in conformance with the policies of the Coastal Act. Therefore, issues of land use, public access, and protection of resources will have to be addressed as appropriate for Solana Beach. (Bill Chopyk 720-2449)

#### Draft Public Recreation Impact Fee Study

The City Council approved the updated <u>Draft Public Recreation Impact Fee Study</u> and LUP Amendment with the adoption of Resolution 2016-039 on April 13, 2016. The Draft Fee Study and LUP Amendment was submitted to the California Coastal Commission on April 29, 2016. The Draft Fee Study and LUP Amendment are posted on the City website.

In conjunction with the ongoing Local Coastal Plan (LCP) certification process with the California Coastal Commission (CCC), the City agreed to partner with the CCC to update the 2010 Public Recreation/Land Lease Impact Mitigation Fee Study. The purpose of the land lease/recreation mitigation fee is to compensate the public for the loss of recreational use of the beach due to the installation of shoreline protective devices such as seawalls. In May 2014, Council approved an agreement with the CCC to accept \$120,000 in grant funding to be used primarily to support the preparation of an update to the 2010 fee study. The first public meeting for the fee study update was held at City Hall in September 2014.

The Fee Study update was needed to incorporate and reflect certified Land Use Plan (LUP) policies and to review comments on the 2010 fee study. In addition, CCC staff requested that the City's fee study update ensure adequate representation of surfers as users of the public beach, and incorporate recent and relevant coastal bluff erosion studies and sea level rise projections into the fee study update.

The CCC held a public hearing on the LUP Amendment at its May 2017 meeting in San Diego. The CCC approved the fee study with 16 modifications as recommended by the CCC staff. On November 8, 2017, the City Council directed staff to pursue geographic segmentation of the bluff top properties from the rest of the City in the LIP and authorized the City Manager to request a one-year extension from the CCC on the Fee Study LUP Amendment. #### **Beach Sand Replenishment** and Retention Projects

San Elijo Lagoon Restoration Project - The San Elijo Lagoon Restoration Project (SELRP) is designed to improve the ecological function and tidal flow of San Elijo Lagoon and will also address the impacts of historical development and infrastructure in and around the lagoon. The SELRP has two components: the restoration of San Elijo Lagoon and the reuse of beach quality sand excavated during the restoration. The project will create a more connected gradient of habitat types relative to existing conditions through modifications to channels and habitat areas within the lagoon. Lagoon restoration has the potential to generate approximately 750,000 cubic yards of beach sand through excavation. The project would involve the creation of an over-dredge pit to provide larger-grained sand suitable for reuse local beaches, which would be exported from the site. Placement would occur at two beach receiver sites (Cardiff and Solana Beach/Fletcher Cove) and also at near-shore receiver sites to be available for future beach replenishments. Beach placement at the Solana Beach site will occur by transporting sand by pipeline along the shore from the lagoon directly to Fletcher Cove. Approximately 146,000 cubic yards of material will be placed at the Solana Beach site beginning in early 2018 and will take approximately two months to complete the placement of sand on Solana Beach.

50-Year USACE Coastal Storm Damage Reduction Project - The Solana Beach-Encinitas shore protection project received congressional "authorization" in the Water Resources Development Act, and the "Record of Decision" was signed in June 2017. This gives the project the final federal approval to be eligible to receive federal funds for construction of the project. First, however, federal funding for Pre-Construction Engineering and Design (PED) must be secured. PED provides all the details that the U.S. Army Corps of Engineers (USACE) and its contractors will need to "construct" the project (or place sand) along the coastline. It provides an engineered profile with details about the quantities of sand to be placed within that profile (mostly, but not entirely, underwater) and the exact locations and quantities from each area of the underwater sites that will be used to obtain (or "borrow") the sand. The Solana Beach project consists of a 150-foot wide placement of sand on the beach, and the Encinitas project consists of a 50-foot wide beach.

The Cities of Solana Beach and Encinitas have also been working for more than 16 years as the local sponsors of a long-term coastal storm damage reduction/shoreline protection project with the state and federal government. The state entity directly involved in financially supporting the project is the California State Parks, Division of Boating and Waterways (DBW). This beach replenishment project has been designed to be resilient to various future sea level rise scenarios over its 50-year life based on National Research Council (NRC) data recommended for use by the California Coastal Commission (CCC).

The project is also consistent with the 2014 adopted CCC Sea Level Rise Policy Guidance document which recognizes beach nourishment a preferred sea level rise adaptation strategy for developed coastlines. The project received a unanimous vote of support from the CCC following a public hearing in November 2013. With project implementation, the beaches would be re-nourished on a regular cycle during a Federal and State investment and participation period of 50 years. (Leslea Meyerhoff 720-2446)

**SCOUP** - In January 2014, the City completed the process to extend its Sand Compatibility and Opportunistic Use Program (SCOUP) for another five years (2019) with new permit approvals received from the California State Lands Commission, CCC, USACE, and Regional Water Quality Control Board. The City's SCOUP program is a key element of the City's long-term shoreline management program and is a key sea level rise adaptation strategy. The SCOUP program allows placement of beach compatible sands on the City's beaches, up to 150,000 cubic yards per year. City Staff are currently tracking several local projects that may generate beach quality export material.

The lead time to develop a SCOUP project is approximately six months, and early coordination with City Staff is important to facilitate final reviews and approvals by the agencies of the sampling and analysis plan (SAP) as well as placement details, monitoring requirements and other logistics.

Annual Shoreline Monitoring Program - The City of Solana Beach, in conjunction with SANDAG and other participating cities, continue to monitor the performance of the beach sand project and the overall health of the public beach through local and regional beach profile data collection and monitoring efforts conducted in the spring and fall each year. The City has an agreement with Coastal Frontiers for ongoing shoreline monitoring services.

## SOLAMA BEACH'S FUTURE Skate Park Update

The City of Solana Beach is in the process of finalizing the design plans for the City's first skate park. Van Dyke Landscape Architects has teamed up with the reputable skate park design firm, Site Design Group, to construct a special skate park that will meet the needs of all levels of skaters in the community. Solana Beach's future skate park will be installed in the northwest corner of La Colona Community Park. Unfortunately, this project is not fully funded, and additional fundraising is still needed before construction can begin.

Fundraising efforts are continuously happening. The City Council has dedicated \$541,000 to begin the process and is working closely with community volunteers to raise funds in hopes of breaking ground early next year. The project still needs approximately \$270,000 to complete the funding. A group of community volunteers has launched a campaign to raise the rest of the expected costs needed to complete the design and construction. These dedicated community residents teamed up with Coastal Community Foundation and established The Solana Beach Skate Park Fund to collect private donations. The City and community group are working together to raise funds for this projects by potentially offering donor tiles that will be displayed at the skate park. In hopes of receiving additional funds, the City has a submitted a grant application for the county's Neighborhood Reinvestment Program and is waiting to hear the final decision.

## Community Choice aggregation

Community Choice Aggregation (CCA), also known as Community Choice Energy (CCE), gives residents and businesses an opportunity to purchase electricity from local government agencies and gives local governments the authority to manage energy resources on behalf of their communities and customers. Electricity continues to be distributed and delivered over the existing electricity lines by the incumbent utility - which is San Diego Gas and Electric (SDG&E) in San Diego County. The central concept of CCA is local choice, allowing customers to choose between energy providers and service options, such as renewable energy products. It also empowers communities to reinvest locally with programs that address economic, social, and environmental justice goals.

On May 24, 2017, the Solana Beach City Council (Council) approved a contract with The Energy Authority (TEA) and Calpine Solutions to engage in a three-phase process for the evaluation and potential implementation of a CCA program. The timeline below proposes a path toward CCA formation and program launch within the first year followed by four years of power supply and operational services.

On October 11, 2017, the Council authorized the City to move into Phases 2 and 3 of CCA development and implementation and on November 15, 2017, the Council approved the CCA Implementation Plan and introduced an ordinance to establish the CCA. On November 20, 2017, the City submitted its Implementation Plan to the California Public Utilities Commission (CPUC) for their review. These are necessary next steps as the City progresses through the phases of CCA development and potential launch. It is important to note that the approval of the Implementation Plan and adoption of the ordinance does not commit the City to launching a CCA but are required steps in the process. The City is still committed to conducting additional public outreach, including workshops, to educate the community on the potential impacts of the implementation of the CCA.

Establishing a CCA program provides tremendous potential benefits to the community, but these benefits need to be weighed against the risks associated with launching and operating a CCA program. The most relevant risks are known, and prudent management and applied experience will be implemented to mitigate many of them. The successful launch and operation of thirteen (13) current CCAs in California, including Marin Clean Energy, Sonoma Clean Power, and Lancaster Choice Energy, have proven the success of the CCA business model and the ability to manage the associated risks while providing significant benefits to their respective communities.

A large part of Phase 2 will focus on community engagement and building a stronger community awareness of the CCA program. Now that the Implementation Plan has been submitted to the CPUC for certification, the City's consultants will focus on engaging the energy market and developing potential cost comparisons to educate the community better. This, along with soon to be released 2018 SDG&E "exit" fee and energy rates, will allow for an updated cost comparison for potential CCA customers. The City and its consultants will also analyze impacts to current solar customers as well as any incentive programs that may be offered to existing and future solar customers. This will better inform the Council of the community priorities (higher renewable energy/reducing greenhouse gas emissions, rate savings, and/or local programs) if the Council decides to launch the CCA.








## RESCUES MAN'S DEST FRIEND

## Seascape Sur Beach Access Stairway Closed

#### Closed for Maintenance and Repairs, November 6, 2017, through March 30, 2018

Maintenance and repair work began on the Seascape Sur Beach Access Stairway on November 6, 2017.

The public beach access stairway and sidewalk connecting to South Sierra Avenue will be closed to the public until approximately March 30, 2018. As part of this project, the concrete walkway that connects the top of the stairs to South Sierra Avenue will be removed and replaced to repair tree root damage to the existing sidewalk. Also, as part of this project, the wood stairway treads (walking/stepping surface) and metal connectors and fasteners will be replaced to repair corrosion that has occurred over the years due to the marine environment. Alternate beach access can be found at Fletcher Cove to the north and Del Mar Shores to the south.

# Proposed Fire Station Art and Landscape Project

#### Notice of 45-Day Public Comment Period for Proposed Fire Station Art and Landscape Project


The 45-Day Public Review Period is from November 1 through December 16, 2017.

The public review period for the City's Fire Station Art and Landscape Project is now open, and the City is accepting comments on the proposed project. The 45-day public review process officially began on November 1<sup>st</sup> and will end December 16<sup>th</sup>. During this time, the City is asking the community to please provide your input and comments on this proposed public art and landscaping project. The comments will be presented to the City Council for their consideration after the public comment period is over.

The selected proposal is titled the "Firewall" by artist Betsy Schulz and Van Dyke Landscape Architects. The materials for the sculpture consist of glass and steel with rusted patina, coated with 2-part epoxy paint. The structure will be approximately 9 to 11 feet tall, 4 feet wide and between 1 to 2 feet thick. The 4-foot sides are red, orange, and yellow chunk glass carefully arranged into a mosaic behind metal mesh and internally lit by LED lights. The proposal also includes complementary landscaping replacing the existing grass turf with drought tolerant, native plants that enhance the art piece to provide a robust, spectacular project. The proposal is shown below.

A mock-up showing the dimensions of the art wall has been placed onsite on the lawn in front of the Fire Station with a sign depicting the proposed landscaping. Also, the artist has created a small sample of the wall and placed it in the City Hall lobby for people to observe what the wall will look like with the mosaic chunk glass and lighting. The City invites the public to review both mock-ups and submit comments.

#### Re-gift Your Tree by Recycling it

Christmas trees are collected curbside for the first three weeks following Christmas, from **Tuesday, December 26th** through **Friday, January 12th,** on your regular collection day. Trees taller than six feet must be cut in half. Please remove all decorations including tinsel, lights, ornaments and tree stands. Place your tree at the curb next to your trash and recycling carts. Flocked trees cannot be recycled but can be collected curbside with your trash, if they are cut down to fit in your trash cart with the lid closed.

In addition to curbside collection, two recycling drop-off locations will be available from **Tuesday, December 26th** through **Saturday, January 13th**. Flocked trees may also be dropped off at one of the drop-off locations. There will be a separate, marked container for the flocked trees, which are not recyclable.





## Reviving Your Wetlands for Nature and You

#### Phase I of the San Elijo Lagoon Restoration Project Begins This December

Imagine the flow of healthy waters and an increase in wildlife diversity at San Elijo Lagoon. New trail connections are on the way. *Reviving Your Wetlands*—the San Elijo Lagoon Restoration Project—is about to begin. San Elijo Lagoon Conservancy is guiding the restoration of the lagoon, estimated to conclude in 2020. Transnet tax revenue funds this essential restoration project.

You're going to see the beginning of 20 years of grassroots planning that has culminated into the restoration of the lagoon. Reviving Your Wetlands is designed to be resilient with sea level rise in our changing climate. Tidal circulation will improve. Lands and waters will be enhanced for native plants and animals—including threatened and endangered species.

Here's a glance at how several native plants, animals, and Pacific Flyway habitats will benefit as tidal flow increases and will reach farther east into lagoon basins:



Following restoration, public access and education opportunities will expand. As managing partners of San Elijo Lagoon Ecological Reserve—San Elijo Lagoon Conservancy, County of San Diego Department of Parks & Recreation, and California Department of Fish & Wildlife—will continue to protect sensitive natural resources.

## Winter is Coming

#### A Message from Marine Safety by Sergeant Robert McPhee

Winter is coming. Although residents of Solana Beach don't have to worry about cold, harsh winters, they can see major changes from summer to winter. The most noticeable changes will be at the beloved beach. Winter storms in the North Eastern Pacific Ocean create larger surf which, in addition to being dangerous itself, will transform the beach and often creates or exposes new hazards. These storms can occasionally bring heavy rain, as we saw last year, which can greatly affect the coastal bluffs and the beach itself. These seasonal changes bring a whole new set of challenges that the Solana Beach Lifeguards must prepare for and adapt to when the situations arise.

Giant northwest swells haven't hit the coast yet but will be arriving sometime in the near future. There are more surfers today on the beaches of Solana Beach than ever before, and it is important for all of these new surfers to know their limits. The large winter swell can be extremely dangerous for surfers and every year the Solana Beach Lifeguards rescue surfers who fail to recognize their limits. These rescues include even experienced surfers, who get pummeled by the large surf and injure themselves or break their boards. When the National Weather Service issues a High Surf Advisory and the warnings about the approaching large surf are blasted all over the media, surfers need to take these warnings very seriously. These alerts are meant to protect the public, not for surfers to paddle out and get in trouble. Please take caution; there will be another perfect day to surf. You can ALWAYS check in with lifeguards if you are unsure about surf conditions, as they enjoy answering any questions you may have.

Another potential safety hazard the large winter swells expose is the numerous lobster buoys that line the coast this time of year. The large surf can push these traps with their buoys and connecting lines into the surf line. This creates potential danger for surfers, boogie boarders, or swimmers to get tangled in the lines. The lifeguards work with the lobster fisherman to try to prevent this when possible, but during large storms, it is impossible to know what is going to happen. When possible, lifeguards go out on their PWCs (jet skis) to remove the traps from the surf line and then notify the lobster fishermen to come and pick up their removed traps. If you see any lobster traps/buoys that appear to be a safety hazard, please notify the lifeguards immediately.

Although it doesn't often happen in beautiful Solana Beach, winter can bring heavy rain. Excessive rain on the beach will generate more hazards that the public needs to be aware of, and the lifeguards need to be ready for. Runoff into the ocean is one of the first things you may notice when it rains on the coast. The first large rain of the year brings down all the debris that has been building up over the summer. It is for this reason that the San Diego County Department of Environmental Health Issues a 72-hour water quality advisory after every measurable rainfall. In addition to poor water quality, winter storms may bring lightning. The beach and lightning are a very serious and dangerous combination, due to the proximity of the water and the electrifying nature of lightning. If you are in the water and see approaching lightning, please exit the water and leave the beach area immediately. Even if you are walking on the beach, it is just as dangerous, since the wet sand can act as a conductor of electricity. If lightning strikes the beach, electricity can transfer through sand and electrocute people nearby. So please, if you are at the beach and see lightning approaching, exit the beach and seek safe shelter.

The beach during winter time can be beautiful and awe-inspiring, but please remember that it can also be very dangerous. Make sure you know your limits if you are going in the ocean this time of year. Always be aware of what the weather and ocean conditions are, even if you are just strolling on the beach. If you have any questions about the beach or ocean, please check in with the lifeguards at Fletcher Cove. They are always happy to speak with you. The Solana Beach lifeguard station will have the 2018 Tide Books in stock early December, so stop by to check on the ocean conditions, meet your local lifeguards, and grab your free tide book.
