General Chapter Information

Duties and responsibilities of Required Chapter officers shall be as follows:

Director: shall uphold this Charter, conduct Chapter meetings and coordinate Chapter officer responsibilities.

Assistant director: shall be responsible for promoting membership, membership orientation, membership retention, and keeping the Chapter members informed of H.O.G.® programs.

Treasurer: shall be responsible for collecting and disbursing Chapter funds, reporting financial transactions to sponsoring Dealer / Retailer / Chapter Manager on a monthly basis, compliance with all revenue recording and reporting requirements.

Secretary: shall be responsible for administering and maintaining meeting minutes, annual reports, membership reports on members.hog.com, insurance and legal documentation, event releases, and enrollment releases. These permanent records shall be kept at the sponsoring Dealership / Retail Store.

Duties and responsibilities of Discretionary Chapter Officers shall be as follows:

Road Captain: assisting in the planning of routes for Chapter rides.

Safety Officer: providing Chapter members with information relating to the availability of rider training.

Historian: preparing and maintaining an account of the history of the Chapter.

Membership Officer: assisting the Chapter secretary in the Chapter membership duties.

Members

Full and Associate Chapter Members are required to belong to National HOG (FYI: A member's spouse is not automatically a member—a separate membership in National HOG & a separate membership in CK HOG is required)

Guests may attend three meetings or rides before being asked to become a member

For Chapter Rides—Guests must fill out and sign a release form at the beginning of the ride
