INTRODUCTION

In general, chaptered legislation will go into effect on January 1, 2020. Bills that contain an urgency clause took effect immediately upon the Governor's signature.

Abandoned Vehicles, Parking, and Towing

AB-516 (Chiu) - Authority to remove vehicles.

This bill would delete the authority for law enforcement and local officials to tow and impound, or immobilize a vehicle that has five or more delinquent parking tickets or traffic violations, as specified. The bill would also modify the authority for those entities to tow and impound a vehicle left standing on a road for 72 hours or more in violation of a local ordinance by extending that time to five or more business days after a specified notice is affixed to the vehicle.

Active Transportation

<u>SB-127 (Wiener) - Transportation funding: active transportation: complete</u> <u>streets.</u>

This bill revises state policies for the management of the state highway system, including requiring the California Department of Transportation to incorporate new pedestrian and bicycle facilities into projects in specified areas.

Governor's Veto Message:

- This bill creates a process to require the Department of Transportation (Caltrans) to add complete streets elements to certain projects on state highways.
- I fully support improving facilities to increase walking, biking and accessing public transit. However, this bill creates a prescriptive and costly approach to achieve these objectives.

 By implementing my Executive Order N-19-19, Caltrans is increasing and accelerating its investments in active transportation where appropriate and feasible. I am committed to holding the department accountable to deliver more alternatives to driving while continuing to maintain our state's highways and bridges. The new leadership we are putting in place at Caltrans will be key in implementing this vision and approach.

SB-152 (Beall) - Active Transportation Program.

This bill makes various programmatic changes to the Active Transportation Program, as specified.

This bill:

1) Modifies ATP allocations by distributing 75% to MPO's, 15% to small urban and rural regions and 10% to projects of a transformative nature. Funds for small/urban regions and transformative projects are to be distributed by CTC.

2) Requires, rather than authorizes, CTC to adopt separate guidelines for MPOs, as specified.

3) Authorizes an MPO to perform its own competitive project selection process using regional guidelines adopted by CTC, or allow MPOs to request CTC to perform the competitive project selection process on the MPO's behalf, as specified.

4) For the funds made available to MPOs, requires CTC to allocate these funds to each MPO as a lump sum, unless the MPO requests CTC to conduct the competitive selection process on behalf of the MPO, as specified.

This bill requires the California State Transportation Agency (CalSTA) to conduct an assessment by July 1, 2021 of the procedures public transit operators use to provide dial-a-ride and paratransit services to individuals with disabilities whom are visiting their service territory, and requires CalSTA to development statewide guidelines.

Air Quality, Greenhouse Gas Emissions, and Fuels

<u>SB-44 (Skinner) - Medium- and heavy-duty vehicles: comprehensive</u> strategy.

This bill requires the Air Resources Board to update the 2016 mobile source strategy to include a comprehensive strategy for the deployment of medium duty and heavy-duty vehicles in the state for the purpose of bringing the state into compliance with federal ambient air quality standards and reducing motor vehicle greenhouse gas emissions from the medium duty and heavy-duty vehicle sector, as specified.

SB-210 (Leyva) - Heavy-Duty Vehicle Inspection and Maintenance Program.

This bill directs the California Air Resources Board to work in coordination with multiple state agencies in order to develop and implement a Heavy-Duty Inspection and Maintenance Program for non-gasoline, heavy-duty, on-road trucks.

<u>SB-216 (Galgiani) - Carl Moyer Memorial Air Quality Standards Attainment</u> <u>Program: used heavy-duty truck exchange.</u>

This bill specifies that a heavy-duty truck exchange is an eligible project for funding under the Carl Moyer Memorial Air Quality Standards Attainment Program. **Status:** Assembly-In Committee Process - Appropriations

<u>SB-400 (Umberg) - Reduction of greenhouse gases emissions: mobility</u> options.

This bill expands the allowable modes of transportation for which Clean Cars 4 All "mobility option" vouchers may be used to include bike sharing and electric bicycles, in addition to previously permitted public transit and car sharing uses.

SB-662 (Archuleta) - Green electrolytic hydrogen.

This bill requires the California Public Utilities Commission to approve or amend investor-owned utility applications for ratepayer-funded investments in green electrolytic hydrogen produce and infrastructure, and incorporates green electrolytic hydrogen into various definitions of transportation electrification related to state agency duties to address greenhouse gas emissions reduction goals.

This bill requires the DHCD to participate in these two joint meetings in order to coordinate their implementation of policies that jointly affect transportation, housing, and air quality.

AB-1046 (Ting) - Air Quality Improvement Program: Clean Vehicle Rebate Project.

This bill requires the California Air Resources Board to develop a plan to provide for the continuous funding of a program with a goal of supporting deployment of 5 million electric vehicles by December 2030 and authorizes the Treasurer to securitize the revenues the identified revenue streams.

AB-1100 (Kamlager-Dove) - Electric vehicles: parking requirements.

This bill counts parking spaces served by electric vehicle charging equipment as a standard parking spaces for purpose of complying with any applicable minimum parking requirement established by a local jurisdiction.

AB-1195 (O'Donnell) - California Global Warming Solutions Act of 2006: Low-Carbon Fuel Standard regulations.

This bill directs the ARB to, through a public process before January 1, 2023, consider allowing renewable natural gas, provided as specified and which reduces in-state methane emissions, to generate Low-Carbon Fuel Standard credits.

Governor's Veto Message:

- This bill requires the California Air Resources Board (CARB) to consider allowing renewable natural gas (RNG) or biogas delivered via a common carrier pipeline to a crude oil production or transport facility from a source that CARB determines directly reduces emissions of methane in the state to generate credits under the Low-Carbon Fuel Standard (LCFS) regulation.
- In 2018, CARB amended the LCFS regulation and made a carefully considered decision to prohibit this type of transfer, because doing so would undermine the program's ability to achieve ozone and particulate matter (PM) 2.5 health standards.
- The Low-Carbon Fuel Standard regulations must be adopted to reduce air quality and health risks, not make them worse.

AB-1406 (O'Donnell) - Alternative and Renewable Fuel and Vehicle Technology Program.
