Dear Parents,

Welcome to the Camp Horizon Registration Packet. This packet is the only way to register for both the Day Camp sessions and Field Trip week. Please take the time to accurately answer each question and fill in each blank, as this information is critical for Camp Horizon to effectively care for your child this summer.

Camp Horizon's Day Camp sessions are offered in one-week segments at Ocean City Elementary School on Center Drive in West Ocean City. These sessions start each day at 9:00 a.m. and end at 4:00 p.m. There will be no before or after care available. These camp sessions offer bus service on a limited basis from the Town of Ocean City limits to camp for \$25 per camper per week. For those choosing to ride the bus you must choose from the set list of bus stops. The bus will only use these stops for this summer. An additional \$5 non-refundable deposit (part of the \$25 per week fee) must be paid at the time of registration for bus service. Bus service is limited and is offered on a first come, first served basis.

Camp Horizon Field Trip Week is August 7–11 and offers five fun filled days of trips. <u>Children must have attended another week of camp in 2017 prior to Field</u> <u>Trip week.</u> During Field Trip Week camp is held at the Ocean City Convention Center and there will be bus transportation within the Town of Ocean City limits to and from camp available at the \$25 per week per camper fee. Camp hours for Field Trip Week are 9:00 a.m. to 4:00 p.m. Monday through Friday. Specific information about this session will be provided later in the summer to those enrolled.

Camp Horizon registration for all sessions starts on February 1st at 8:30 a.m. for Ocean City Residents, Property Owners, and Town Employees. These individuals must provide documentation confirming their status in the form of a Town of Ocean City property tax or water bill, a Town of Ocean City Employee Identification Card, or a residential lease agreement for a Town of Ocean City property. A copy of this document must be left with your registration packet. Non-Resident registration begins on March 1st at 8:30 a.m. For all campers ages 5 and under a copy of the camper's birth certificate should be submitted along with the registration packet. All participants must include a **\$25 non-refundable deposit** for each session and all applicable bus deposits.

Parent Packets confirming your registration in camp, your bus stop, and other important camp information will be **e-mailed** by June 1st. On behalf of the staff of Camp Horizon I want to welcome you to another great year. It is going to be a wonderful summer.
