**Application Process:** Some federal positions require that an applicant form be submitted along with a resume and cover letter. The type of form varies depending on the agency to which you are applying. The specific job posting should indicate what form is required, if any. **Loan Forgiveness:** The Federal student loan repayment program permits agencies to repay Federally insured student loans as a recruitment or retention incentive for candidates or current employees of the federal government. - Working in a law firm as a recruiter, trainer, or manager
- Working for a bar association as a foundation director, administrator, or community relations liaison
- Working for a corporation or other business as an affirmative action officer, pension officer, contract specialist, or policy analyst
- Working in a law school or education institutional teaching law-related courses, and
- Working in the political arena as a lobbyist, political fund-raiser, or on staff for a public official.

Each year there are four important career fairs specifically geared toward careers in intellectual property.

- The Loyola Patent Law Interview Program is held each August in Chicago. Major intellectual
  property law firms and corporate legal departments from across the country interview students
  from both summer and permanent positions. The Career Center will receive registration
  materials in the Spring Semester.
- The American Intellectual Property Lawyers Association (AIPLA) hosts a career fair each fall in Washington, D.C. Students with either technical or non-technical backgrounds are interviewed for summer and full-time positions with prominent firms across the country. Participants must join AIPLA by the August preceding the fair in order to participate. For more information visit www.aipla.org.
- The Southeastern Intellectual Property Job Fair (SIPJF), held annually in July, is an initiative founded by the Intellectual Property Advisory Board, which is an alumni group associated with the Georgia State University College of Law. The fair is managed and executed by the Georgia State University College of Law Career Services Office. SIPJF continues to position itself to become the IP job fair that encompasses all areas of intellectual property from litigation to
