#### Agenda Summary April 12, 2021

Agenda Item No: 5B 2 Memorial Hall Video Conference System

<u>Summary</u>: Historically, the Selectboard, Development Review Board and other town boards and commissions have met in-person. With the onset of the COVID-19 Pandemic the transition was made to a fully remote forum. There are pros and cons of both in-person and remote meeting platforms. Moving forward, a hybrid model, that allows both in-person and remote participation is the most accommodating.

Casually known as "zoom rooms", technology has rapidly developed to support this hybrid format and a software based system that provides an integrated experience for audio conferencing, screen sharing, and video conferencing to both in-person and remote attendees is proposed. With one screen and camera for board members at the end of the horseshoe of tables, and a second screen and camera facing the Memorial Hall audience, the system can voice track and screen share between board members, in-person audience members as well as individual remote participants. The system would function very similarly to the current fully-remote Zoom format, but would allow both the board and the in-person audience to participate as a group in a similar manor that an individual would in a fully-remote meeting.

Public Works has solicited pricing from REnVisioning Technology, LLC, a regional firm with a focus on installing and supporting "zoom-room" technology. Their experience spans everything from public schools to universities and towns and cities in northern New England.

With lead time on materials, it would be appx. 6-8 weeks from commitment to having the room fully operational.

<u>Town Plan Impact</u>: Local Planning Process Policy #1: *Opportunities for citizen input will be provided, and participation encouraged, at every stage of the planning and decision-making process and decision-making shall only occur in an open, public environment.* 

<u>Fiscal Impact</u>: Estimated total project cost is \$20,000.00. Pricing for REnVisioning Technology is \$17,466.38 (quote attached). The Town will have to engage an electrical contractor separately to install electrical outlets and internet connections. The money would be accounted for in the administrative contingency line item which would be exceeded but staff anticipates the overall General Fund Budget to come in on-line.

<u>Recommendation</u>: Move to authorize the Town Manager to engage REnVisioning Technology, LLC and a to-be-determined electrical contractor to purchase and implement the video conference system in Memorial Hall.

#### **Proposal Overview**

Included in this proposal; project overview, statement of work, and quotes.

#### **Project Overview**

Installation of a Poly Studio X50 codec for video conferencing and content sharing. The X50 will be installed on a custom cabinet along with a 50" LG display facing toward the town selectman. A floor box with power and data will need to be installed at the custom cabinet location. To the right hand side of the town selectman seating will be an OFE (owner furnished equipment) of a large display on a moving cart. Installed above the display on the cart will be a Poly Eagle eye cube camera. The cart assembly will be facing towards the audience for presentation and video conferencing. At the cart location will need to be a floor box with power and passthrough to run cabling between the cart and cabinet floor boxes. Inside the cabinet will also be an assisted listening system along with 2 Shure condenser microphones mounted on the cabinet for the assisted listening system. Lastly there will be a Poly touch 8 panel to control the system and HDMI connected for laptop presentation. Both will be located at the town selectman table.

#### **Statement of Work**

- Install custom cabinet.
- Install 50" LG display on custom cabinets to face towards the selectman table.
- Install X50 on custom cabinet.
- Install OFE cart and display.
- Install Eagle Eye director camera above OFE display.
- Run necessary cabling between cabinet floor box and display cart floor box.
- Install assisted listening system in cabinet.
- Install assisted listening microphones on top of cabinet.
- Install Touch 8 control panel at selectman table.
- Install HDMI connection at table location.
- Clean Program and Test.
- Training.

#### Town of Stowe VT (to be ready prior to our arrival on site)

- Install floor box for custom cabinet location.
- Install floor box for display cart location.
- 2 Available active network ports at cabinet and display cart floor boxes.
- Active power connection at cabinet and display cart floor boxes.

#### Warranty

We have included a 30 day labor warranty for the installation of this project. This warranty is not an extension of any manufacture warranties. We honor all manufacture warranties. The warranty starts at sign off between Town of Stowe VT and REV-T no later than 3 business days from completion of the project.

Example: If a device fails in its first 30-days, we will provide remote and/or on-site support. If needed, we will work with the manufacturer for repair or replacement. If the device is no longer under manufacturer warranty the cost of the repair, excluding REnVisioning Technology's labor, will be billed (if approved) to the owner of the failed device.

#### Invoicing

Equipment is invoiced at time of equipment ordering with Net 30. Labor and Services are invoiced at the project major completion milestone or prior to a punch list. Labor and Services have Net 30.

#### Labor Costs

All labor costs in this proposal are based on REnVisioning Technology's staff, non-union personnel. This proposal does include weekend hours. Requirement for Union rates shall be billed additionally.

#### **Return Policy**

REnVisioning Technology, LLC offers a limited return policy. All returns are subject to a 20% restocking fee. Labor and services are non-refundable, and Labor cost will be invoiced for any returns that require Labor outside of the original approved scope of work. Consumer model displays and miscellaneous items are not eligible for return. All of other items have a 14-day return policy unless marked otherwise in the quote. 14days start the same day as commissioning the system and prior to punch list completion.

#### Wall and Ceiling Finish Work

The customer will assume responsibility for repairing, patching and painting all walls or ceiling finished that may be disturbed as the result of penetrations and mounting procedures.

#### **Electrical Work**

All line voltage electrical work is the responsibility of the customer and is not included in this proposal.
